A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE ADOPTING A "RESOLUTION OF LOCAL SUPPORT" INDICATING THE CITY WILL (A) FOLLOW ALL GRANT PROGRAM REQUIREMENTS AND DELIVERY TIMELINES; AND (B) AUTHORIZE THE CITY MANAGER OR DESIGNEE TO NEGOTIATE AND EXECUTE A GRANT FUND AGREEMENT AND ALL DOCUMENTS NECESSARY TO EFFECTUATE THE GRANT WITH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION (CALTRANS) IN AN AMOUNT NOT TO EXCEED \$10,000,000 FOR THE EAST SAN JOSE CORRIDOR SAFETY IMPROVEMENT PROJECT

WHEREAS, on June 30, 2022, Governor Gavin Newsom signed into law California Assembly Bill 178 (AB 178), which was a budget trailer that referred to the process of assigning money for a special purpose. The trailer bill revised the Budget Act of 2022 by amending, adding, and repealing items of appropriation; and

WHEREAS, in July 2022, the adopted 2022-2023 California State Budget included a \$10,000,000 funding appropriation for the East San José Corridor Safety Improvement Project; and

WHEREAS, the East San José Corridor Safety Improvement Project will improve pedestrian, bicyclist, and transit safety along 4.7 miles of Senter Road between Story Road and Monterey Road, by implementing several safety features; and

WHEREAS, the City Council is asked to adopt a Resolution of Local Support which indicates that the City will follow all grant program requirements and delivery timelines; and

WHEREAS, in order for the City to receive this State allocation, the City must enter into a "Fund Transfer Agreement" with the California Department of Transportation ("Caltrans") that would allow Caltrans to transfer the State funds to the City; and

WHEREAS, the grant funding will help achieve the City's goals of improving transportation safety and equity and align with one or more Climate Smart San José energy, water, or mobility goals; and

WHEREAS, the City desires to authorize the City Manager or designee to negotiate and execute a grant fund transfer agreement and all documents necessary to effectuate the grant with Caltrans for the East San José Corridor Safety Improvement Project;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

With the adoption of this Resolution of Local Support:

A. The City will follow all grant program requirements and delivery timelines; and

B. The City Manager or designee is hereby authorized to negotiate and execute a grant fund transfer agreement and all documents necessary to effectuate the grant with Caltrans in an amount not to exceed \$10,000,000 for the East San José Corridor Safety Improvement Project.
