SUBJECT: APPROVAL OF PUPPIES AND ICE CREAM WITH COUNCILMEMBER PERALEZ SPONSORED BY COUNCIL DISTRICT 3 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

1. Approve the Puppies and Ice Cream with Councilmember Peralez event scheduled on August 16, 2018 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
3. Place the item on the June 26, 2018 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Puppies and Ice Cream with Councilmember Peralez will be held on August 16, 2018 at the Taylor Street Night Market and sponsored by Councilmember Raul Peralez. This special event will provide community members with a fun filled evening of family activities, ice cream and the opportunity to meet some of our puppies up for adoption at our local animal shelter. The event is free and open to the public.


