Legislative and Regulatory Priorities

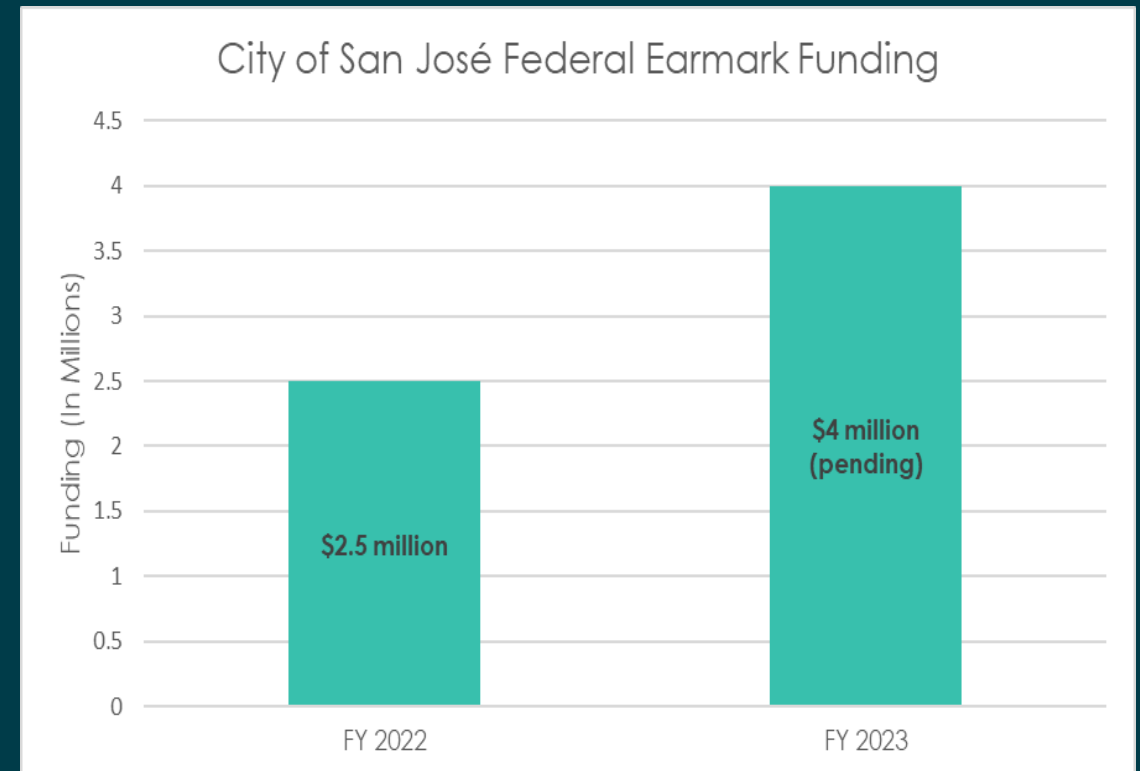

Funding Advocacy - \$18.7 million confirmed; \$4 million pending

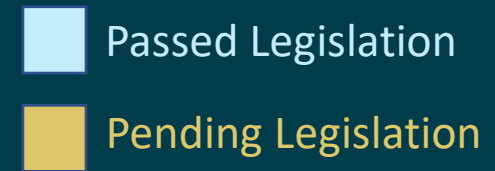
- Federal Grant Awards Received - \$18.7 million
 - FRA Consolidated Rail Infrastructure and Safety Improvements (CRISI)
 - Bascom Ave. \$1.2 million
 - Monterey Rd. \$7.5 million
 - Airport Terminals Program - \$10 million
- Congressionally Directed Spending
 - Mabury Interim Housing Site (Rep. Lofgren)
 - SureStay Interim Housing Site (Rep. Khanna/Rep. Eshoo)
- Pending Applications
 - Rebuilding American Infrastructure with Sustainability and Equity (RAISE) – Diridon Station (\$5.9 million)

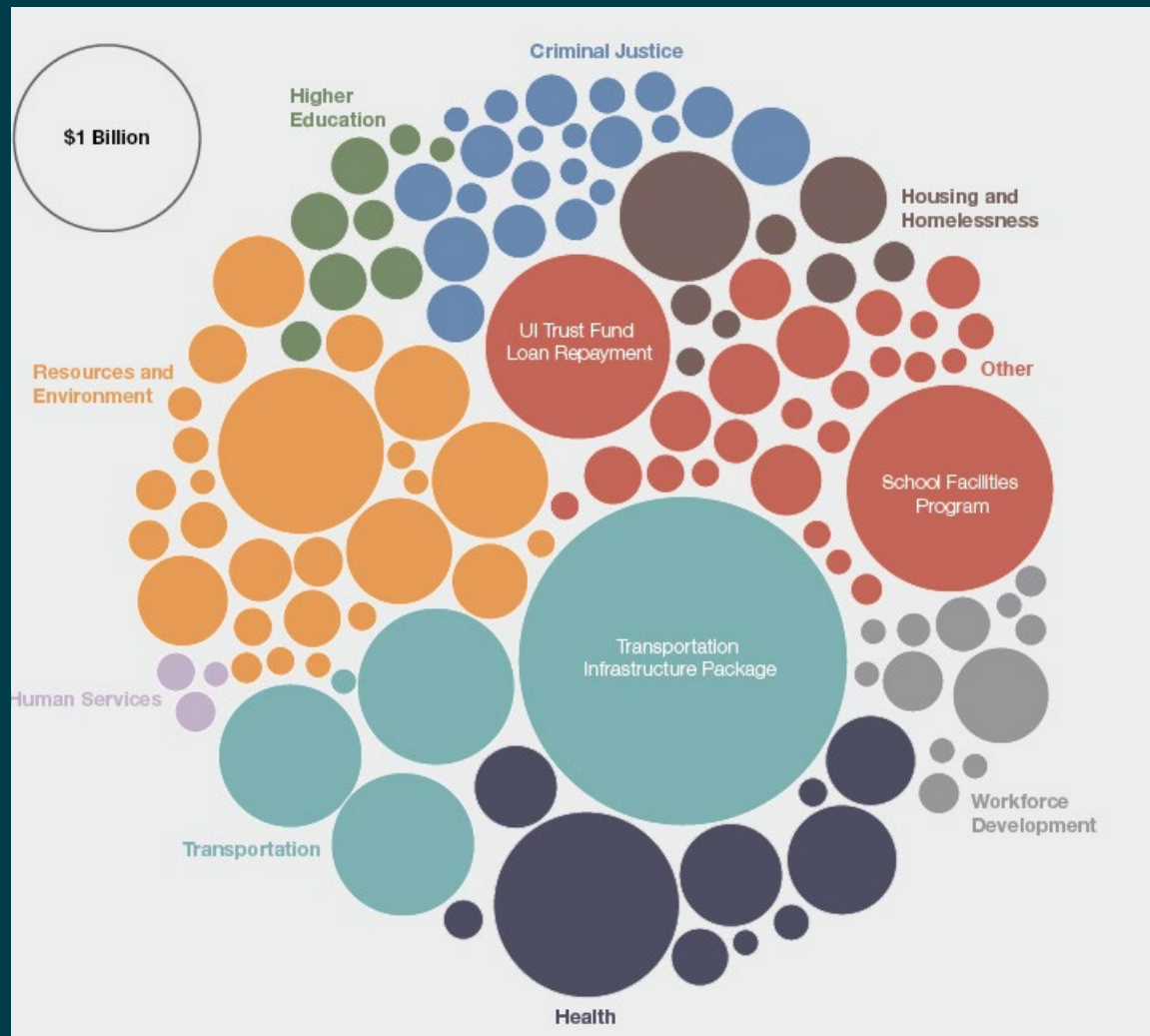

Budget Overview



- ✓ \$1.2 billion in immediate drought support
- ✓ \$17 billion in Fiscal Relief
 - \$9.5 billion in direct tax rebates
- ✓ \$2 billion in HHAP over two years
- ✓ \$150 million for Project HomeKey
- ✓ \$1 billion Active Transportation Program
- ✓ \$7.7 billion Transit and Intercity Rail
- ✓ \$1.5 million for the CA Youth Empowerment Commission
- ✓ \$25 million for Summer Youth Workforce

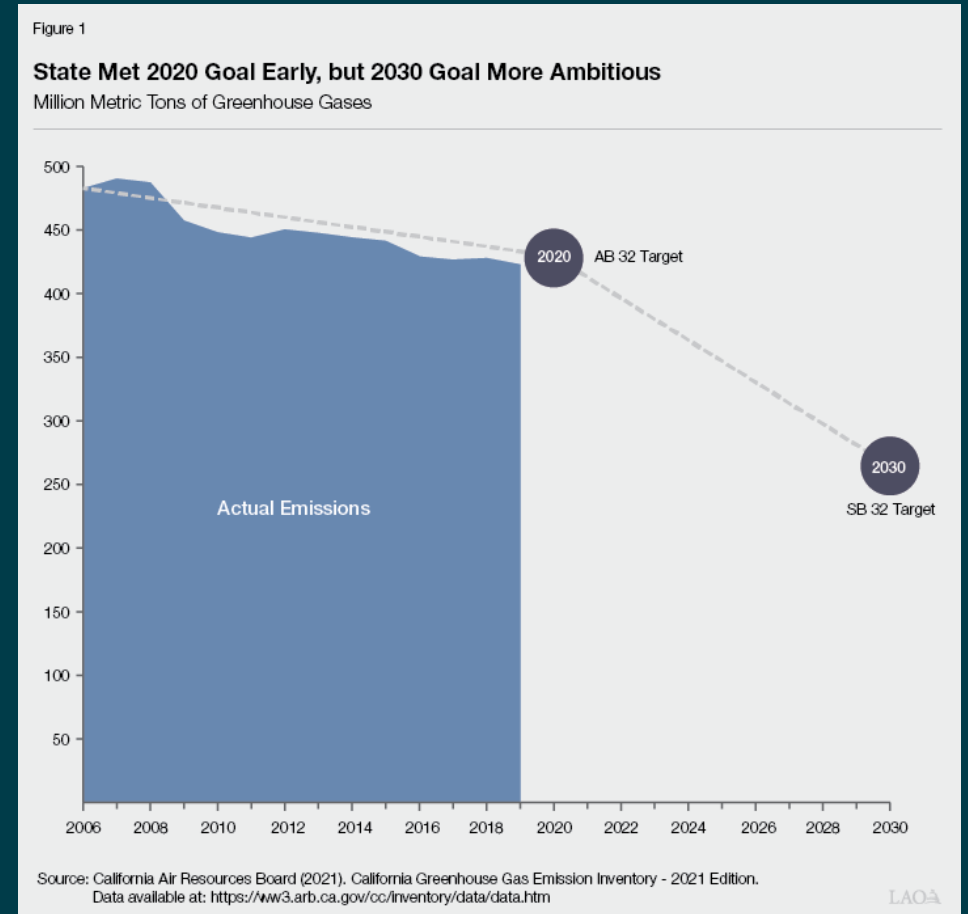

- Clean-up bill with technical changes to the budget

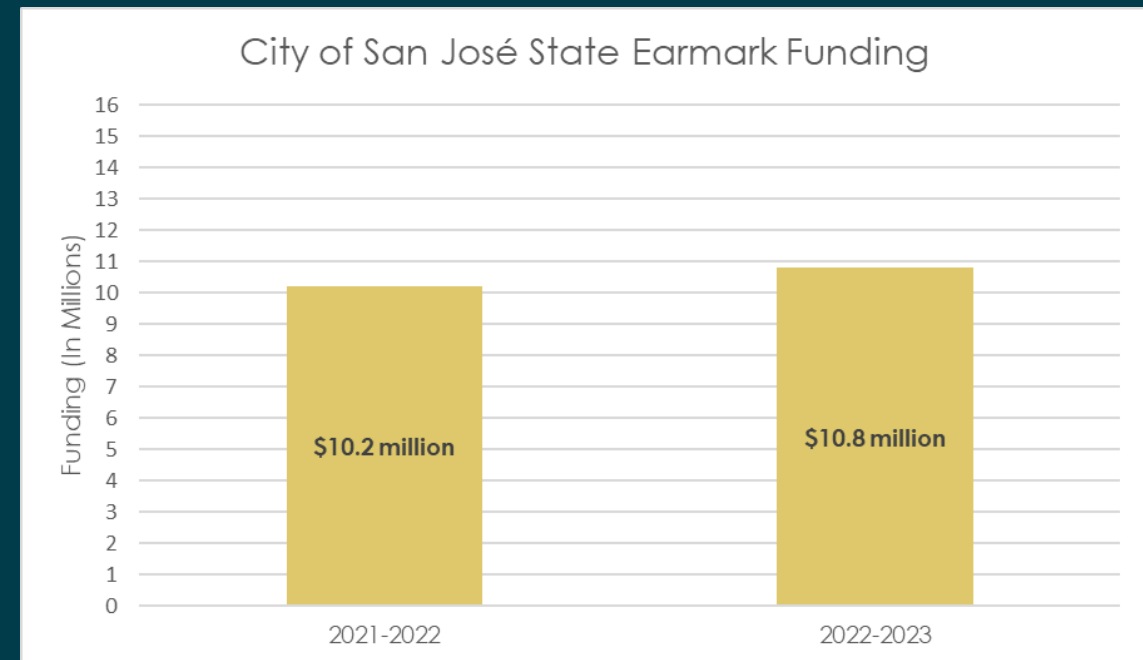


State Highlights

Funding Advocacy

- Community Project Funding (Earmarks)
 - East San José Corridor Improvement
\$10 million (Asm. Kalra)
 - Responsible Landlord Engagement Initiative
\$800k (Asm. Kalra)
- 2022-2023 California Budget
 - \$1 billion more for rail projects including Bay Area Rapid Transit (BART) phase two and Caltrain electrification
 - **\$7.7 billion total investment**
 - \$1 billion in Homeless Housing Assistance and Prevention program (HHAP)
 - Funding advocacy with Big City Mayors
 - Active Transportation Program (ATP) eligibility for new projects instead of only backlogged projects

Nearly \$11 million coming to San José!

- AB 2091 (Bonta): Disclosure of information: reproductive health and foreign penal actions
- AB 1918 (Petrie-Norris): California Reproductive Health Service Corps
- AB 2134 (Weber): Grants for low-income abortion
- AB 2626 (Calderon): Licensing of physicians for performing abortion care
- SB 1142 (Caballero, Skinner): Public information for abortion services
- AB 2223 (Wicks): Prevention of Criminal Penalties

■ Gun Violence Reduction

- AB 2571 (Bauer-Kahan) – Restricts advertising of firearms to minors
- AB 1621 (Gipson) – Restricts ghost guns
- SB 1327 (Hertzberg) – Creates private right of action
- AB 1594 (Ting) – Allows governments and victims of gun violence to sue manufacturers and sellers of firearms
- SB 505 (Skinner): Would largely mirror San José's ordinance as it relates to gun liability insurance

State Ballot Measure Overview

7 Ballot Measures Qualified for the November 8 ballot

- Recommending a position on five measures:
 - Prop 1: SCA 10: Reproductive freedom – **SUPPORT**
 - Prop 26: Authorizing new types of gambling – **OPPOSE**
 - Prop 27: Online and mobile sports wagering – **OPPOSE**
 - Prop 28: Funding for arts and music education – **SUPPORT**
 - Prop 31: Challenging law prohibiting retail flavored tobacco – **OPPOSE**
- Not recommending a position on two measures:
 - Prop 29: Dialysis Clinic Requirements
 - Prop 30: Wealth Tax for EV Infrastructure and Wildfire Prevention

Prop 1: SCA 10: Reproductive Freedom

Recommended Position: **Support**

- Supported by the legislative program

Purpose

- Enshrines the right to an abortion into the California Constitution

Path

- Legislative – introduced in June

Support

- Governor Newsom
- Senator Atkins
- Assemblymember Rendon

Prop 26: Authorizing New Types of Gambling

Recommended Position: **Oppose**

- Supported by the legislative program
- Negative impact on City cardrooms with respect to Private Attorney General's Act

Purpose

- Allow Retail sportsbooks for in-person wagering at tribal casinos and horse tracks

Path

- Initiative

Opposition

- California Cities Gaming Authority (CCGA)

Prop 27: Online & Mobile Sports Wagering

Recommended Position: **Oppose**

- Consistency with Prop 26 to protect San José tax revenue

Purpose

- Allow online and mobile sports betting Retail sportsbooks
- Minimal funds to address homelessness

Path

- Initiative

Opposition

- California Cities Gaming Authority (CCGA)

Prop 28: Funding for Arts & Music Education

Recommended Position: **Support**

- No negative impact to City functions
- Increases quality of life for residents

Purpose

- Establish minimum funding standards for art and music education in all K-12 public schools through an annual 1% allocation of required state school funding.

Path

- Initiative

Support

- Californians for Art and Music Education in Schools
- Former U.S. Secretary of Education Arne Duncan

Prop 31: Challenging Law Prohibiting Retail Flavored Tobacco

Recommended Position: **Oppose referendum**

- Aligns with legislative program and City Tobacco Retail Ordinance

Purpose

- Halt implementation of SB 793 banning the sale of flavored tobacco products

Path

- Referendum

Opposition

- Governor Newsom
- California Teachers Association
