Business:

Minutes from 9/12 BOD meeting approved unanimously

Charlie Faas Remarks: Thank you to Dev Davis for your support and dedication to SJSA.

JP: Councilmembers are assigned boards by the mayor, it's a major task. Dev Davis has been fantastic for SJSA, tells you what you need to hear, not what you want to hear. We appreciate everything you have done.

DD: The Sports Authority has a special place in my heart, I am grateful to have been a part of this board and have enjoyed every impactful event we have brought to the city.

Dev Davis City Updates: Bearer of bad news, the city manager this week informed all city staff of a hiring freeze due to sales tax revenue being below expectations. Hole in current year's budget that needs to be fixed, next year's budget will be affected. Do not know what that means for 2026. Hope we do not pull back on the things that need to happen for 2026 to ensure revenue and civic impact.

LS: The future property tax revenue will show less growth than previous years due to tanking of the office market. Won't get better for a year or two.

Pam Foley City Updates: On a positive note, we are in the process of interviewing and hiring the 2026 sports czar, will be in place soon and hopefully will not be affected by the budget. Critical hire due to the activities and events that all revolve around SJ26.

Blage Zelalich Remarks: A budget exercise ahead of us from a staff perspective. Really good to know that leadership in the city values what SJSA does. Councilmembers will be strong advocates for SJSA. Last year of the 5 year budget agreement, we will begin discussions for another 5 year agreement in January. Minimum amount will be based on what we did this year. Every year there are one-time funds that revolve around special events such as the Super Bowl and World Cup, can also be additional one-time funds.

CF: To me, there have been two recent notices from the SCC board of supervisors or the city of Santa Clara that have been "anti-sports." Mayor Mahan spoke at the SJSHOF in great detail about sports, and my takeaway from that was that he cares. He wants sports in San Jose and

he wants to dedicate his time. I view the sports czar position as a "glass half-full" as it bridges the gap between the city and the Sports Authority:

Nanci Klien Remarks: This board and staff are phenomenal. We know that the set of the events leading up to 2026 and beyond is critical to San Jose's future. From our point of view, I want to reiterate that JP is the face that we work with in getting things done with TSJ and other San Jose community leaders. When the notion of the position came up, we realized it was critical to us, especially with the budget challenges. We often ask for a lot of communication, but because it was moving so fast, we did not communicate with SJSA and Charlie, that will not continue. It was not an espersion towards JP and SJSA, that is why I am here to make it clear that we will work together. It is leading to great things. Great things have already come out of this partnership, such as the Stay and Play in San Jose campaign. There is some distrust with the Bay Area Host Committee, I do not know how they plan to function long-term or how they will work with SJSA in the future. That is something that we will need to think through to gain as much partnership as possible with them in the future, but also be mindful with them that we will not go down.

Andy Dolich: What is the timing of this individual being hired?

NK: Interviews before the end of this month, they will be on by January.

BOD Development:

Andrei Losche of Zoom has joined our board, came as a reference from JH. The first partnership with Zoom was hosting the livestream for the '24 HOF ceremony at no cost to us.

We are looking for a representative to replace the Pac-12 Conference. Already have WCC and MW representatives, if no Bay Area ties in the future Pac-12, prospective replacement board members include:

Our bid to host the Rugby World Cup Qualifiers is almost over the finish line. They want to enhance their presence in the United States.

We are at risk of losing the Water Polo JOs to Southern California, we are hoping to rely on our university partners to keep them in the Bay Area (particularly at Stanford) in 2026.

James Hamnett: USA Gymnastics has sent us the RFP for the 2028 Olympic Trials, going to cost us \$1 million and will be highly competitive. Because the 2028 Olympics are two weeks early, they have placed themselves in the Stanley Cup and NBA Finals windows, knocking out potential city hosts
