

Dear City Councils and City Management:

My name is Sophie Yan Song, I am writing to introduce you a company who saved the home in LA fires:

Frontline Wildfire Defense System: Protect Your Home from Wildfires, this will be powerful prevention tools. I suggest that the City to fund prevention get help from them and set up rooftop sprinklers systems for mountain homes.

Last but not the least importantly, what is the communication between the Chief of the Water department and Fire Department?


I trust that our chief offices will take actions and prevent fires from happening, will invest in prevention measures and get human resources and tools such as power and pumps and water supplies.



I am responding to my personal email however the neighbors are beyond patience and any form of sympathy for these individuals who are engaging in illegal activities at the site of this motor home. The vehicle attracts two individuals who have assaulted and robbed and permanently injured a senior resident.

These individuals have been identified by the victim.

The police have an open case that is stuck between the SJPD desk waiting for a referral to the DA to issue a warrant for their arrest.

These individuals frequent the site every 90 days and carry out their business and leave.

The SJPD policy of social justice does not seem to refer to cases if you're not perceived as worthy of justice because of your socio-economic status.

The neighbors' children have been accosted, threatened and do not feel safe walking past this vehicle on the corner of Kooser and Dellwood on thier way to Dartmouth MS, Pioneer and Branham HS.

This vehicle is in front of the Montessori Pre School (18 months-3yrs) on Dellwood Ave 95118

The mothers of Merrywood Dr have asked the KooserWoods Coalition Neighborhood Association to start a petition to remove this dangerous public welfare threat to our neighborhood children.

The Board of Directors will vote on this motion to launch the petition tomorrow night.

If the petition is not honored I am afraid further actions will be taken.

San Jose City staff and council members' policies are responsible for one senior's permanent injury by a person occupying this vehicle and frequenting this vicinity.

Do you need to have a child hurt to take notice and action before you bring your attention and remedy to this situation?

I have included the city clerk in this email. It is part of the public record relating to this request and the petition.
