The Director of Planning, Building and Code Enforcement requests a hearing to review the Notice to Register issued and sent to the Property Owner(s) for the blighted and vacant property 995 E Santa Clara St on May 29, 2025, and the Property Owner's Appeal of Notice to Register, received on June 5, 2025.

Recommendation: Affirm the Notice to Register the Subject Property (into the Neglected and Vacant Building Monitoring Program) actions on May 29, 2025, as set forth in the Staff Report dated June 20, 2025.

b. 914 ALBA CT (599-11-014) PROPOSED ABATEMENT

(Manuel Duarte, Code Enforcement Inspector/Rashel T Ross, Property Owner)

The Director of Planning, Building and Code Enforcement requests a hearing to consider the adoption of a proposed abatement order, to require the property owner by the end of ten (10) calendar days of the date of service of the Board's resolution to eliminate the blighted conditions, in all yard areas, trim all overgrown vegetation and remove all unpermitted items including but not limited to all inoperable vehicles (black GMC SUV & tan Toyota 4 door), auto parts, household items, lumber, recyclables, boxes, plastic containers, cardboard and all miscellaneous debris on the property, eliminate all substandard housing violations inside the residence including but not limited to restoring all paths of egress, removal of all solid waste, removal of accumulations of personal items stored in a manner that would create a harborage for vector/vermin and/or fire hazard and removal of all debris from the floor. Responsible party/occupant, Nathan Ross, shall cooperate with all requests for inspection.

Recommendation: Adopt the proposed abatement order requiring the property owner to take abatement action as set forth in the Staff Report dated July 16, 2025.

c. 000 ANNA DR (419-37-114) ADMINISTRATIVE REMEDY

(Brandon Riddle, Code Enforcement Inspector / Venkata Sivananda Lakshmanarao Garlapati)

The Director of Planning, Building and Code Enforcement requests a hearing on a proposed order to require the Property Owner to take the corrective actions to remove the unpermitted accessory building (storage container) from the vacant lot

Recommendation: Issue an administrative order as set forth in the Staff Report dated July 29, 2025.
