Mayor Matt Mahan requested to include the informational staff memorandum dated, December 1, 2023 as part of the motion. The make of the motion and seconder did not respond to the request.

Councilmember Dev Davis expressed her concerns with the word "encourage" in recommendation 2 of Councilmember Peter Ortiz' memorandum dated, December 5, 2023; and highly recommended removing recommendation 2 from the memorandum.

Councilmember Pam Foley suggested amending the language in recommendation 2 of Councilmember Peter Ortiz' memorandum dated, December 5, 2023, from "encourage" to "suggest".

Deputy Director, Planning, Building & Code Enforcement Department; Michael Brilliot offered the following additional language suggestion regarding recommendation 2 of Councilmember Peter Ortiz' memorandum dated, December 5, 2023; "Staff should inform Affordable Housing Developers that they are not required to

provide commercial space, however staff should either consider, suggest, or encourage that Affordable Housing Developers consider including commercial space if it is feasible as part of their project."

Deputy City Manager, Rosalynn Hughey suggested to use the word "explore" instead of "encourage," regarding the language in recommendation 2 of Councilmember Peter Ortiz' memorandum dated, December 5, 2023. The maker of the motion and seconder accepted the staff recommendation as part of the motion.

Councilmember Dev Davis requested to take a separate vote on Item 10.1(a)

Deputy Director, Planning, Building & Code Enforcement Department, Michael Brilliot, requested clarification of the motion on the floor.

Councilmember Sergio Jimenez confirmed that the staff suggestion to use the word "explore" instead of "encourage," regarding the language in recommendation 2 of Councilmember Peter Ortiz' memorandum dated, December 5, 2023, was accepted.

Mayor Matt Mahan stated that it doesn't fundamentally work to substitute the word "encourage" to "explore."

Councilmember David Cohen offered grammatical clarification that the word "explore" in recommendation 2 should read as follows: "To encourage Affordable Housing Developers to explore including commercial spaces"

Mayor Matt Mahan requested clarification of the motion.

Councilmember David Cohen stated that Council should reiterate its position to encourage affordable housing projects to have commercial space if feasible.

After further discussion, Mayor Mahan called for a vote, and stated the motion includes both the joint memorandum and Ortiz' memorandum, with the word "encourage" given unclarified modifications in recommendation 2 of Councilmember Peter Ortiz' memorandum dated, December 5, 2023.
