SUMMARY AND OUTCOME

Provide the quarterly update on debt management, investment management, revenue management, purchasing, and risk management activities.

BACKGROUND

The attached Second Quarter Financial Reports for Fiscal Year (FY) 2023-2024 (quarter ended December 31, 2023) (Financial Reports) presents the quarterly activity for the City of San José

(City) Finance Department's Debt Management, Investment Management, Revenue Management, Purchasing, and Risk Management programs (Attachment A). Additionally, the Second Quarter Investment Report for the Quarter Ended December 31, 2023 (Attachment B) is available on the Finance Department web page¹ and is included as part of this report to the Committee. As part of the ongoing effort to streamline work efforts within the Finance Department, these programs are combined into a single report for submission to the Public Safety, Finance and Strategic Support Committee (PSFSS Committee) for its review and referral to the City Council for acceptance.

A brief narrative discussion is provided below for all programs in this quarterly report:

Debt Management Program

This Second Quarter Debt Report focuses on the City's debt activities for the period ended December 31, 2023 and the following quarter ending March 31, 2024, and relates to the following elements of the City's Debt Management Program:

- Completed financings and current debt portfolio;
- Debt issuance, redemptions, and management activities completed during the second quarter and anticipated in the third quarter (January 1, 2024 through March 31, 2024); and
- Current interest rate environment as of December 31, 2023 and credit ratings.

Investment Management Program

Pursuant to the City's Investment Policy, verbal presentations in addition to the written reports are provided to the PSFSS Committee for the Second and Fourth Quarter Reports. The materials presented in this consolidated report provide a "snapshot" of the investment portfolio.

Revenue Management Program

The Revenue Management report highlights key aspects of the City's ongoing collection efforts. These efforts focus on reducing delinquent accounts receivable and enhancing revenue compliance through four primary collection programs: Accounts Receivable, Business Tax, Revenue Compliance and Monitoring, and Utility Billing. This report highlights the Revenue

Management Division's collection efforts and summarizes progress towards maintaining a return on investment ratio of 5.0 to 1. The second quarter FY 2023-2024 return on investment is 8.3 to 1, and FY 2023-24 fiscal year-to-date return on investment is 6.15 to 1.

<u>Overview of Collection Process</u> – City departments issue invoices for various fines, fees, or other costs incurred by the City. Invoices are entered in the City's centralized Accounts Receivable system or referred to the Accounts Receivable group for invoices generated by City departments through stand-alone billing systems. Each department is responsible for the initial invoicing of the appropriate parties.

If an account has an unpaid balance after 30 days, a delinquency notice, including any additional interest, penalties, and applicable fees, is generated, and mailed to the debtor. The account is then assigned to an Investigator Collector in the Finance Department, who begins the revenue collection process by contacting the debtor to attempt to collect the past due amount. After 60 days, a second collection notice, including any additional interest, penalties, and other fees, is mailed to the debtor. At this point, a collection cost recovery fee is added to each account. This cost recovery fee is reviewed and set on an annual basis. After approximately 120 days, the Senior Investigator Collector reviews each remaining delinquent invoice with Investigator Collectors to determine any appropriate action to take against the debtor to collect the outstanding balances.

<u>Overview of the Bad Debt Write-Off Process</u> – In addition to proactively collecting the City's delinquent accounts, it is important to write off the City's uncollectible debts to ensure the accuracy of the City's financial statements. On a periodic basis, the Finance Department, in coordination with Departments and the City Manager's Budget Office, establishes reserves for bad debt to cover potential write-offs of uncollectable accounts. The bad debt reserves are funded as an estimate of total billings each year, in each revenue category billed. The accounts recommended for bad debt write-off will be offset by bad debt reserves that have been established.

The annual analysis of the City's bad debt reserve is conducted by the Finance Department and reviewed by the City Manager's Budget Office during the year-end closing process. In addition, during the preparation of the City's annual financial statements, the City's external auditors review the City's bad debt exposure as well as the adequacy of the bad debt reserves.

The Director of Finance is authorized to write off as uncollectible any account or claim not exceeding five thousand dollars (\$5,000). No account or claim of the City exceeding \$5,000 may be written off as uncollectible without the express authorization of the City Council. As accounts are considered for write-off through the City's evaluation process, the following criteria are used to determine if an account should be written off as bad debt:

- Debtor has no assets, is out of business, or has no indication of future assets;
- Debtor is deceased and has no estate:
- Debtor is incarcerated for an extended or unknown period;

- Debtor filed bankruptcy;
- Debtor "skipped," moved, or sold property with no forwarding information; and/or
- Statute of limitations has expired.

The Finance Department recommends the PSFSS Committee forward the Citywide Write-Off Report (Attachment C) of delinquent accounts, with delinquent balances totaling \$1,053,825.71, to the full City Council for write-off approval. It should be noted a write-off is not a relinquishment of the City's claim for debts due to the City. Should new information arise that changes the collectability of these claims, the City may attempt to collect payment.

Accounts Receivable Amnesty Program - The pilot Accounts Receivable Amnesty Program² (Amnesty) was developed to increase statutory compliance while providing needed financial relief for City residents and businesses, by authorizing the Director of Finance to waive the respective late payment penalties, interest, and other collection levies in exchange for full payment of base fees and charges owed. The Amnesty application period began November 1, 2022 and continued through June 30, 2023, with eligibility limited to invoices billed between April 2020 to August 2021. The total population of eligible accounts was 3,600 accounts with outstanding balances of \$2.34M (base fees and charges of \$1.39M and \$950K in interest, penalties, and collection expenses). At the conclusion of the Amnesty, total payments received on eligible accounts amounted to approximately \$211K.

In partnership with the Department of Public Works Enterprise GIS team and the Information Technology Department, the Finance Department superimposed the eligible accounts' anonymized addresses on the San José Equity Atlas BIPOC and Income combined score map³. The equity index is a calculated score ranging from 2 to 10 based on race and income. Higher equity indices indicate a higher concentration of both people of color and low-income households in the selected census tract.

The Amnesty aimed to assist those accounts in low-income communities and with a higher equity index. During the Amnesty, the percentage of invoices paid from higher equity index score areas as compared to lower was evenly distributed and statistically insignificant. Table 1 shows the number of invoices and amounts paid by equity index.

During the Amnesty, 458 invoices were paid, representing 12.1% of eligible invoices. The Amnesty increased the administrative workload of collections staff, resulting in less capacity for collections oppose to administrative activities. While no additional staffing was used to operate the pilot Amnesty, a permanent continuation and/or expansion of the Amnesty would require additional staffing resources to ensure other collections activities remain on target. With the cost of additional staffing and the low collectability of invoices eligible for the Amnesty, Finance does not recommend continuing the Amnesty.

Purchasing Program

The Purchasing Report highlights the key aspects of the City's purchasing operations. The Purchasing Unit of the Finance Department is responsible for the centralized procurement of equipment, supplies, materials, information technology, and non-consulting services, pursuant to Chapter 4.12 of Title 4 of the San José Municipal Code. The Purchasing Unit's objective is to deliver procurement and contracting services pursuant to public procurement best practices. The Purchasing Unit is also leading two strategic initiatives: *Citywide Disparity Study* and *Procurement Improvement Initiative*.

<u>Citywide Disparity Study</u>. The City is partnered with MGT Consulting of America LLC (MGT) to study if there are any disparities between the City's use of minority-, women-, disabled veteran-, and LGBTQ+ business enterprises (collectively referred to as "diverse business enterprises" in its purchasing program, compared to the availability of diverse business enterprises in the marketplace who are ready, willing, and able to perform work. The objectives of the study are two-fold: (i) to determine whether the City, either in the past or currently, engages in discriminatory practices in the solicitation and award of contracts in goods and related services, professional services, public works and construction-related services, and non-professional services to diverse business enterprises; and (ii) to determine if a legally justified need exists for remedies in accordance with the guidelines set forth by case law. MGT has

completed the data collection and data analysis phases of the study and has provided staff with a draft report.

Staff is continuing to review drafts of the final report provided by MGT and providing feedback. Staff is targeting the middle of February to complete the review and feedback process so MGT can issue the final report. Staff contemplates the Third Quarter Financial Reports for fiscal year 2023-2024 to this Committee will include a confirmation of the completion of the study.

<u>Procurement Improvement Initiative</u>. The ordinance to implement changes to Title 4 of the San José Municipal Code was approved by the City Council in October 2023. The changes which included an increase to the informal procurement threshold and expansion of the ability to leverage other municipalities' competitive solicitations and contracts went into effect on November 16, 2023. Staff is finalizing the processes and procedures for implementing the changes. In the meantime, Purchasing is seeing increased willingness by City departments to leverage other municipalities' competitive solicitations and contracts. Staff continues to review the other recommendations in the study and assess options for future adoption and implementation.

Risk Management Program

The Risk Management report highlights the key aspects of the City Risk Management Program. The Risk Management Unit is responsible for the procurement and oversight of the City's property and casualty insurance programs. The Risk Management Unit also provides contractual risk management services, property subrogation claims reporting, and other key services to City Departments including enterprise departments such as the Airport Department and San José – Santa Clara Regional Wastewater Facility.

This quarter, the Risk Management Unit highlights include:

- Facilitated property loss prevention visits at the San José Santa Clara Regional Wastewater Facility, the Central Service Yard, the San José Museum of Art, and the Police Department Administrative Building;
- Negotiated \$504,516 in insurance recoveries from property and builders risk insurers related to property losses at History Park and the San José-Santa Clara Regional Wastewater Facility; and
- Implemented a business process automation for Self-Insurance Letter Requests.

EVALUATION AND FOLLOW-UP

The Finance Department prepares this report on a quarterly basis for review and approval by the PSFSS Committee. Finance Department staff will be available to answer questions on the Financial Reports at the PSFSS Committee meeting on February 15, 2024 and City Council meeting on March 12, 2024.



Outstanding Debt as of December 31, 2023: \$4.4 Billion FY2023-24 Debt Issuance: \$79.2 Million




□ City and Related Entity Debt Outstanding










SECURED OVERNIGHT FINANCING RATE



Total Investment Portfolio: \$2,385,783,590








INVESTMENTS BY FUND

GENERAL FUND BALANCE


- General Fund balances decreased by \$24 million during the quarter and ended with a balance of \$458 million as of December 31, 2023. General Fund balances usually peaks during the months of January and June, when the bulk of property taxes are received; declines in the summer due to retirement prefunding; and declines throughout the rest of the year due to debt service payments and operational expenditures
- Projected investment maturities, cash and revenues are sufficient to cover anticipated expenditures for the next six months

The following graph compares monthly balances of the five largest City funds as reported by FMS.






REVENUE MANAGEMENT PORTFOLIO






INVOICING AND PAYMENTSFIVE-YEAR HISTORY (FY 2018-19 to FY 2022-23)



OUTSTANDING RECEIVABLES THREE-YEAR HISTORY (Q3 FY 2020-21 To Q2 FY 2023-24)








FY 2023-24 Q2 DELINQUENT RECEIVABLES

COLLECTION STATUS SUMMARY (\$ IN MILLIONS*)



- Payments Received: \$210K
- Amnesty Waivers: \$73K
- Recommendation: No extension/expansion at this time

PURCHASING PROGRAM

PROCUREMENT IMPROVEMENT UPDATE

- Procurement Improvement is a Strategic Support initiative that was created under the legacy City Roadmap structure.
- Staff presented a status report on the efforts to implement the recommendations at the last quarterly meeting including the changes to Title 4 of the City of San Jose Municipal Code. The changes to Title 4 went into effect on November 16, 2023.
- Staff will continue to review and consider other recommendations from Procurement Improvement Study for adoption and implementation.





DISPARITY STUDY UPDATE

- A Citywide Disparity Study is underway to evaluate any need for new or updated procurement policies to facilitate participation of diverse business enterprises in City contracting.
- Finance-Purchasing, in collaboration with the City Manager's Office of Communications, Racial Equity and Economic Development & Cultural Affairs, is working with MGT of America Consulting, LLC to deliver this scope of work.
- MGT Consulting has provided staff with a full draft report of the study. Staff is reviewing the draft report and providing input to the consultant. Staff hopes to complete the review by the middle of February 2024.
- Target date for final completion of the study is end of March 2024.





RISK MANAGEMENT PROGRAM

The Division is responsible for the procurement and oversight of the City's property and casualty insurance programs and providing contractual risk management services, property subrogation claims reporting and other key services to City Departments.







General Fund Balances

The General Fund balances decreased by \$24 million during the quarter and ended with a balance of \$458 million as of December 31, 2023. General Fund cash balances usually peak during the months of January and June, when the bulk of property taxes are received, and decline in the summer months due to retirement prefunding, debt service payments and operational expenditures.

The following graph compares monthly balances of five largest City funds as reported by FMS.



Prefunding of Annual Retirement Contributions

The City opted to prefund Police and Fire Retirement Plan Tier 1 annual employer retirement contributions along with Other Post-Employment Benefit (OPEB) contributions for Fiscal Year 2023-24 with cash and matured investments on July 3, 2023. The total prefunding amount was \$211 million.

Successor Agency to the Redevelopment Agency of the City of San José

Historically, the Redevelopment Agency participated in the City investment pool with both restricted bond proceeds and operating cash balances. As of February 1, 2012, redevelopment agencies in California were dissolved by legislative action and the City, as the Successor Agency to the Redevelopment Agency (SARA), transferred the Redevelopment Agency funds from the investment pool to SARA bank accounts. In July 2018, the City entered the final stage of dissolution and absorbed the remaining SARA operations into City operations. City staff will continue to manage SARA's accounts until all assets are liquidated and bonds are redeemed.



Yield and Maturity Trend

The following graph illustrates the monthly dollar-weighted average maturity (WAM) of Fund 3 Portfolio (bar graph) along with the weighted average yield (line graph) for the past two years.

Fund 3 Portfolio Yield and Maturity Trends December 2021 – December 2023



Fund 3 Portfolio's WAM increased from 631 days on September 30, 2023, to 682 days on December 31, 2023. The weighted average yield increased from 2.998% on September 30, 2023, to 3.166% on December 31, 2023.

The Federal Reserve Bank elected to leave interest rates unchanged at the two final 2023 Federal Open Market Committee (FOMC) meetings. The Fed signaled that the Fed Funds Rate could be on hold for the foreseeable future, but would keep an eye on changing economic conditions. The consensus among market experts suggests that the Fed may begin cutting rates as early as March 2024 as inflation eases toward the Fed's 2% target. Staff made near-term investments to match anticipated cash outflows. New investments were purchased at higher yields, compared with matured and called securities. Additionally, staff invested excess funds strategically for longer terms (3-5 years) to lock in yields at recent relative highs given the changing rates outlook. As a result, the aggregate portfolio yield and WAM increased.



Comparison with Benchmarks

The City Total Portfolio is not compared to benchmarks as it includes various funds which have separate cash flows and investment requirements. Only the City's Fund 3 Portfolio is compared against benchmarks for performance purposes. The following graph demonstrates a yield comparison by month of the City Fund 3 Portfolio, the California LAIF, and the BAML Index for the period from December 2021 to December 2023.

Portfolio vs. Benchmarks December 2021 – December 2023



Notes:

- 1. City refers to City's Fund 3 Portfolio, and the yield data are month-end weighted average yields.
- 2. LAIF refers to the State of California Local Agency Investment Fund and yield data are average monthly effective yields.
- 3. **BAML** refers to Bank of America Merrill Lynch 1-3 Year AAA-A US Corporate & Government Index, and yield data are rolling 2-year effective yields.

LAIF is a short-term investment option available to local agencies in California. LAIF's WAM was 230 days as of December 31, 2023, much shorter than the City Fund 3 portfolio's WAM of 682 days. A shorter portfolio such as LAIF is better positioned to benefit from rapidly rising interest rates in the shorter maturities.

The BAML Index is a broad market index that tracks dollar-denominated, investment-grade, bonds with a remaining maturity of up to three (3) years. To simulate an index portfolio for comparison purposes, Treasury staff calculates a 2-year rolling average of daily BAML Index effective yields. The City's Investment Policy allows investments, in several sectors, up to a 5-year final maturity. As of December 2023, approximately 28% of the City's portfolio held securities purchased prior to October 2021 when interest rates were lower. As interest rates increased steadily for the majority of 2023, especially in the short term maturities (under 2 years), the BAML Index surpassed the City portfolio in performance and widened the spread.

Unrealized Losses and Gains

As shown in the Investment Summary Table on page one of this report, the total portfolio size as of December 31, 2023, was approximately \$2.39 billion. The following table illustrates the net unrealized gains or losses on the portfolio when comparing the portfolio's market value to both its original cost and amortized cost for the quarter ending December 31, 2023.

An inverse relationship exists between changes in interest rates (Yield) and the value (Price) of fixed income investment securities. As interest rates decrease, the value of fixed income investments increases. Conversely, as interest rates increase, the value of fixed income investments decrease. The City's investment practice, per the Investment Policy, is generally to hold securities to maturity, with exceptions as noted in the Investment Policy. The net unrealized losses noted above are "paper losses" and would only be realized if securities were sold prior to maturity.

Interest rates fell sharply across longer maturities this quarter as expectations of the commencement of Fed rate cuts are pulled forward. Rates are expected to fall further in 2024 as market expectations of Fed action get closer to being fulfilled. Given the inverse relationship between interest rates and value, this has led to a decrease in unrealized losses in FY 2Q 2023 to \$40 million (as compared with original cost) and \$46 million (as compared with amortized cost) as of December 31, 2023, respectively, as shown in the table above. These unrealized losses stood at \$76 million (as compared with original cost) and \$84 million (as compared with amortized cost) as of September 30, 2023. As interest rates are expected to decline, this may lead to a further reversal of unrealized losses.

Earned Interest Yield

The earned interest yield of the total investment portfolio for the quarter ended December 31, 2023, was 3.106%, 0.106% higher than the previous quarter and 0.873% higher than a year ago.

COMPLIANCE REPORTING REQUIREMENTS

Cash Management Projection

Based on the Finance Department's pooled cash flow projection as of December 31, 2023, total revenues, investment maturities and cash for the next six months are anticipated to be approximately \$2.4 billion. This is sufficient to cover projected expenditures of approximately \$2.2 billion.

Statement of Compliance with the Policy

There were no exceptions or violations outstanding for the quarter ended December 31, 2023. The investment portfolio meets the requirements of the City's Investment Policy and California Government Code Section 53601.

Comparison of Portfolio Investment Earnings to FY 2023-24 Budget

The following is a comparison of actual General Fund investment earnings, on an accrual basis, to the Fiscal Year 2023-24 budget. The Fiscal Year 2023-24 Budget included \$10.5 million for interest earnings for the General Fund, based on an assumed net interest yield of 2.75%. The schedule below compares the unaudited actual net investment earnings to the General Fund budget for the quarter ended December 31, 2023. The actual interest earning rates are greater than the forecast for the quarter and for the fiscal year.

In general, the City holds all securities to maturity. On rare occasions, the City may liquidate holdings to raise cash or as allowed under the Investment Policy.

INVESTMENT STRATEGY AND MARKET UPDATE

The Investment Program continues to focus on its core mandates of safety, liquidity, and yield. Staff continues its effort to match known cash flow outlays in the next 24-month horizon with investment maturities. Beyond the 24-month horizon, staff selectively invests in various assets classes and maturity buckets to diversify the portfolio structure and maximize the portfolio's earnings potential, as allowed by the Investment Policy.

The US economy showed signs of slowing at the end of this quarter as households pulled back on discretionary spending and labor demand also receded as economic growth cooled and inflation reverted closer to the Fed's target. Gross Domestic Product (GDP) reported an annualized rate of 4.9% in the third quarter of 2023 compared to the previous quarter rate of 2.1%, an increase of 2.8%. GDP for the fourth quarter is yet to be released and is tracking at a 2.1% annualized rate as per the Atlanta Fed. The national unemployment rate decreased to 3.7% in December 2023 from 3.8% for the previous quarter ended September 30, 2023. Year-over-year inflation decreased to 3.4% in December 2023, from 3.7% reported in the previous quarter and still above the Fed's target of 2%. The Federal Reserve elected to leave interest rates unchanged at the two final 2023 Federal Open Market Committee (FOMC) meetings. The consensus among market experts suggests that the Fed may begin cutting rates in early 2024 as inflation eases toward the Fed's 2% target.

Investment staff will closely monitor market developments, continue to focus on the overall quality of the portfolio and invest with care, prudence and diligence.

<u>Future Commitments</u> – As of December 31, 2023, the City had no obligations to sell securities and no commitments to participate in securities trading.

<u>Executed Reverse Repurchase Agreements</u> – No reverse repurchase agreements were executed this quarter.

Restructuring – No restructuring activities took place during this quarter.

CONCLUSION

The total investment portfolio as of December 31, 2023, was \$2,385,783,590 a decrease of approximately \$155 million from the previous quarter. For the quarter ended December 31, 2023, the earned interest yield increased from 3.000% to 3.106% as compared to the quarter ended September 30, 2023, and the weighted average days to maturity increased from 631 days to 682 days over the same period. As of December 31, 2023, approximately 46% of the total portfolio was invested in U.S. Treasuries and Agency securities.





SECTION C

PORTFOLIO HOLDINGS AT COST

Investment Status Report shows cost information of portfolio holdings including yield to maturity, accrued interest at purchase, current principal and amortized book value of the portfolio by investment type. Types of investments are described as follows:

MONEY MARKET MUTUAL FUND: An entity that pools funds and invests in a variety of short-term debt instruments. The City only invests in money market mutual funds that are invested in US Treasuries, federal agency securities, and repurchase agreements backed US Treasury and federal agency securities.

LOCAL AGENCY INVESTMENT FUND: An investment pool managed by the State Treasurer in which local governments and agencies in California may participate.

CORPORATE NOTES: Debt instruments which are issued by private corporations.

NEGOTIABLE CERTIFICATE OF DEPOSIT: A time deposit in large denomination with a specific maturity evidenced by a certificate. It is typically negotiated between the investor and the issuing bank.


COMMERCIAL PAPER: Short-term, unsecured, negotiable promissory notes of corporations.

FEDERAL AGENCY SECURITIES: Securities issued by US federal government agencies, including the Federal Agricultural Mortgage Corporation, the Federal Farm Credit Banks, the Federal Home Loan Banks, Federal Home Loan Mortgage Corporation and the Federal National Mortgage Association.

U.S. TREASURY OBLIGATIONS: Securities issued by the U.S. Treasury and backed by the full faith and credit of the United States.

SUPRANATIONALS: Debt obligations issued by international development institutions that provide development financing, advisory services, and other financial services to member countries to promote improved living standards through sustainable local economic growth.

MUNICIPAL BONDS: Debt obligations issued by states and local governments and their agencies, including cities, counties, government retirement plans, school districts, state universities, sewer districts, municipally owned utilities and authorities running bridges, airports and other transportation facilities.
