The District 4 Office Hours for October will be held on October 20, 2018 at VillaSport VillaCafé, located at 1167 N Capitol Ave. and is sponsored by Councilmember Lan Diep. This special event allows residents to meet with the Councilmember and discuss issues that are important to their community. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Lan Diep will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 4, City departments and the Office of the City Clerk to proceed with

the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.


