WHEREAS, the property located at 170 South Market Street, commonly known as the "South Tower Property," is currently operated as part of the Signia by Hilton San José hotel in conjunction with the adjoining property, commonly known as the "North Tower Property," both of which are currently owned by SC SJ Holdings, LLC, and in which SC SJ Holdings, LLC, seeks to sell the South Tower Property to a developer, AG170, LLC; and

WHEREAS, in 2002, the previous property owners, known as Light Tower Associates I & Light Tower Associates II, owners of the North Tower Property and South Tower Property, respectively, entered into a Lot Tie Agreement and Covenant Regarding Transfer and Certain Services dated March 15, 2002 (Lot Tie Agreement), with one another which restricts the property owner's ability to sell or transfer the South Tower Property to any entity that does not hold one hundred percent (100%) of the interest in the North Tower Property, unless they receive the prior written consent of the City of San José (City); and
