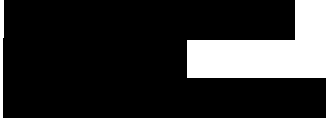
Dear Mayor Liccardo, Vice Mayor Jones, and Members of the San José City Council,

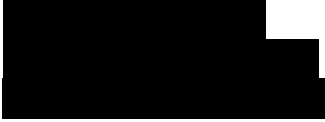

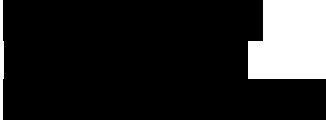

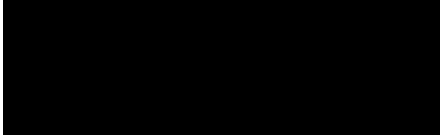
