**MINUTES OF THE  
JOINT MEETING OF THE RULES AND OPEN GOVERNMENT COMMITTEE AND  
COMMITTEE OF THE WHOLE**

**SAN JOSE, CALIFORNIA**

**WEDNESDAY, SEPTEMBER 20, 2023**

The Committee meeting was held in a hybrid format, both in person in the Council Chambers and teleconferenced from remote locations. The meeting convened at 2:01 p.m.

Present: Councilmembers - Kamei, Davis, Jimenez, Foley.

Absent: Councilmembers - Cohen.

### **1. Retroactive Approval of the Fiesta Patrias Reception, Mexican Flag Raising, and Lighting Events Sponsored by Council District 3 as City Council Sponsored Special Events to Expend City Funds and Accept Donations of Materials and Services for the Events. (Torres)**

The Fiesta Patrias Reception Event scheduled on September 14, 2023, the Mexican Flag Raising Event scheduled on September 15, 2023, and the Mexican American Heritage Lighting scheduled from September 14 to September 21, 2023, sponsored by Council Districts 3, were retroactively approved for placement on the August 8, 2023 City Council Agenda.

Action: Upon motion by Vice Mayor Rosemary Kamei, seconded by Councilmember Dev Davis, and carried unanimously, the Committee approved the item for discussion and consideration at an upcoming City Council Meeting for adoption of a resolution affirming the City of San José's support of the transgender and broader LGBTQ+ communities. (4-0-1; Absent: Cohen)
