#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Council District 7 has planned these community events. The events are free and open to the public and are supported through the efforts of many neighborhoods, businesses, and community volunteers. Additionally, books, games, toys, and dollar store items will be purchased for raffle prizes, and a limited number of gift cards under \$50 may be purchased for raffle and volunteer appreciation. The raffle will be free and open to the public.

The event will bring the community together to celebrate accomplishments in the neighborhood. The event is free and open to the public.
- 9. Valley Palms Neighborhood Association Christmas Celebration will be held on Wednesday, December 20, 2017 at the Valley Palms Family Resource Center and sponsored by the Valley Palms Neighborhood Association and Councilmember Tam Nguyen. The event will bring the community together to celebrate accomplishments in the neighborhood. The event is free and open to the public.
- 10. RockSprings Neighborhood Association Christmas Celebration will be held on Wednesday, December 20, 2017 at Los Paseos Senter and sponsored by the RockSprings Neighborhood Association and Councilmember Tam Nguyen. The event will bring the community together to celebrate accomplishments and provide resources for participants. The event is free and open to the public.
- 11. Approve and accept donations from various individuals, businesses, or community groups to support the events listed above.
- 12. Place the item on the January 9, 2018 Agenda for action.

#### **ANALYSIS**

Approval by the City Council of the events will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Tam Nguyen will report any cash or in-kind donations received for the events on their Disclosure of Fundraising Report (DFR-1).
