Dear Mayor, Vice Mayor, and Council Members:

Across the Bay Area, families are increasingly impacted by the housing crisis as rising rents and the lack of affordable housing in the area force them to move from their homes and communities. This burden is especially heavy for low-income families who already have fewer options when searching for housing, particularly when their housing search is dependent upon a landlord's acceptance of a Housing Choice (or "Section 8") Voucher or another housing assistance program. The Law Foundation therefore supports the Housing Department's recommendation to pass the Housing Payment Equality Ordinance, which will help to alleviate some of these burdens that families receiving rental subsidies face.

It is not uncommon for us to hear reports from the low-income tenants that we assist here at the Law Foundation that it is incredibly difficult to find a landlord who will allow them to use a Section 8 voucher at their property. Often times, individuals will spend a significant amount of time – nearly a decade in some cases – on the waitlist to get a Housing Choice Voucher from the Santa Clara County Housing Authority. Once someone becomes eligible for one of these coveted vouchers, they will only have a few months in which to use it; this means that if they do not find a landlord who will accept the voucher within that time frame, they will lose their voucher, be unable to re-enroll on the waitlist (which is now closed and includes over 4,000 people waiting to become eligible), and their years of waiting will have been for naught. The same is true of those who may otherwise need to move to a new rental property and continue using their voucher elsewhere. Without the crucial assistance that a voucher provides, many families are forced into homelessness or are displaced from their communities and must move away from their jobs, schools, healthcare providers, and other support systems.

As San José relies more and more upon voucher-based assistance to help low-income families facing displacement in this harsh rental climate, it is imperative that the City protect those who seek to utilize rental assistance programs so they can be stably housed and without fear of unfair discrimination. An ordinance like the proposed Housing Payment Equality Ordinance will work to prevent housing segregation, will expand opportunities for low-income tenants, and will help advance the City's obligation to affirmatively further fair housing. Because of the positive effects that can be achieved when vouchers are actually put into use, **the Law Foundation of Silicon Valley supports passage of the Housing Payment Equality Ordinance and the prohibition of housing discrimination based upon a tenant's source of income.**

The Law Foundation further supports a framework for the enforcement of this Ordinance that will allow the City and the aggrieved individuals themselves to take action if a landlord has not complied with its simple, straightforward directives. Should a prospective tenant with a voucher or subsidy be turned away when applying for an apartment because of their voucher/subsidy status, or voucher-holding tenants otherwise be discriminated against because of their source of income, it is imperative that immediate steps can be taken in order to remedy the wrong, especially given the aforementioned short window of time in which a voucher may be used. Given the general reliance upon and use of private enforcement mechanisms in state and federal fair housing laws, along with the low risk of abuse of such a mechanism, we feel that the right to private enforcement without intervening administrative barriers will ensure that landlords are taking the Ordinance seriously and complying with its requirements *every* time they interact with voucher-holding tenants, not just when they have received a slap on the wrist for failure to follow these easy rules in the first *reported* instance. The Law Foundation would also support the implementation of an administrative process, similar to one available to tenants in the ARO petition process, whereby aggrieved tenants or prospective tenants could seek assistance from the City in enforcing their right to be free from discrimination based on their voucher or subsidy status.

Along with the recently-introduced State Senate Bill 329 (Mitchell) (the "Housing Opportunities Act"), and similar to the vast number of source of income anti-discrimination ordinances passed in cities and states across the country, the Housing Payment Equality Ordinance will put those who receive rental assistance on equal footing with other renters while still providing landlords with the ability to run their rental business. These ordinances do not force landlords to rent to voucher holders, but rather give tenants receiving subsidies a fair shake at decent, stable housing. We hope the City of San José will stand behind its residents and pass the Housing Payment Equality Ordinance to give all of our neighbors that chance.

Tenant-based rental assistance programs are an essential resource in the response to the lack of permanently affordable housing in San Jose, and the destabilizing impact that severe cost burden, displacement, and homelessness are having on our communities. These subsidies promise a lifeline for struggling households -- the stability of affordable housing in the private market. Demand for these programs far outpaces existing resources and the waiting lists are very long.

It is disheartening, then, that those fortunate few who receive rent-vouchers often struggle to find suitable apartments. Extremely tight markets for rental housing in San Jose make the housing search difficult in the best of circumstances, but as staff has confirmed, Housing Choice Voucher (Section 8) recipients face the additional hurdle of landlords who refuse to rent to voucher holders or even accept applications from them. Tenants who cannot find an apartment with a willing landlord may lose their vouchers with little hope of future eligibility for affordable housing assistance, and increasing the likelihood of homelessness. The result is an opportunity denied -- continued hardship for lower-income households, and significant inefficiency in the use of these scarce affordable-housing resources.

**For these reasons, the undersigned organizations support staff's proposed *Housing Payment Equality Ordinance***, which prohibits housing discrimination based on a tenant's Source of Income (SOI), requiring that all persons with the ability to pay for housing should be treated equally when applying to rent an apartment or home, regardless of whether they receive a housing subsidy or housing assistance of any kind.

We also **support ongoing efforts to** coordinate with the Santa Clara County Housing Authority to:

- **Facilitate reduction of the administration burden that hinders the effectiveness of tenant-based rental assistance programs, without compromising habitability standards.**
- **Improve the overall effectiveness and efficiency of these programs, whether through landlord outreach and education, or various incentive structures to increase participation.**

While we support Staff's work in crafting a reasonable framework for stages of enforcement action, the remedies described pose real administrative challenges and burdens that will impact the policy's effectiveness without thoughtful implementation mechanisms. **We recommend that Council direct staff to develop mechanisms to identify cases of discrimination that violate the ordinance, track warnings for first offenses and identify repeat offenders, and allow for city and resident-led enforcement actions. Clear mechanisms and processes will ensure that reasonable enforcement does not cause undue burden on either the city or residents to document and substantiate cases of discrimination. These mechanisms will require ongoing coordination with the Santa Clara Housing Authority, and may include a program that would provide legal support to tenants to bring their own cause of action.**

Including tenant-based rental assistance subsidies as a protected source of income is a long-established means of addressing the otherwise legally allowable forms of Section 8 discrimination. To date 11 states, including Massachusetts, New Jersey, Oregon, Washington, and Washington, D.C., have extended these protections, as have over 50 cities and counties including New York, Chicago, San Diego, San Francisco, and Santa Clara County. More recently, State Senate Bill 329 (Mitchell), titled "Housing Opportunities Act," has been introduced in Sacramento to extend Source of Income protections to voucher recipients statewide.

Neither the proposed ordinance, nor any of those already in effect throughout the country, would force landlords to rent to voucher holders. What it will do is forbid them from using an applicant's rent subsidy as the basis for denying them the ability to apply or be selected for tenancy. We believe this is both important on principle, and an important step towards optimizing the effectiveness of these critical affordable housing programs.

You are in the enviable position of representing all members of this beautiful place where we live. As you attend the meeting next Tuesday to hear both sides of the presumptive need to force landlords to accept Section 8 vouchers, I would like you to consider the following comments from me as a small housing provider.

1. We are owners of a duplex & live next door to a rental unit.
2. What percentage of San Jose's population is qualified for vouchers? Are you creating a blanket ordinance to give a MINORITY OF RENTERS an advantage over other qualified renters? I think that you are by passing this ordinance.
3. Last year we accepted a Section 8 voucher from a program that supports returning veterans who are transitioning into civilian life. It was our choice, we took a hit of \$150 per month for the first year to help our Navy vet with a goal that we could support. I am proud to say that he is doing great, our son has now joined & is serving in the Navy, & we are nearly back to market rate.
4. Two years ago my other son rented a couch with roommates in Section 8 housing. The holder of the voucher was a 24 year old able bodied male who worked part time, which kept his income low, & stayed high most of the time. The apartment was not kept clean & filled with vermin. When my son moved back, I would not let him bring any belongings into our house until he left them outside for a week & checked each piece to avoid bringing vermin into our house.
5. We cannot afford to defend in court a decision not to rent to a tenant because we found someone who would be a better fit. As long as the City of San Jose will step in & pay for our court costs that resulted from a forced housed tenant with a voucher, & you include this guarantee in the ordinance, you will address a small housing supplier's pressing economic worry.

6. Will this ordinance include CSJ folks renting a room in their house? How about all of the granny units? Why not? How far will CSJ go to bring 'supposed equity' to a minority of represented citizens?

7. Philosophically, we have not accepted Section 8 because as many government entitlement programs are expanded, they just keep growing. Expansion of forced housing will increase my taxes by creating more demand, more need for CSJ employees to 'monitor & report on' the new ordinance enforcement, & more cost in the CSJ budget. Not identifying & disclosing the added costs to future budgets for all citizens of CSJ is disingenuous on your part.

Mayor Liccardo and City Council,

The California Apartment Association (CAA) supports the mission of voucher programs to assist low-income residents find safe, secure and affordable housing. CAA relies on many of our members who voluntarily participate in this program and encourage them to be open to working with local housing authorities and various rental subsidy programs. However, because of the significant challenges associated with Housing Choice Voucher (Section 8) program, a mandate is not feasible nor warranted.

The Housing Department's proposed 'Source of Income' ordinance is broad, requiring acceptance of all types of vouchers without regard to their compatibility with a particular unit or property. Accepting a voucher most often requires property inspections and government reviews that can take anywhere from two to four weeks to complete, time that an owner may not be receiving rent on the unit. Then upon clearing all the hurdles with the Housing Authority, it can take up two months to receive the first rent check. It's that kind of bureaucracy that discourages owners from opting into the program. It's a challenge that the Housing Authority knows well and has worked hard to address but they are limited by the resources provided to them by the Federal Government. Resources that will be limited further as the number of inquiries into this program increase from the mandate.

Housing Voucher programs, like Section 8, are complicated and differ from state and local laws. The Section 8 voucher program rules and regulations encompass nearly 800 pages of fine print. Property owners (especially small property owners) not familiar with the program will need legal counsel or housing authority staff to walk them through the requirements of the program. Under the Section 8 program, notices are different, the eviction process is different, a grievance process is mandated, plus many more requirements. At the same time, forcing owners to sign a federal Section 8 contract would certainly raise constitutional challenges.

Requiring rental owners also accept the short-term rental assistance vouchers offered by the City and non-profits pose a dual risk to both the owner and the tenant. The City and non-profits offer vouchers that are designed to rehouse someone for a limited amount of time, typically six months to one year. If the tenant is unable to secure an ability to pay the rent once their voucher has expired, they run the risk of being evicted for nonpayment of rent and having that eviction on their record.

This proposal by the Housing Department fails to take the proactive step of working with the Housing Authority and property owners to develop programs that would encourage

adoption of housing vouchers and instead are proposing to add another burdensome ordinance that places the responsibility to ensure vouchers are utilized on somebody else.

CAA understands the housing authority and the city significantly lack the resources and funding to efficiently administer the program. Mandating that every owner accept Section 8 will only further strain housing authorities and lead to increased costs and delays for rental property owners. This proposed ordinance is a costly new mandate, without providing any additional funding for the housing authority to effectively do its job or offer incentives to for landlords to accept vouchers by reducing risk and streamlining the program in an effort to encourage owners to willingly accept tenants with Section 8 or other housing vouchers.

I am writing to you as a property owner and housing provider in the City of San Jose. I am concerned that the Housing Payment Equality Ordinance is vague, complicated and problematic, making compliance difficult to determine. In addition, the proposed Ordinance does not appear to apply to one of the largest housing providers in the City, namely San Jose State University. As someone who owns rental property, I want to urge you to reconsider the mandated burden that this ordinance unfairly imposes on small housing providers.

Table 2 of your staff report indicates that out of a total of 19,179 vouchers available, approximately 16,486 voucher holders are housed, which means **86% of voucher holders are finding housing without the proposed mandate, and only 5% of voucher holders are currently shopping for housing.** It seems unnecessary to mandate acceptance of voucher holders when the vast majority are already housed and the percentage of voucher holders seeking housing doesn't appear to deviate from the percentage of the general population seeking rental housing.

A housing voucher, such as those provided by the governmental bodies

and nonprofits, carries a significant compliance challenge. Vouchers require another level of compliance determination, which is difficult and expensive for small landlords such as myself who manage their own properties. There are many owners who own and operate their properties that will find it difficult to carry the financial risk of having to accept vouchers but will have to shoulder the financial burden of waiting weeks or months to receive rent checks. Furthermore, accepting a tenant with vouchers puts a landlord at increased risk of a tenant unlawfully holding over should the vouchers become unavailable and the tenant can no longer afford the rent.

The naturally affordable units that many of the voucher holders will seek tend to be rent controlled units that are already subject to a litany of regulations. Please consider all of the laws the City of San Jose has passed that impact small owners like me before you pass new ones that are vague, create additional financial risk and are not necessary.

Dear Mayor Liccardo and members of the City Council:

I am a District 6 resident. My family owns, and I manage, residential rental properties in San Jose. I'm writing to express my concern about the proposed Housing Payment Equality Ordinance, Agenda Item 4.4 on the August 13, 2019 Council Agenda. My concerns are as follows:

1. I agree that there is a housing problem in this Valley. It's impossible to ignore, and must be addressed. However, this seems to be part of a "scattershot" approach undertaken by various jurisdictions in an attempt to take quick action. Unfortunately, adding another level of regulation onto an already burdensome regulatory structure will lead to ambiguity and confusion. I believe that what's really needed is a multi-jurisdictional, inter-disciplinary effort that includes the city, the county, and ABAG at the very least. This effort should include departments of Housing, Building, Finance, Social Services, Transportation, etc. and should develop a **regional** transitional housing model that fills a gap in the housing continuum to temporarily house residents, educate them about their responsibilities and prepares them to be good tenants. Education should include budgeting, household maintenance, life and job skills. It's unreasonable to expect formerly homeless to immediately understand what it takes to be successful in permanent housing. We need to support them as they move from homelessness to transitional housing to hopefully stable rental housing.
2. It's important to ensure that landlords aren't at undue financial risk under the current Section 8 structure. Landlords shouldn't have to wait an unreasonable length of time to get units inspected by the Housing Authority, or, if vouchers expire, be burdened with financially unqualified tenants whom they otherwise would not have accepted. All that does is put financial stress on the tenant and create a heightened risk of default, which creates financial stress on the landlord, who may have to undergo the time and expense of the unlawful detainer process and suffer damage to property. Landlords shouldn't have to wait for payments – they have bills to pay and for most cash flow is an issue. Close these gaps in the program then educate landlords about benefits of accepting vouchers.

3. Landlords are currently subject to a highly regulated environment, which regulations come from myriad jurisdictions – Federal and state fair housing, city rent control, not to mention state landlord-tenant rules and processes that are strongly skewed toward tenants. This ordinance would create another regulatory burden that falls on landlords, and most small landlords don't have the resources to adequately respond to the burden thereby creating another financial stress for landlords, most of whom cross their fingers and pray they're doing the right thing.

4. Is this really going to help? Most landlords have rental policies in place that require successful applicants to have a certain income-to-rent ratio and credit score, in addition to other factors (no bankruptcies, no evictions, no felony records, etc.) It's likely that many section 8 applicants won't qualify based on other, legitimate factors and this will just be another regulatory structure that will cost landlords money to ensure compliance and at best, add only a few available units for voucher applicants.

I urge the Council to consider my concerns and direct staff to return with a draft ordinance that addresses these concerns. Alternatively, I urge the Council to consider the recommendations contained in the Memorandum circulated by Councilmembers Khamis, Foley, Davis and Diep.

I am writing to you as a housing provider in the City of San Jose. We are concerned the Housing Payment Equality Ordinance is complicated and problematic. Therefore, I urge you to reconsider the mandated approach this ordinance takes.

A housing voucher, such as those provided by the governmental bodies and nonprofits, carries a significant amount of compliance challenges. There are many owners who own and operate their properties who will find it difficult to carry the financial risk of accepting vouchers, to wait weeks or months to receive rent checks, to go through the inspection process and to manage tenant(s) who operate by a different set of rules.

The naturally, affordable units many of the voucher holders will seek are rent-controlled units, which are already subject to a litany of regulations. Please consider all of the laws San Jose has passed that impact these owners before you pass new ones.
