Honorable Mayor and Council Members,

PAC\*SJ thanks you for the opportunity to consider our comments regarding the following recommended actions:

- (a) Approve a master plan for an approximate 2.5-acre public park located along the northeast side of Seely Avenue, approximately 500 feet northwest of Montague Expressway.
- (b) Approve a Turnkey Parkland Agreement between the City of San José and SummerHill Epic Way LLC, Seely Development Partners, LLC, and Trimble Building A Holdings LLC to satisfy the requirements of the City's Park Impact Ordinance (San José Municipal Code Section 14.25) and Parkland Dedication Ordinance (San José Municipal Code Chapter 19.38) which include:
  - (1) Dedication of a 2.506 gross acre site to the City;
  - (2) Design, construction, and dedication of park improvements on this site;
  - (3) Payment of City Design and Review Fees; and
  - (4) Payment of Parkland Fees.
- (c) Direct the City Clerk to record a certified copy of the Turnkey Parkland Agreement, including the exhibits hereto, with the Office of the Recorder for the County of Santa Clara.
- (d) Adopt "Eiichi Edward Sakauye Park" as the official name for the park as recommended by staff and the Parks and Recreation Commission and as a result of a public outreach process.

First off,PAC\*SJ wishes to thank The Mayor and Counsel for its discussion at its 8/13/24 meeting of its desire to ensure the Sakauye Farmhouse's preservation. Since that time, the developer has kept the farmhouse on site pending its eventual move to History Park. As funding for relocation is being pursued, we encourage the City and the developer to do everything possible to protect this historic asset. Even with fencing, security cameras and patrols, there were several fires under the Pallesen Apartment Building when it was sitting on the same type of box cribbing that the Sakauye home sits on now. The developer in that project applied fire retardant on the undercarriage of that building that likely saved it. Also, given the City's recent experience in a lengthy process of authorizing the ascension of the Coyote Depot into History Park, PAC\*SJ would like a formal assurance that the Sakauye House will remain on site until full funding is secured from outside sources, or the developer provides the remaining funding. PAC\*SJ also recommends that the City require that Landmark Eligible buildings such as this one, be appraised and insured against loss while they remain on a development site.

Despite our deep respect for the hardworking people of San Jose's PRNS, and our sympathy for the monumental challenge facing this department

relative to deferred maintenance, it is our opinion that the Conceptual Master Plan (Exhibit B) and its 35% Construction Drawing (Exhibit B1) are far from adequate in commemorationing Eiichi Sakauye. We are grateful that PRNS listened to the family and got the name of the park properly named, but do not believe this plan reflects the will of the people of San Jose or the desires of the Japanese-American Community. While the 149 page Parkland Agreement document provides great specificity about everything else, it includes almost nothing about how it will recognize Eiichi Sakauye's life experience and contribution to the greatness of our City (no public engagement, no examples, nothing).

As for today's Agenda Item, Staff's memo provides a summary of feedback from members to the City's survey of members of the public living in proximity of the project. Staff's report includes data that "Historic Interpretation" ranked second only to the pickle ball court in importance, with park space for dogs coming in 6th out of 9 generic park features. And yet, the space allocated to dogs dwarfs the pass through area of commemoration of Eiichi Sakauye. We believe that the general public who live in the area were likely customers of the farmland that was operated into 2024, and were sufficiently moved by what little they actually heard of Eiichi Sakauye's life story to rank its importance higher than a dog park that will occupy a significantly higher proportion of the park's space.

If Council accepts Staff's recommendation to accept the 35% design before you today, it is our understanding that the elements and proportions of the park plan will be locked in place for the next 5 years with no opportunity for the family, JAM, History San Jose, PAC\*SJ or the public in general to ask for any additions or alterations within the proposed park's boundaries that could better honor Eiichi Sakauye. Given that NO funds will go into the City coffers for this park or the Alviso Park until 2030, we respectfully ask what in the world is the rush to accept the current 35% design?

That said, PAC\*SJ sees the importance to the project's success in the financials associated with the park clearly specified (as is the case with the current draft of the Parkland Agreement) so PAC\*SJ respectfully requests that the Council add and/or modify language relative to the 35% design to

allow for reasonable changes that specifically benefit the City's commitment to commemorate Eiichi Sakauye. PAC\*SJ further requests that Staff be given guidance to develop a Master Plan that truly represents the interests of the people. Doing less than this risks making it look like we don't care about the commemoration of a truly worthy American citizen. The total budget could be capped using current numbers.

Finally, PAC\*SJ reminds Counsel when this project was last discussed we stated very clearly that we were not in any way opposed to the proposed housing of this project. We hoped for an onsite retention of artifacts and trees, but did not challenge the demolition of all but one of 18-structures on a working orchard that dates back to the late 1,800s. At one point, this Developer was willing to work with the City to preserve the Sakauye house on site if PRNS would have accepted its relocation within the park. We know that ship has sailed, but the Staff Report Recommendation before you today erroneously asserts that the building could not be saved in the park space. That is not the case. It could have been saved on site, and could have made for a much more effective commemoration of Eiichi Sakauye. We believe this "it can't be done" mindset needs to change if we are ever to develop solid public/private partnerships that can address the financial and operational concerns that PRNS rightfully deals with on a daily basis.

In short, PAC\*SJ believes that we need to find a way to better honor Eiichi Sakauye.
