RECOMMENDATION

Accept the annual report on the Citywide Capital Improvement Program for fiscal year 2017-2018.

OUTCOME

The Citywide Capital Improvement Program (CIP) Annual Report provides the Council an opportunity to review up-to-date information on major public works projects and programs worked on during the 2017-2018 fiscal year.

BACKGROUND

Since early in the 2000's, the CIP Report has provided Council with periodic updates on the status of the Citywide CIP. At the peak of this period, the status report was produced quarterly and tracked more than 600 projects for a 5-year adopted CIP budget of close to \$4,000,000,000. Comparatively, the current 5-year adopted budget is approximately \$3,300,000,000 with a projected annual amount of 240 active projects. The CIP Report focuses on currently active major public works projects and is currently presented twice each fiscal year, a mid-year report and an annual fiscal year end report

ANALYSIS

This report is intended to provide a summary of the FY 2017-2018 CIP. Project information is sourced from the Capital Project Management System as of June 30, 2018, and has been coordinated with all project delivery partner departments.

In summary, from July 1, 2017, through June 30, 2018, the Citywide capital program has completed 71 major construction projects valued at \$151,500,000 and has awarded 50 major

projects valued at \$290,300,000. The CIP received an average of 3.3 bids per project with an average bid variance of 1% below the engineer's estimate (median variance of -0.9%). Section II of this report contains Citywide and City Service Area specific CIP updates.

There are a number of new programs and policy initiatives being worked on in the City's capital improvement programs that will enhance project delivery and create greater opportunities for our residents, employees and employers partner in the delivery of the CIP. These initiatives are summarized below:

- Project Manager development: Continued investment in the development of our project managers and the recruitment of new team members is the most critical factor to ensuring that we can deliver a quality CIP program with our community. In 2018, the Department of Public Works kicked off a training program for CIP managers and the rotation program for entry level managers continues to be valuable in ensuring cross training of staff.
- Local and Small business participation: Public Works is working with the Community and Economic Development Committee on policy alternatives to encourage more local, small and disadvantages business participation on City projects. Policy alternatives such as a potential local business preference, will be presented to the Community and Economic Development Committee in early 2019. In the FY 17-18 reporting year, local contractors were awarded 16 contracts (32%) totaling \$158,400,000, of which 7 (22%) were also small businesses totaling \$8,200,000.
- Project Labor Agreements: On October 16, 2018, the Mayor and City Council directed staff to enter into a PLA with the Santa Clara and San Benito County Building Trades Council. On November 8, 2018, the draft PLA was approved by the Regional Wastewater Facility Treatment Plant Advisory Committee and is expected to be executed within the next month. In future CIP Annual Reports, the Public Works department will report on out the statistics and trends associated with projects on which PLAs are applied.
- Public Works Audit Implementation: On August 7, 2018, the Mayor and City Council
 accepted an audit of the public works department's project delivery processes. A list of
 audit recommendations and status is included as an appendix to this report.
- Measure S: On November 6, 2018, voters approved Measure S which modifies the City's charter to update contracting rules for public works projects. These modifications include the increase of the minor public works threshold from \$100,000 to \$600,000, the design-build threshold decreases from \$5,000,000 to \$1,000,000, bid notices to be published online electronically, and the addition of "Best Value Contracting" as an alternative procurement method.
- Measure T: On November 6, 2018, voters approved Measure T which allows the City to issue \$650,000,000 in General Obligation Bonds to upgrade the City's infrastructure.

Bond funding would be used to upgrade public safety buildings, emergency/disaster response facilities, and roads and bridges. City staff will report back to the Mayor and Council on a proposed implementation plan for Measure T in early 2019.

EVALUATION AND FOLLOW-UP

The Citywide CIP Annual Report documents the progress of the Citywide CIP Program activity in FY 2017-18. This program is committed to the delivery of quality projects that are on time and on budget. Additionally, in 2019 staff will look at revising the timing of this CIP report to better coincide with reports related to Measure T implementation and the City's infrastructure backlog report.

PUBLIC OUTREACH

This memorandum will be posted to the City's website for the December 4, 2018, City Council Agenda.

COORDINATION

This Annual CIP Report has been coordinated with the Airport, Environmental Services, Fire, Library, Parks, Recreation and Neighborhood Services, Police, and Transportation Departments as well as the Offices of the City Attorney, City Manager and Cultural Affairs.

COMMISSION RECOMMENDATION/INPUT

Capital projects identified in this report may have included suggestions, recommendations or actions from a City Commission. Projects with specific City Commission action will be individually reported through the appropriate department action.



SECTION I PROGRAM OVERVIEW

The City of San José implements and manages a Capital Improvement Program (CIP) that was approved by the City Council as the 2017-18 Adopted Capital Budget and 2018-2022 Capital Improvement Program. Projects were recommended for funding in the proposed CIP in consideration of approved budgets, policy guidelines, public safety and/or economic development urgency, approved master plans and external regulatory agencies. To facilitate program delivery across multiple departments, the City worked within the City Service Areas (CSA) and Capital Programs identified in Appendix 3.

The 2017-18 Adopted Capital Budget totaled \$1 billion and included significant investment in infrastructure improvements at the San José-Santa Clara Regional Wastewater Facility (RWF), as well as investment in the rehabilitation and enhancements of a variety of park assets and recreational facilities, pavement maintenance, and continueing renovation of the City's cultural facilities.

From July 1, 2017 through June 30, 2018, the CIP completed 71 projects valued at \$151.5M with an additional 48 projects under construction valued at \$307.2 M. There were 50 projects awarded valued at \$290.3M with an additional 7 projects in the bid phase valued at \$107.1M. The CIP also has 93 projects in the feasibility and design phase valued at \$258.9M, as detailed in Chart 1¹. Over the past five years, this brings the City to 335 projects completed at a value of \$529.2M which is reflected in Chart 2 by fiscal year.




Chart 2: Totals Completed Projects and Total Values

Report Objective and Contents

This Year End Status Report is intended to provide an update on the FY 2017-18 CIP for the period of July 2017 to June 2018. This Status Report contains information on the CIP projects tracked through the Capital Program Management System (CPMS) database.

Two types of project classifications are tracked in this report:

- Major Public Works Construction Projects projects that result in the construction of capital improvements with a value of \$100,000² or greater. These projects are typically publicly bid and awarded to the lowest responsive and responsible bidder. However, construction projects can also be built by City forces or built by other jurisdictions or entities through an agreement.
- Public Art Projects projects involving artworks that are funded by the CIP. Public art projects may be associated with a specific capital improvement or as part of a larger public art strategy with funding support from the CIP.

Project Updates

Appendix 1 provides schedule information, current project phase and anticipated completion date for projects that are active in FY 2017-18. Appendix 2 provides a list of the projects that achieved Beneficial Use and are considered substantially completed in FY 2017-18. Projects are sorted by CSA and are listed according to project phase.

Project Budget

Project specific budget information is included for FY 2017-18 projects listed in Appendix 1 of this report. Budget figures provided reflect the baseline budget, current funding programmed, or construction contract award for that particular project in the CIP. Baseline budgets are usually set once the project scope is complete and a schedule has been determined.

CIP Performance Measures

The Citywide CIP has a set of consistent and comprehensive performance measures along with targets and goals that have been established in two key areas: *schedule (cycle time) and project delivery cost.* During FY 2017-18, the on-schedule performance was estimated at 84% (65 of 77 projects on schedule with an 85% target) and the on-budget performance was at 85% (51 of 60 projets on schedule with a 90% target). The Capital Performance Measurements of schedule and project delivery cost are tabulated and presented in a holistic manner in the 2017-2018 Adopted Capital Budget and more specifically in the 2017-2018 Adopted Operating Budget.

Public Works Audit Implementation

On July 27, 2018, the Mayor and City Council accepted an audit of the public works department's project delivery processes. A list of audit recommendations and status is included as an appendix 4 to this report.

SECTION II CITYWIDE CAPITAL IMPROVEMENT PROGRAM & CITY SERVICE AREAS (CSA) UPDATES

In this section some of the specific citywide and CSA updates are discussed.

Citywide Capital Improvement Program (CIP)

1. Management and Administration

Bidding Environment – During FY 2017-18, the CIP conducted 47 construction bids totaling \$107.7M. During that time, the program received an average of 3.3 bids per project with an average variance of 1.0% below the engineers estimate (median variance of -0.9%) which is within the industry average of $\pm 5\%$ variance. During FY 2017-18, The CIP returned to historical averages of number of bidders and variance from engineers estimate. Chart 3 illustrates the fluctuation of high and low bids seen from project to project. Chart 4 compares the variance in bids for FY 2017-18 with the previous five fiscal years.

Project Manager Development – With the Departments turnover numbers and a large number of new employees, Public Works will continue to conduct project manager training programs to further develop the workforce.




Chart 3: Variance of Engineer's Estimate FY 2017-18

2. Local and Small Business Participation

The Public Works Department tracks local and small prime contractor participation for CIP Major Public Works construction contract awards each fiscal year. This data is collected through a voluntary form filled out by Contractors during the contract execution stage. During FY 2017-18 there were 50 CIP construction contracts awarded totaling \$290.3M. Local contractors were awarded 16 projects (\$158.4M), of which seven (\$8.2M) were also small businesses. In comparison, local business contract awards saw a decrease in FY 2017-18, however, the total dollars awarded increased significantly. Chart 5 and 6 provides a comparison of the previous five fiscal years.




Chart 5: Local and Small Business Contracts Awarded (as Percentage)




Chart 6: Local and Small Business Dollars Awarded (as Percentage)

3. Contract Costs by Project Type

The Capital Program has compiled data on three project types that are completed on a regular basis. This data captures only the main portions of the projects. These projects include airport pavement projects (excludes demolition and utilities), cast iron sewer replacement projects (excludes traffic control, mobilation, and pipe rehabilitation), and Citywide street paving projects. Over the past five years the capital program has seen a steady increase in the construction cost per unit of measurement. Staff will continue to utilize this information when generating engineer estimates for projects. Charts 7-9 reflect the increasing cost.



SECTION III PROJECT UPDATE INFORMATION FOR APPENDICES

Appendix 1 provides schedule information, current project phase and scheduled beneficial use date for projects that are active in FY 2017-18. The status of the projects shown in this report will be represented by one of the following five categories:

- On Schedule: Projects are determined to be on schedule if they are completed within two months of the committed completion date. Projects are also in this category if no previous schedule commitment existed, in which case a schedule is established with this report. This may include projects that had pending schedules at the time of the previous report. In addition, projects that have a working schedule are considered on time. Finally, schedules for public art projects that are adjusted in order to align with the implementation of their associated capital improvement projects are considered to be on schedule.
- Extended: Projects have extended schedules when the project is running more than two months behind the committed delivery date. Unless the project delivery team is able to make up the delay prior to project completion, these projects will track as extended schedule projects appropriately in the Adopted Capital Budget.
- Reset: Projects that have their schedule reset are those where committed schedules are no longer feasible as a result of significant changes in scope, bid protests or due to Council or Manager directed reprioritization. Schedule resets are not granted for delays within the control of the project team. Upon approval of this report, the schedules shown in Appendix 1 will reflect the new baseline schedule commitments.
- Pending: Projects that do not have schedules at the time of this report are noted as Pending. The schedules for these projects are uncertain due to incomplete scoping, community concerns, real estate or funding issues. New projects beginning activity in FY 2017-18 that have not been fully scoped are shown as schedule pending. Projects whose schedules will be set at the time of award of the construction contract are noted as Pending. Projects with schedules pending are counted as active projects.
- On-hold: Project schedules that have been deferred and placed on-hold.

Project specific budget information is included for FY 2017-18 projects listed in Appendix 1 of this report. Budget figures provided reflect the baseline budget, current funding programmed, or construction contract award for that particular project in the City's CIP. Baseline budget or current funding programmed includes all past, current and future fiscal years of funding. Baseline budgets are usually set once the project scope is complete and a schedule has been determined.

The baseline budget serves as a commitment for delivery and a reference point for measuring on-budget project delivery performance. At the latest, a project budget will be set at the time of award and until then will be identified as "TBD". Alternatively, with the increasing use of time-and-materials/on-call contracts as an alternate project delivery method, budget information for projects completed under these contracts will be listed as "TBD" and reflected in the on-call contract total only to avoid duplicative reporting.

It is important to note that the baseline budget for a project may not match the budget amount shown in the 2017-18 Adopted Capital Budget and 2018-2022 CIP. A project may be sufficiently funded in the CIP yet exceed the committed baseline budget and, therefore, may not be considered on-budget for performance measurement purposes. Projects that have their baseline budgets reset are those where committed budget amounts are no longer feasible as a result of significant changes in scope. Budget resets are not granted for projects that simply exceed their established budget without an external influence.
