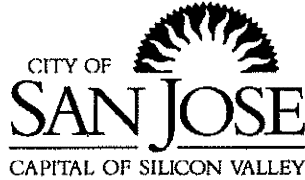
**RECOMMENDATION:**

## RECOMMENDATION

1. Retroactively approve the Safe and Green Halloween event scheduled on October 25, 2019 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Retroactively approve and accept donations from various individuals, businesses, or community groups to support the event.
3. Place the item on the November 12, 2019 Council Agenda for action.

## BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Safe and Green Halloween event was held on October 25, 2019 at various elementary schools in District 3 and sponsored by Councilmember Raul Peralez. This special event brought together hundreds of elementary students and community engaged learners to implement interactive activities focused on sustainability themes such as recycling, active lifestyles, water conservation, energy efficiency and healthy eating. The event also included a Sustainability Fair for the students to participate in.

## ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure

Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
