RECOMMENDATION

1. Approve WEPA Salsa Festival scheduled on June 13, 2025, as a City Council sponsored Special Event and approve the expenditure of funds.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

WEPA Salsa Festival 2024 will be held on June 13, 2025, at Parque de los Pobladores and sponsored by Councilmember Rosemary Kamei. The event is co-hosted by the cultural nonprofit organizations MACLA/Movimiento de Arte y Cultura Latino Americana and San Jose Jazz. It commemorates El Día de San Juan, which is a popular celebration of life and joy focused on San Juan, the patron saint and namesake of the capital of Puerto Rico. This Puerto Rican tradition features top-notch music performances grounded in Puerto Rican culture, including Salsa, Bomba, and Plena. It is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Rosemary Kamei will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 1, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
