A Participant to a Proceeding may voluntarily report a campaign contribution on the form located on <u>the Levine Act webpage</u>. The City San José is committed to open and honest government and strives to consistently meet the community's expectations by providing excellent service, in a positive and timely manner, and in the full view of the public.
