(D) REPORTS TO COMMITTEE

1. Parks, Recreation and Neighborhood Services Community Impact Annual Report. (Parks, Recreation and Neighborhood Services)

Parks, Recreation, and Neighborhood Services' Director Jon Cicirelli, Public Information Manager Daniel Lazo and Division Manager Dave Delong provided a presentation and responded to questions with the department's Division Manager Hal Spangenberg and Deputy Director Avi Yotam.

<u>Action</u>: Upon motion by Councilmember Domingo Candelas, seconded by Councilmember Omar Torres and carried unanimously, the annual report on Parks, Recreation and Neighborhood Services Community Impact, including the transition of programming from cost recovery to equitable access for 2021- 2022 was accepted. 2. Family Camp Status Report. (Parks, Recreation and Neighborhood Services)

The motion included direction for staff to return with a status update to the Neighborhood Services and Education Committee meeting in Fall of 2023 after the Neighborhoods Conference.
