2023-2024 Budget: Overall Performance Met Revised Expectations

- Revenues generally performed as expected
- Overall expenditures ended the year within or below budget
- General Fund had an <u>extremely</u> small surplus and most other funds ended the year with balances at or above estimated levels
 - After rebudgets and clean-ups, GF fund balance variance of 0.05% of Modified Budget revenues and expenditures
- Recommended actions close out 2023-2024, adjust 2024-2025 as necessary and in accordance with City Council Policy 1-18, recognize grants and reimbursements, and address several urgent needs in the General Fund, Special Funds, and Capital Funds.

General Fund: Additional Fund Balance

- General Fund ended the year with a gross fund balance of \$600.9 million;
 \$24.5 million above the estimate used to develop the 2024-2025 Adopted Budget (0.6% of the Modified Budget for revenues and expenditures)
- Net of required adjustments to close out 2023-2024, the Ending Fund Balance variance was \$2.4 million (0.05% of the Modified Budget for revenues and expenditures)
- As revenues ended the year slightly below estimated levels, this marginal amount of fund balance was solely generated by expenditure savings, primarily within the City-Wide expenses category



Selected Special/Capital Fund Performance


Building & Structure, Construction Excise, and Construction and Conveyance Tax Revenues

- Adopted Budget assumes passenger activity for 2024-2025 is 12.5 million passengers
