Action: Upon motion by Vice Mayor Pam Foley, seconded by Councilmember Anthony Tordillos, and carried unanimously, the City Manager, or her designee, were authorized to negotiate a donation agreement to receive the Peace Monument, an artwork by artist Mario Chiodo from donor Diane Brandenburg, to be sited at Arena Green West in accordance with the City Council- approved Donation and Monument Policies. Seventh Amendment to the Agreement with Kone, Inc. for Elevator Maintenance Services.

• Open Forum

1. Azazel Holmkust spoke on behalf of Yuri Castillo, an RV community member, who stated that traditional housing is no longer affordable in one the most expensive cities in the United States. For this reason, the City should expand it's safe parking capacities citywide, not have towing or sweeps where there is no safe parking options available, a 72-hour notice before relocation, and suggested having an RV community advisory group.
2. Manuel Cortez (*Spanish translation assisted by Wordly*) expressed his financial struggles since the pandemic, losing his job and house. He expressed the City's allocation of funds on hotels, but the lack of funding for parking spaces.
3. Maria spoke to (*Spanish translation assisted by Wordly*) urged the City to provide safe mobile home parking spaces where they can have peace, comfort, and dignity. She spoke to the City spending more on hotels, but not a safe parking lot.
4. Emma addressed the importance of having permanent stable parking spot throughout their community to avoid sweeps. She suggested that the City should partner with the VTA and the County to get permanent parking spots.
5. Aldo Salvador Fernandez with Victory Outreach, spoke on behalf of all the hard working people living in their mobile homes with kids and pets who are trying to make it work, the constant sweeps and needing to move causes mental health concerns.
6. Ha Trieu (*submitted a written copy of his statement*) addressed his concerns regarding his treatment by a Councilmembers staff member.
7. Lan Phuong Ngo (*Vietnamese translation assisted by Wordly & submitted a written copy of her statement*) addressed her concerns regarding an incident she stated occurred within the Council Chambers pertaining to a Councilmembers staff member.
8. A speaker spoke on behalf of an unhoused resident (*neither names were provided at the podium*), who stated there is currently two safe parking sites in San José, one has 86 spaces and the other has 42 spaces, but the City has over a thousand people living in vehicles citywide; they also addressed the City's "Oversized and Lived-In Vehicle Enforcement Pilot", and how temporary tow away zones are unstable.
9. Van Le (*submitted a written copy of her statement*) addressed the incident that happened to Ha Trieu regarding his treatment by a Councilmembers staff member.

10. A speaker (*name not provided at the podium*) addressed a previous occurrence and legal matter regarding former Mayor Liccardo and spoke to the Innocence Project.
11. Larry Moody, the Government Affairs Community Liaison for “Job Training”, stated that residents need strategies regarding workforce opportunities and pathways towards economic development, and he thanked Councilmember Ortiz for his help over the last couple years.
12. Long Dang (*Vietnamese translation assisted by Wordly & submitted a written copy of his statement*) spoke in support of Ha Trieu, regarding his treatment by a Councilmembers staff member.
13. Connie Nguyen (*submitted a written copy of his statement*) spoke in support of Ha Trieu, regarding his treatment by a Councilmembers staff member.
14. Gustavo Flores (*Spanish translation assisted by Wordly*) stated he lost his apartment during the pandemic, his family having to move every 15 days is hard on them, he requested assistance regarding stable safe parking spaces.
