**SUBJECT: RETROACTIVE APPROVAL OF DECK THE DOORS COMMUNITY  
EVENT SPONSORED BY COUNCIL DISTRICT 8 AS A CITY COUNCIL  
SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT  
DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT**

## **RECOMMENDATION**

1. Retroactively approve Deck the Doors scheduled from November 24, 2021 through the month of December 2021 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.
3. Place the item on the Tuesday, December 14, 2021 Council Agenda for action.

## **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Deck the Doors began on November 24, 2021 and will go through the month of December 2021 as a virtual event and sponsored by Councilmember Arenas. This special event is an online event aimed to bring the holiday spirit to residents and beautify District 8 neighborhoods. Residents will be provided holiday decoration kits from Council District 8 to decorate their homes for the holidays. Residents can submit photos online of how they utilized the kits and decorated their homes, to be spotlighted virtually by Council District 8 and entered into a drawing. The event is free and open to the public and follows all appropriate local public health rules, including requiring masks and social distancing.

## **ANALYSIS**

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Arenas will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 8, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.

The Office of the City Clerk will post the item on the City's Website for the December 8, 2021 Rules Committee Agenda and the December 14, 2021 City Council Agenda.
