## RECOMMENDATION

### **ANALYSIS**

The Mayor and the City Manager are responsible for developing the City Council Meeting Schedule. To facilitate more efficient planning of longer-range agenda content, the Administration recommends the continuance of the established practice of approval of a meeting schedule for the entire fiscal year and the cancellation of City Council meetings when there is a holiday that falls on a Monday or the meeting is within a holiday period. The proposed schedule (Attachment A) contains the cancellation of 12 meetings: August 6, September 3, October 15, November 12, November 26, December 24, December 31, January 7, January 21, February 18, April 1, and May 27.

Additionally, at the request of the Rules and Open Government Committee, the Administration has developed a tentative schedule of Study Session dates for August 2024 – June 2025 (Attachment B) to facilitate calendaring for Mayor and Councilmembers. As topics are set for the dates in the attachment, staff will bring these forward to the Rules and Open Government Committee for approval.
