RECOMMENDATION

1. Approve the Holocaust Remembrance Day scheduled on January 29, 2019 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses or community groups to support the event.
3. Place the item on the February 5, 2019 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Holocaust Remembrance Day will be held on January 29, 2019 at San Jose City Hall, 200 East Santa Clara St, San Jose, CA 95113 and sponsored by Councilmember Jimenez. This special event will commemorate International Holocaust Remembrance Day, local Holocaust survivor Marie Donner and Councilmember Sergio Jimenez will join Mayor Sam Liccardo in proclaiming a week of remembrance in San Jose during the Ceremonial Items portion of the regular meeting of the San Jose City Council. That same evening a small gathering in the plaza will be followed by lighting the City Hall Rotunda in purple. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Jimenez will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 2, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
