

RESOLUTION NO.

**A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE (1) APPROVING THE SAN JOSE MUNICIPAL WATER SYSTEM'S 2025 WATER SHORTAGE CONTINGENCY PLAN ("WSCP"); (2) APPROVING THE SAN JOSE MUNICIPAL WATER SYSTEM'S 2025 URBAN WATER MANAGEMENT PLAN ("UWMP"); AND (3) DIRECTING STAFF TO FILE THE PLANS WITH THE CALIFORNIA DEPARTMENT OF WATER RESOURCES ("DWR")**

**WHEREAS**, the Urban Water Management Planning Act ("Act"), enacted in 1983, requires all California urban water retailers supplying more than 3,000 acre feet (AF) (1 AF = 325,000 gallons) per year or providing water to more than 3,000 customers to develop an Urban Water Management Plan ("UWMP") and to update the UWMP every five years; and

**WHEREAS**, the City of San José ("City") filed its initial UWMP for the San José Municipal Water System ("SJMWS") with the California Department of Water Resources in 1985 and most recently updated the UWMP in 2021; and

**WHEREAS**, the Act requires the City to file a 2025 updated UWMP for the SJMWS with the California Department of Water Resources ("DWR") by July 1, 2026; and

**WHEREAS**, the SJMWS Water Shortage Contingency Plan ("WSCP"), a detailed plan for how a water provider intends to respond to and address a water supply shortage and last adopted as part of the 2020 UWMP, must now be separated from the UWMP, according to legislation and revised WSCP requirements, and adopted first; and

**WHEREAS**, the City timely provided a draft UWMP and WSCP for public review and comment; and

**WHEREAS**, on June 2, 2026, the City Council held a properly noticed public hearing to consider the recommended 2025 updated WSCP and UWMP for the SJMWS and receive community input on the proposed 2025 update; and

**WHEREAS**, the approval and adoption of the 2025 updated WSCP and UWMP will allow SJMWS staff to submit the 2025 updated plans to the DWR to fulfill the requirements of the 1983 California Urban Water Management Act, and enable the City to be eligible for water management grants or loans administered by the DWR, the State Water Resources Control Board, and/or the Delta Stewardship Council; and

**WHEREAS**, Water Code Section 10652 exempts the preparation of the WSCP and the UWMP from the California Environmental Quality Act (“CEQA”); and

**WHEREAS**, before taking action on this item, City Council considers and agrees with such exemption;

**NOW, THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

- (1) The San José Municipal Water System’s 2025 Water Shortage Contingency Plan (“WSCP”) is hereby approved.
- (2) The San José Municipal Water System’s 2025 Urban Water Management Plan Update (“UWMP”) is hereby approved.
- (3) Staff is hereby directed to finalize the WSCP and UWMP with final documents, including this adopted Resolution, and file the plans with the California Department of Water Resources.
