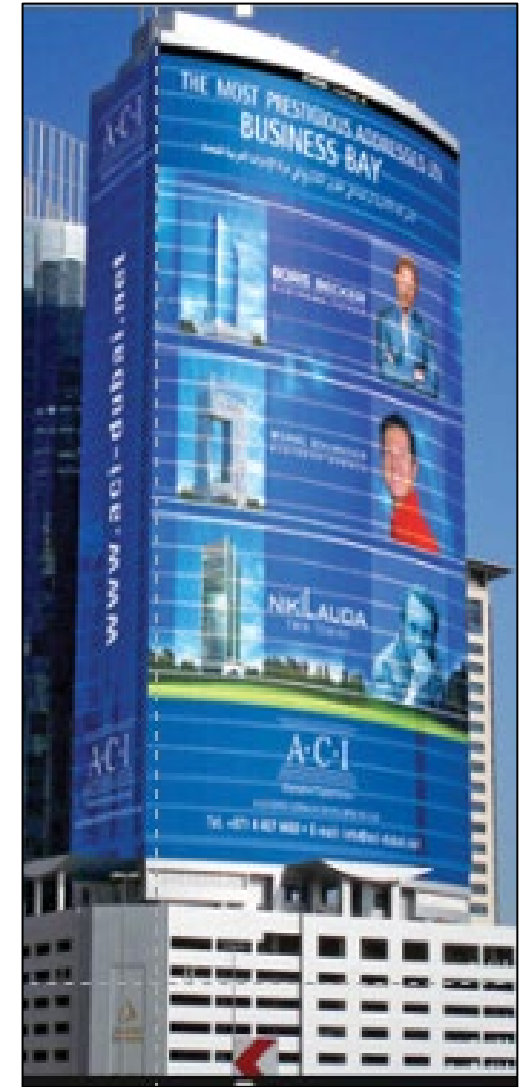
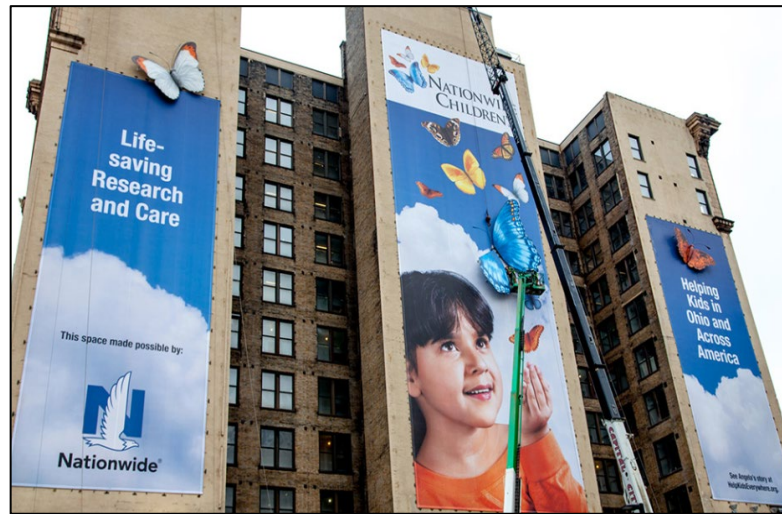

# Supergraphic Signs



Supergraphic sign means a sign made of flexible material that is attached flush to a building



# Supergraphic Sign Code History



**2017:** Allow and regulate supergraphic signs

**2020:** Modify permit provisions to streamline

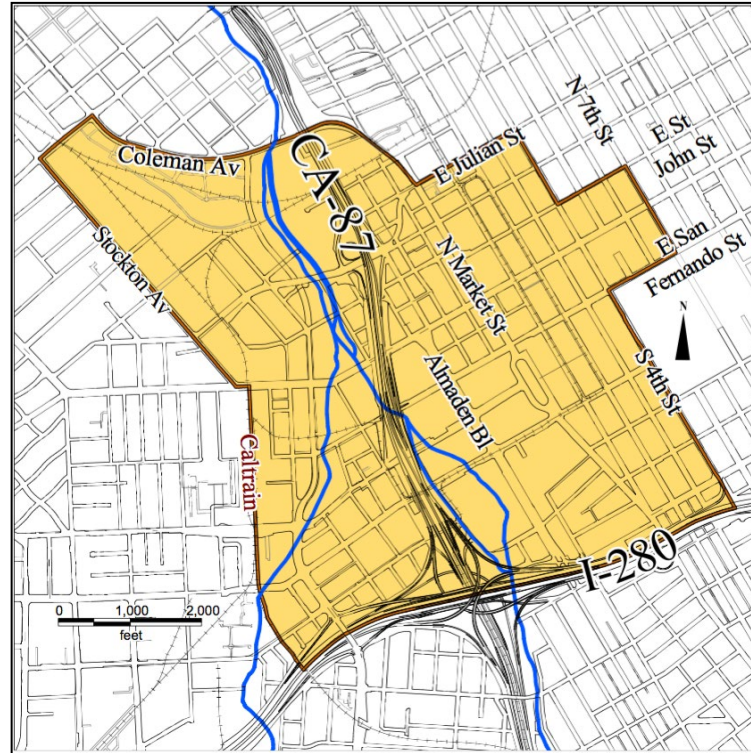
**2023:** Sign code provisions for supergraphic signs sunsets, supergraphics no longer allowed



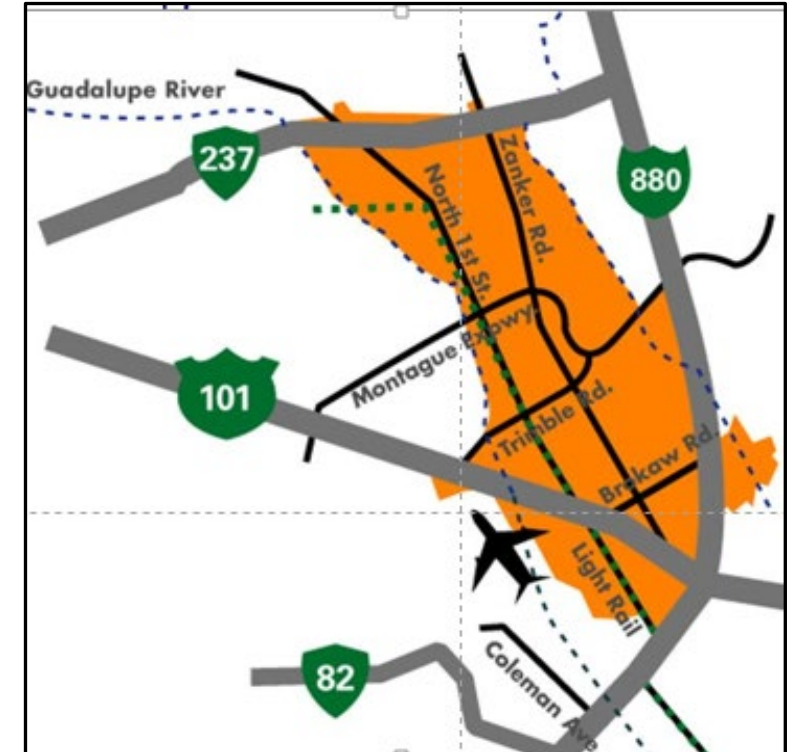


# Supergraphic Signs

- Signs limited to Downtown and North San José Signage Area
- Large Downtown Conventions or Large Downtown Special Events
  - 700 hotel room nights booked or projected attendance of 10,000+
- Allowed on Non-Residential Buildings
- Limited to on-site commercial/non-commercial signage

# Supergraphic Sign Code Amendment

- Proposed Changes specific to **Large Downtown Conventions** or **Large Downtown Special Events**

	Existing Regulations	PROPOSED Regulations
Limitation	Sunset Clause January 2023	Eliminate Sunset Clause
Building Height	Minimum 125 feet	No minimum building height but sign installed at a minimum height of <b>40 feet</b> from grade
Duration	Maximum 7 days before and 7 days after a large convention or special event and a total of not more than 30 days in a calendar year	Maximum 75 days before and 75 days after a large convention or special event and a total of not more than <b>180</b> days in a calendar year
Roof Sign	Roof Sign not allowed	<b>One</b> flat mounted Roof Sign allowed
Sign Allowance	One sign allowed for each building: The sign can wrap around on two facades of the building.	Total of <b>two</b> signs allowed for each building: Each sign can wrap around on two facades of the building.

# Analysis of Monetizing Supergraphic Signs

---

## Private Property

- Constitutional and other legal issues prohibit the City from monetizing any type of signage on private property

## City-owned Property

- City Council Policy 1-17 on Donation, Sponsorship, and Fundraising encourages and supports City departments and City-related foundations/entities to create opportunities for partnerships and enhancing revenue for department priorities
- Example: Parks, Recreation, and Neighborhood Services – Viva CalleSJ

# Analysis of Monetizing Supergraphic Signs

---

## How a Sponsorship Program for Supergraphics Could Work

- Administered by the City Manager's Office of Economic Development and Cultural Affairs
- Develop an agreement with partner organization such as San José Sports Authority or Team San José
- Develop program goals, timeframe, target audience, outreach strategy, reporting, and other administrative procedures
