WHEREAS, Section 100060 of California's Public Utilities Code further requires that the five (5) City representatives and one (1) alternate shall be City Council Members or the Mayor of the City, appointed by the City Council; and

WHEREAS, pursuant to Section 2-26 of Article III of the Santa Clara Valley Transportation Authority Administrative Code, the officers of the Board shall be the Chairperson and Vice Chairperson who shall be elected annually by the Board from its voting membership; and

WHEREAS, on November 7, 2024, the Board elected San José Mayor Matt Mahan to serve as Vice Chairperson of the Board for the remainder of 2024 and for calendar year 2025; and

WHEREAS, CITY and VTA mutually agree that providing dedicated staff assistance to Mayor Matt Mahan during his term as Vice Chairperson of the Board will promote maximum cooperation and efficiency for the benefit of the public; and
