Marketing and Promotion: Targeted marketing campaigns will attract new businesses and customers to the Corridor.


By supporting the BID, we are investing in the long-term success of our city. The benefits will extend far beyond the Monterey Corridor, positively impacting the entire San Jose community.


Mr Mayor and City Council members :
