

RESOLUTION NO. _____

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE RECITING THAT A RUN-OFF SPECIAL MUNICIPAL ELECTION WAS HELD IN THE CITY OF SAN JOSE ON TUESDAY JUNE 24, 2025; STATING THE OFFICE TO BE FILLED AT THE ELECTION; FINDING AND DECLARING THAT THE REGISTRAR OF VOTERS OF THE COUNTY OF SANTA CLARA HAS CANVASSED THE RETURNS OF THE ELECTION AND CONFIRMING THE RESULTS OF THE CANVASS; STATING THE WHOLE NUMBER OF VOTES GIVEN AT EACH PRECINCT TO EACH PERSON; AND FINDING AND DECLARING WHO RECEIVED THE HIGHEST NUMBER OF VOTES OF THE VOTES CAST

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1. The Council of the City of San José hereby finds, determines, declares and recites that, in accordance with Article IV and Article XVI of the San José City Charter, a Run-off Special Municipal Election was held in the City of San José on Tuesday, June 24, 2025, for the purpose of electing one person from Council District 3 to the Council for the remainder of the unexpired term of the Council District 3 vacancy, concluding on Dec 31, 2026.

SECTION 2. The Registrar of Voters of Santa Clara County has duly canvassed the votes cast in the City of San José at the Run-off Special Municipal Election on June 24, 2025, by the electors of the City for the office set forth, and has prepared a statement of all votes cast, and has certified the results of the votes cast at said election for each office, which said certification is now on file in the office of the City Clerk of the City of San José.

SECTION 3. The Council of the City of San José hereby finds, determines, and declares that said canvass is confirmed, and that the following are the results of said canvass and of said elections:

- (a) That the total number of ballots cast in the City of San José in said election is set forth in the Certificates of Election Results, attached hereto as Exhibit A and incorporated herein by this reference;
- (b) That the candidate who is declared elected to office, having received a majority of all votes cast for such office, is:
