# **RECOMMENDATION**

Adopt a resolution authorizing the City Manager or designee to negotiate and execute a contract with Fehr & Peers for planning & design consulting services to develop the Downtown Transportation Plan in an amount not to exceed \$675,000.

# **OUTCOME**

A transportation plan that provides clear, well-vetted direction to improve access, mobility, circulation, navigability, streetscapes, and public life in Downtown. A key deliverable is providing for a cohesive long-term transportation network with enough capacity to meet future demand.

#### **BACKGROUND**

On September 7, 2017, the City of San José was awarded \$813,000 of One Bay Area Grant Cycle 2 funds by the Valley Transportation Authority through the Metropolitan Transportation Commission for transportation planning in Downtown San José. The project area for this effort is the Downtown San José Priority Development Area. On March 13, 2018, the City Council authorized the City Manager or designee to accept grant funds and negotiate and execute all documents necessary to fund and complete this project. In both City and Metropolitan Transportation Commission budget documents, this effort is referred to as the *Downtown San José Mobility, Streetscape, and Public Life Plan*.

#### **ANALYSIS**

In 2018, the Department of Transportation developed a Request for Proposal with input from the Valley Transportation Authority, San José Downtown Association, SPUR, Knight Foundation, TransForm, and other City groups, including Council District 3, Office of Economic

Development, Planning, Building and Code Enforcement, and Parks, Recreation, and Neighborhood Services.

In September 2018, the Department of Transportation released a Request for Proposal for planning and design consulting services to develop the Downtown Transportation Plan. Proposals were received from the following teams:

- 1) Fehr & Peers, Winter Consulting, Gehl, EPS, HMH, Bonnie Nelson, Jay Primus
- 2) Sam Schwartz, CHS, CityFi, Crossroad Lab, Gehl, InterEthnica, MIG
- 3) Nelson\Nygaard, AIM Consulting, Gehl, Kimley-Horn, Mobycon, Perkins+Will
- 4) IBI, Gehl, Public Space Authority, VRPA Technologies, Greensfelder Commercial Real Estate

The proposals and teams were evaluated based upon the following weighted criteria:

- Project Understanding & Work Plan: Technical 30%
- Community Engagement 25%
- Project Staffing: 20%
- Firm & Project Team Qualifications: 20%
- Environmental Stewardship: 5%

The Fehr & Peers proposal received the highest overall score, 91 out of 100 points. The team has extensive and excellent local knowledge and experience, relevant big city downtown transportation planning experience, and many accomplished members who are ready to mobilize immediately. The proposal also includes international experts to challenge local practices and outstanding technical and community engagement work plans. The team includes technical transportation professionals who are fluent in Spanish and Vietnamese.

The scope of work will include project management, community engagement, and developing a vision and strategies to achieve the vision. Key deliverables will include decision-making frameworks, prioritized lists of projects and programs, designs and estimates for up to 30 top priority projects, and a phasing, implementation and monitoring plan. The total contract will not exceed \$675,000, with the work occurring over an 18 month term.

## **EVALUATION AND FOLLOW-UP**

Progress on the development of the Downtown Transportation Plan will be reported to the Transportation and Environment Committee.

## **PUBLIC OUTREACH**

To solicit bids, this Request for Proposal was listed on BidSync. Many community members and groups supported the Downtown Transportation Plan grant application, including California Walks, Silicon Valley Bicycle Coalition, County of Santa Clara Public Health Department, Greenbelt Alliance, San José Downtown Association, and the Council District 3 office. The development of the Downtown Transportation Plan will also include a significant level of community outreach. This memorandum will be posted to the City's website for the April 16, 2019 Council agenda.

# **COORDINATION**

This memorandum has been coordinated with the City Attorney's Office and the City Manager's Budget Office.

## **COST SUMMARY/IMPLICATIONS**
