Homelessness Funding

Homeless Emergency Aid Funding (HEAP)

- Secured \$11.3 million to City of San Jose in FY '18-19
 - 640 housing opportunities with temporary or emergency shelter beds
 - Prevent 730 individuals or households from entering homelessness
 - Expand services for 2,000 individuals

- Priorities for HEAP 2.0
 - Navigation Center
 - Enhanced Encampment Outreach
 - Homelessness Prevention
 - Hotel/Motel Acquisition



Emergency Preparedness

- AB 291 (Chu): Local Emergency Preparedness and Hazard Mitigation Fund
 - \$500 million on-going funding to local governments
 - Staffing, mitigation, facilities and equipment
- \$12 million City of San Jose budget request
 - Emergency Operations Center equipment, technology, furnishings
 - Fire Training Center
 - Soft-story inventory, education, and grant program
 - Coyote Creek Maintenance
 - Staff training and recruitment

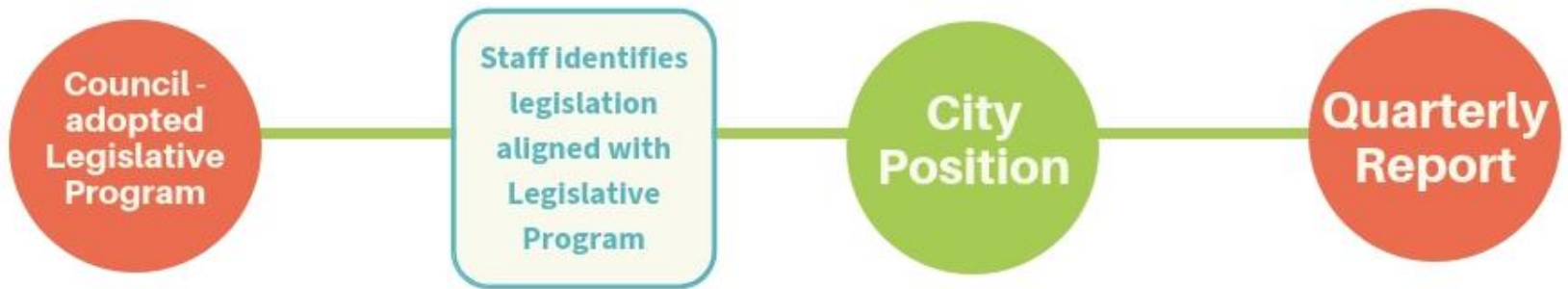


Proposed Streamlined Internal Legislative Framework
