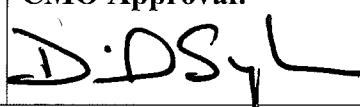

SUBJECT: FILE NO. ST18-004 STREET RENAMING TO CHANGE A PRIVATE STREET FROM ALL PROGRAMMABLE DRIVE TO LOGIC DRIVE

RECOMMENDATION:

Adopt a resolution to rename All Programmable Drive, a private street extending approximately 1,000 feet west of its intersection with Union Avenue, to Logic Drive.

BASIS FOR RECOMMENDATION:

On May 22, 2018, Lawrence Wolfson, on behalf of the property owner Xilinx, Inc., submitted an application to rename the private street of the Xilinx corporate campus from All Programmable Drive to Logic Drive. The attached map identifies the location of the private street proposed to be renamed.

Although Xilinx is the owner of all parcels currently accessed from Logic Drive, Xilinx is no longer the single occupant. The existing street carries no through traffic and provides no access to or from adjacent properties. The renaming has been approved by Santa Clara County Communications, the United States Post Office, the City of San Jose Fire and Police Departments, and the City of San Jose Building Addressing Section.

City Council Policy 6-5 entitled "Street Naming and Renaming" establishes the process and criteria for public and private streets naming and renaming. Pursuant to the Council Policy, the Planning Director determined the proposed street renaming is a renaming of a "minor" private street subject to a more streamlined process and criteria because no more than twenty (20) occupied parcels are affected by the proposed renaming. Planning staff fully implemented the Council Policy on Public Outreach by requiring the applicant to post an on-site sign notifying the public of the proposal and identifying how to obtain additional information or submit comments. No public comments were received for this project. No community meeting was held, as it was deemed unnecessary by the Director of Planning, Building and Code Enforcement since All Programmable Drive is not a major thoroughfare. The property owners and occupants within a 300-foot radius were sent public hearing notices for the City Council hearing pursuant the aforementioned policy.

Planning staff recommends the City Council adopts the resolution approving the renaming of the private street from All Programmable Drive to Logic Drive as the renaming meets the criteria of City Council Policy 6-5 and does not affect any other property owners.

Xilinx, Inc. is responsible for all costs associated with the new street signs.
