### 3. STRATEGIC SUPPORT

**Purpose**: The purpose of the Study Session is to provide information related to the City's Fees and Charges Program and review key elements of the 2024-2025 Preliminary General Fund Forecast. The first portion of the Study Session will provide an overview of the Fees and Charges Program, including a review of programs that offer lower or waived fees based on income eligibility, and a review of the Dog and Cat License fee program overseen by Animal Care and Services and the potential to exempt this fee for those meeting income eligibility criteria. The second portion of the Study Session will provide a historical perspective of the General Fund Budget and an overview of the 2024-2025 Preliminary General Fund Forecast to help inform the upcoming budget development process.
