### RECOMMENDATION

#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Dumpster Day will be held on March 10, 2018 at the Cambrian Park Plaza and sponsored by Councilmember Donald Rocha. With the rise of illegal dumping and increase in trash throughout the community, this special event provides a space for local residents to dispose of household items in a safe and proper way. Through this process, this event will help educate residents on the importance of appropriate disposal and where to find assistance for proper disposal in the future.

#### **ANALYSIS**
