FOR Α COMPENSATION **EXCEED** NOT-TO AMOUNT \$4,450,000; (B) APPROVE A CONTINGENCY OF \$445,000 FOR UNANTICIPATED DEMAND FOR REMOVAL AND REPLACEMENT OF CONCRETE, SUBJECT TO THE APPROPRIATION OF FUND; (C) EXERCISE UP TO FOUR (4) ADDITIONAL ONE-YEAR OPTIONS TO EXTEND THE INITIAL TERM OF THE PURCHASE ORDERS WITH THE LAST OPTION YEAR ENDING ON OR ABOUT AUGUST 31, 2026, SUBJECT TO THE ANNUAL APPROPRIATION OF FUNDS

WHEREAS, the City of San José ("City") oversees the maintenance of concrete sidewalks, curbs, gutters, driveway approaches, park strips, concrete pads and other concrete surfaces on City's streetscapes within the public right of way at over two hundred (200) locations; and

WHEREAS, the City conducted a Request for Bid ("RFB") for concrete removal and replacement services; and

WHEREAS, staff recommends award to Duran Construction Group, Inc., Golden Bay Construction, and JJR Construction, Inc. as the responsive and responsible bidders in the RFB pursuant to the bidding procedures of San José Municipal Code Section 4.12.310.B.2; and

maintained properly, kept in optimal condition, and are safe to use;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF

SAN JOSE THAT:

The City Manager is hereby authorized to:

A. Execute purchase orders with Duran Construction Group, Inc. (San Jose, CA),

Golden Bay Construction (Hayward, CA), and JJR Construction, Inc. (San Mateo,

CA), for the purchase of concrete removal and replacement services for an initial

twelve-month period starting on or about September 1, 2021 and ending on or

about August 31, 2022, for a cumulative compensation not-to exceed amount of

\$4,450,000; and

B. Approve a contingency of \$445,000 for unanticipated demand for removal and

replacement of concrete, subject to the appropriation of funds; and

C. Exercise up to four (4) additional one-year options to extend the initial term of the

purchase orders with the last option year ending on or about August 31, 2026,

subject to the annual appropriation of funds.
