RECOMMENDATION

- (a) Reject all bids received on March 4, 2021 for the 2021 Local Streets Remove and Replace Project.
- (b) Approve award of a construction contract for the 2021 Local Streets Remove & Replace Project (Re-bid), to the lowest bidder, Teichert Construction, in the amount of \$2,823,304.
- (c) Approve an approximate 10% contingency in the amount of \$282,300.

OUTCOME

Approval of this contract will provide required asphalt concrete pavement repairs along 57 miles of streets on the Local and Residential Streets Network to be surface sealed in the 2021 construction season. Approval of an approximate 10% contingency will provide funding for any unanticipated work necessary for the proper construction and completion of the project.

BACKGROUND

The Department of Transportation (DOT) will maintain approximately 140 miles of streets on the Local and Neighborhood Street Network in the 2021 construction season. Of these 140 miles, DOT is planning to seal (Micro-Surface) approximately 57 miles of streets in fair to good condition as a preventive maintenance measure to extend their useful life and reduce long-term maintenance costs to the City.

Micro-Surfacing is the application of a thin layer of asphalt emulsion blended with rock approximately 3/8 of an inch in depth to the pavement. This is typically performed in two separate phases: preparation and a final surface sealing application. The preparation phase includes minor concrete repairs as well as ADA curb ramp installations and retrofits prior to the commencement of the pavement treatment. Streets to be surface sealed will also require the

removal and replacement of any structurally failed areas of pavement along any of the 57 miles of streets. The final surface treatment is applied to the entire street after preparation phases are complete.

To decrease the overall timeframe for completing the preparation work, reduce cost, and provide more bidding opportunities for small and local contractors, DOT divided the Concrete and ADA ramps preparation work into two major and 13 minor public works projects across the City. As part of the preparation phase, the removal and replacement of structurally failed asphalt pavement areas was scoped in a separate project, which is also the subject of this memorandum. A description of the 2021 pavement maintenance projects was provided in an information memorandum to the City Council in February 2021.

The City's Local and Neighborhood Street Network is organized into 135 geographically contiguous "Pavement Maintenance Zones" (PMZs). The PMZs were established several decades ago to support efficient planning and delivery of paving projects, maximize the amount of paving work completed at one time within a neighborhood area, and provide geographic equity of pavement maintenance across the City. Information provided by the City's pavement management database is used to identify candidate PMZs for preventive maintenance and sealing. The final list of PMZs to receive treatments was established using the following criteria:

- Funding availability and funding use restrictions
- Total miles of streets in reconstruction and rehabilitation category
- Streets not affected by current or future street related projects
- Maintenance history and prescribed treatment schedules
- Relative location of street segments to create multiple, continuous segments, consistency within neighborhoods, and project efficiency
- Multi-year geographic spread across the City and street network
- Number of public traffic attraction facilities such as schools, hospitals, libraries, community centers, etc.
- Community and City Council office feedback regarding roadway conditions and priority street segments

This year, DOT added an additional criterion, equity. DOT staff cross-referenced the selected zones with census tracts designated by the Municipal Transportation Commission (MTC) as "Communities of Concern" (COC) to better track equity in service delivery. Results confirmed that 207 out of 325 miles (roughly 65%) of local and neighborhood streets designated in COC areas will be maintained by the end of the three-year plan (2023). DOT anticipates completing pavement maintenance for nearly 50% of the local street network in this same timeframe.

Since 2019, DOT has maintained a total of 96 COC miles and will be maintaining an additional 52 COC miles in 2021, which is roughly 37% of the 140 miles of Local and Neighborhood

streets selected for maintenance in 2021. This project in particular will maintain approximately 22 miles of streets in COC neighborhoods, which accounts for approximately 38% of the scope of work.

The Attachment to this memo contains the list of streets to be prepared for sealing. The list may change if unforeseen circumstances arise or new information regarding other street-related projects becomes available.

ANALYSIS

ORIGINAL BID: The construction contract for this project was originally advertised on February 17, 2021 and bids were opened on March 4, 2021. The apparent low bid in the amount of \$2,934,225.80 was 20.24% lower than the original Engineer's Estimate of \$3,678,889. However, there was an irregularity in the apparent lowest bid regarding a miscalculation of three bid item extensions. This resulted in a written protest by the second, and only other bidder, and a counter-protest by the first bidder shortly thereafter.

To uphold the integrity of the project and to maintain this year's pavement projects schedule, Public Works Procurement staff and DOT determined that it would be in the City's best interest to reject all bids pursuant to the authority granted by San Jose Municipal Code Section 27.10.530 and re-advertise the project for the next available opening.

RE-BID: The project was re-advertised on March 31, 2021 and opened on April 15, 2021 with the following results:

The low bid submitted by Teichert Construction. is \$2,823,304 and is 23.3% below the Engineer's Estimate. The Engineer's Estimate for this project is \$3,681,066.51. The estimate is

based on bids received from similar past projects and most current estimated construction prices. The bid is considered acceptable for the work involved in the project. Staff recommends that the construction contract be awarded to Teichert Construction.

San Jose Municipal Code Section 27.04.050 provides that the contingency for all public works contracts (except those involving the renovation of a building or buildings) cannot exceed 10% of the total contract amount. Staff recommends an approximate 10% contingency, which should be sufficient to account for unforeseen conditions that might arise in the excavation, removal and replacement of failed concrete areas.

Construction is scheduled to begin in July 2021 and will be completed by early September 2021.

Project Labor Agreement Applicability

A project labor agreement (PLA) is not applicable to this project as more than 50% of the scope of the work within the project is providing street maintenance for existing infrastructure.

Local and Small Business Outreach

This project does not have a preference for local and/or small businesses.

CONCLUSION

Based on the evaluation of bids, the low bid is considered acceptable and staff recommends awarding the construction contract for the 2021 Local Streets Remove & Replace Project (Re-bid) to Teichert Construction.

EVALUATION AND FOLLOW-UP

DOT provides an ongoing evaluation of the City's pavement conditions and provides periodic reports on this topic to the Transportation & Environment Committee, and the City Council. In addition to the project discussed in this memo and the 2021 Local Streets Resurfacing#2 project that is also agendized for Council action on the same date, two additional projects for the Local & Neighborhood Streets Network will be brought forward for Council action this Spring. Specifically, the additional contracts will provide sealing or resurfacing work on a combined total of 140 miles neighborhood streets.

To inform traveling motorists of upcoming construction activities and potential traffic delays, changeable message signs may be used on selected streets stating the scheduled date and time for work to occur on the street. This memorandum will be posted on the City's Council Agenda website for the June 8, 2021 Council meeting.

COORDINATION

This project has been coordinated with the Department of Public Works, and this memorandum has been coordinated with the Department of Planning, Building and Code Enforcement, the City Attorney's Office and the City Manager's Budget Office.

No commission recommendation or input is associated with this action.
