In addition, staff requests that the Anti-Displacement Tenant Preference and Neighborhood Tenant Preference for Affordable Housing Status Report and Soft Story Seismic Retrofit Policy Status Report be deferred from the October 23, 2023, to the November 27, 2023, CED Committee, meeting. The purpose of the deferral for the Anti-Displacement Tenant Preference and Neighborhood Tenant Preference for Affordable Housing Status Report is to align the work with the Citywide Residential Anti-Displacement Strategy Status Report scheduled for the same November 27, 2023, CED Committee meeting. Deferring the Soft Story Seismic Retrofit Policy Status Report allows staff additional time to conduct community engagement.

Lastly, staff requests to move the Local/Small Business Contracting Participation Annual Report and Berryessa Flea Market Status Reports from the November 27, 2023, CED Committee meeting to the October 23, 2023, CED Committee meeting. The purpose of the changes is to accommodate staff workload to meet reporting deadlines for priority projects and to provide better management of monthly agendas for the CED Committee.
