#### RECOMMENDATION

### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 3 Night at Christmas in the Park will be held on Wednesday, December 1, 2021 at Cesar Chavez Park and will be sponsored by Councilmember Raul Peralez. This special event will be a community filled evening at Christmas in the Park that will include live entertainment and free hot chocolate. The event is free and open to the public.

## **ANALYSIS**

In observance of existing fundraising disclosure requirements, Councilmember Raul Peralez will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 3, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
