### **Executive Summary**

On behalf of the Board of Directors and staff of the San Jose Arena Authority, we are pleased to submit the Executive Summary of activities undertaken by the Arena Authority during Fiscal Year 2023-24. Included in this Executive Summary are areas of responsibilities administered by the Arena Authority for its oversight of the management and operations of SAP Center at San Jose, Sharks Ice at San Jose, and Excite Ballpark Home of the San Jose Giants. Additionally, there is information on the Authority's community outreach programs as well as the organization's leadership with the South Campus Operations Team (SCOT). This last year, the Arena Authority participated in the reactivation of the City's Emergency Services Council (ESC).

### **Background**

Created by a resolution of the San Jose City Council and consisting of a 17-member, Mayorappointed Board of Directors, the Arena Authority was originally designated with the oversight of operations of SAP Center at San Jose (originally San Jose Arena). Since then, the organization's administrative oversight has been broadly expanded to include Sharks Ice at San Jose and Excite Ballpark Home of the San Jose Giants. In 2010, the Arena Authority created the South Campus Operations Team. Chaired by the Authority, the team meets monthly to address area operations, provide project updates, and discuss other management issues in the area in and adjacent to the south campus of San Jose State University. In 2018, the Arena Authority created the Emergency Resources Network (ERN). The mission of the ERN is to enhance the collaborative relationships between facility operators and first responders in the preparation and response to natural disasters and man-made threats. Along with that, the Authority became a member of the City's Emergency Services Council, a public safety body assembled to address operations of natural and human-induced emergencies. The Council convened in April to review the new City-wide emergency response plan.

### Facility Operational Oversight


### **SAP Center at San Jose**

In Fiscal Year 2023-24, SAP Center at San Jose continued to provide a full schedule of events, featuring Sharks hockey games, concerts, comedy shows, and family entertainment. In August, the Center hosted the U.S. Gymnastics Championships. And in October, the Sharks celebrated their 30<sup>th</sup> season at SAP Center at San Jose. In 21 seasons while playing at the Center, the Sharks advanced to the National Hockey League Playoffs, including one run of 10 consecutive years. They have been to five Western Conference Finals and one Stanley Cup Final. Also, over the 30 years in San Jose, SAP Center Management has presented world-class entertainment, featuring this era's greatest musical talent and covering a wide field of musical genres.

Regarding the annual capital improvements program, the City approved \$6,885,000 in capital funding for the arena in FY 2023-24. Major projects included upgrading the building's LED displays, upgrading the Rinkside Room and replacing food service equipment. In preparing the annual capital repair and replacement budget, the Arena Authority works closely with Sharks Sports & Entertainment, the City Manager's Budget Office, and the Department of Public Works to evaluate and refine the budget for eventual submittal to the City.

For operations at SAP Center at San Jose, the Arena Authority engages SAP Center Management, several City departments, and other entities to facilitate the management of the Center's day-to-day operations. As such, the Authority works collaboratively with the other agencies to administer to the arena's Transportation and Parking Management Plan (TPMP). Through the elements of this plan, critical vehicular traffic and pedestrian movement strategies, on-site and off-site parking operations, vicinity street management and closures, and neighborhood integrity concerns are addressed in a safe and well-thought-out fashion.

Regarding long-term operations at and adjacent to the Center, the Arena Authority is engaged in a host of generational transit, parking, and development projects. These projects include the design and function of the San Jose Diridon multimodal transit center, an extensive transit hub that will service several future modes of public transportation. One of those major transit projects is the Valley Transportation Authority's BART project, which will provide a subway and station adjacent to the arena. Preliminary work on the arena subway project has already begun. While Google is reassessing the Downtown West Mixed-Use Project, work continues to address parking needs in the area, including the development of the Milligan property just north of the arena. The new parking facility will include over 320 spaces and is scheduled to open during the first quarter of 2025. Additionally, SAP Center Management and the City are engaged in discussions on updating the arena to current operational standards. Although the arena is still considered by many as one of the most-treasured public assets, the building is 30-years old and in need of vital upgrades.

### **Sharks Ice at San Jose**

As in the past, Sharks Ice at San Jose/Tech CU Arena had another active year. In February, Tech CU Arena hosted the 2024 American Hockey League All-Star Classic. Over two days, thousands of guests enjoyed all-star activities at the arena. By building Tech CU Arena, Sharks Ice at San Jose is now the largest public ice facility in the United States.

Additionally, participation in both figure skating and youth and adult hockey camps and leagues has increased with public access to five rinks and Tech CU Arena. Clinics and public skating programs also offered an opportunity for many to enjoy the numerous amenities at the ice center. For Fiscal Year 2023-24 the City approved \$969,000 in capital improvements, which included upgrades to the elevators and the HVAC systems.


### **Excite Ballpark Home of the San Jose Giants**

Excite Ballpark Home of the San Jose Giants typically conducts over 140 events annually, including a large variety of baseball activities such as youth clinics, high school regular season games, Central Coast Section playoff and championship games, San Jose State University baseball games, and San Jose Giants regular and post-season games. Other events at the stadium include campouts, drive-in movies, concerts, and fireworks shows. Recent stadium improvements included code compliance features for concession and fan viewing areas.

### **Community Outreach Programs**

The Arena Authority serves a critical function as the City's community liaison in identifying and addressing day-to-day operational issues at SAP Center at San Jose. To address any extraordinary elements to Center and vicinity operations, the Arena Authority works directly with the City's Department of Transportation, the Office of Cultural Affairs, the San Jose Police Department, Sharks Sports & Entertainment, and local City Council offices to conduct outreach to residents and business owners. This is typically accomplished through civic engagement in regional project discussions, including the Authority's participation on the VTA's BART Downtown/Diridon Community Working Group.

Another key community outreach element is the Authority's Arena Ticket Distribution Program. During FY 2023-24 the Authority distributed all 3,410 tickets made available per the guidelines of City Council Policy 9-11. The Arena Authority has now distributed over 130,000 tickets to the San Jose community since the program was introduced in 1993. Additionally, the Arena Authority distributes tickets to Barracuda home games at Tech CU Arena through the City Council ticket distribution policy.

Another active community program is the Arena Authority's City and Community Events (CCE) program. During the last fiscal year, two organizations conducted events at SAP Center at San Jose. From this activity, \$70,000 of City and Community Events program funding was allocated to program applicants to offset event expenses. It is worth noting that the Authority has issued more than 2.2M in program funding credits to community-based organizations since the funding element was introduced in FY 2001-02. The two events included the 28<sup>TH</sup> annual San Jose Sports Hall of Fame induction ceremony and the San Jose Unified School District middle school graduations. For the Sports Hall of Fame, the Arena Authority maintains representation on the San Jose Sports Authority's Sports Hall of Fame Committee and participates in the selection of the annual inductees. The bronze plaques presented at the annual induction ceremony are eventually placed on permanent display along the public concourse at SAP Center at San Jose. To date, over 115 athletes and coaches have been inducted into the San Jose Sports Hall of Fame.

The South Campus Operations Team (SCOT) continued to see significant change in the area during the last fiscal year. In March, construction was completed by the City's Department of Public Works at the Emergency Operations Center/Fire Training Center. These facilities allow emergency responders the most up-to-date technologies to identify and respond to significant emergency events in San Jose. Its opening represents another South Campus cornerstone facility following the construction of Tech CU Arena, the expansion of SJSU's CEFCU Stadium and the construction of the SJSU 1,500-space capacity parking garage. SCOT was created to provide a forum for South Campus facility and park operators to share program and event information, address ongoing operational and parking issues, manage simultaneous events, and discuss capital projects. The team includes representatives from Kelley Park, Happy Hollow Park and Zoo, History Park, Sharks Ice at San Jose, Excite Ballpark Home of the San Jose Giants, San Jose State University Athletics, the Office of Cultural Affairs, the Department of Public Works, the San Jose Police Department, and the Arena Authority.

### Arena Authority Administrative Activity

The Arena Authority continues its administrative responsibilities with the development of the arena Transportation and Parking Management Plan (TPMP) in preparation of the submittal of the BART construction TPMP in the vicinity of the arena. Among the many roles involved in this significant project the Authority continues to serve as an important project liaison within the working groups involved in the project. Furthermore, the Arena Authority strongly supports the creation of a BART design and construction executive oversight group. In doing this, the major stakeholders would convene on a regular basis to find solutions to the critical issues that would impact the arena's ongoing functioning as the City's most prized public asset. The Arena Authority is also fully committed to continue to administer to the contents of the management agreements for the three City sports facilities and looks forward to working cooperatively to ensure that these City-owned assets remain active and accessible while offering a wide range of opportunities for public participation.

Our group, No Digital Billboards in San Jose, is a coalition of residents, neighborhood associations, and environmental groups opposed to new billboards.

We are writing to ask for the Arena Authority's position on the legality and appropriateness of the signs shown below at Arena Authority sites.


Our concern is that elements of these signs are not compliant with Municipal Code and not good for San Jose. We have been advised by the City of San Jose Planning Department that signage on City property DOES need to comply with Municipal Code.



Specifically the following signs are questioned:



These kiosks are at Sharks Ice on South 10th Street. They are showing off-premise advertising which including products and services not available at the site (i.e. national brands). That is generally prohibited by the Municipal Code. Furthermore they are using full motion video advertising. The Municipal Code Section 23.02.905(A) states: "No sign shall display animated messages, including flashing, blinking, fading, rolling, shading, dissolving, or any other effect that gives the appearance of movement.". They are also advertising destinations like Disneyland, an out of town destination. This undermines Team San Jose's marketing mission to attract people to San Jose.



The SAP Center sign is occasionally showing advertising for a national brand alcoholic beverage product. We question how this content (off-premise advertising) is compliant with the Municipal Code. We also question outdoor advertising of alcoholic beverages on San Jose civic assets and the image of our City this projects.

Our group is concerned that normalizing signs with the flagged characteristics, which today appears to be unique to Arena Authority sites, is pushing legal boundaries and moving the City down a path that residents strongly oppose. These signs also represent how difficult it is to control content for outdoor advertising. What should the public expect to see on signs in the future and what should the City and the Arena Authority be doing to set appropriate standards? If ads for alcohol are OK here, then where next? We urge the Board to take up this discussion.
