Dear Council,

HomeFirst's defense yesterday of their firing 5 black people was completely inadequate.

They had an internal investigation that determined they did no wrong. Of course they did! That is what everyone does. We need an outside agency, chosen by Council (and not HomeFirst), to conduct an investigation of the 5 firings and of their management processes in general.

While they offered to make employee files public and used the employee's not given permission to make their own personnel files public as a way to vindicate HomeFirst, this is invalid because HomeFirst has had ample time to make sure the files match their narrative.

An outside investigator will not only look at HomeFirst's files, but they will be able to verify with the employees whether or not the files presented by HomeFirst have integrity. They will also be able to visit prior years' files and see if they all pass muster.

Please require HomeFirst to have an outside investigation. It is the ONLY way we can be sure that these firings are not what they look like.

If such an investigation absolves HomeFirst, great! But you owe it to your constituents to take the effort to verify the integrity of HomeFirst, given the gravity of the current situation.

Also, their Media Blitz was interesting. As Lori Smith, their Marketing and Communications Director, said she would in her letter to HomeFirst management asking them to appear, the scripts that most of them read from sounded like she had indeed worked them over. They sounded like something written by a marketing person. When a few of them said "I'm here because I want to be here," I thought, "Well done, Lori."

I want Council to demand of HomeFirst:

- 1. An investigation by an outside agency, chosen by Council, into the firing of the 5 black workers.
- 2. You (Council) create an Oversight Committee that has enforcement powers over HomeFirst.
