Background

CA Senate Bill 969

- Effective January 1, 2025, allows cities to establish Entertainment Zones that allow the sale of “to go” containers of alcohol that can be consumed outdoors within a geographic public area – streets, sidewalks, plazas
- Goal is to help activate the public realm and streets with entertainment and community-driven events to support businesses, create a festive atmosphere, and spur economic development

CA Senate Bill 969 Requirements

- Cities must enact a local ordinance to define geographic boundaries and operating hours
- Cities must consult with law enforcement
- Cities must report to the Department of Alcoholic Beverage Control biennially



Proposed Process and Regulations

- Activation of an Entertainment Zone will be part of the City's Special Event Permit application
- Entertainment Zones can only operate during the permitted special event hours—between 8:00 a.m. and 11:59 p.m.
- Geographic area must be marked via signs, sidewalk decals or other methods approved in the Special Event Permit
- All ABC license conditions apply
- Alcoholic beverages must be served in approved non-glass, non-metal containers determined in the Special Event Permit
- Alcoholic beverages can be taken into an Entertainment Zone but not into an establishment where it was not purchased
- Patrons must dispose of containers in recycling, compost, or reusable container return receptables before leaving the Entertainment Zone

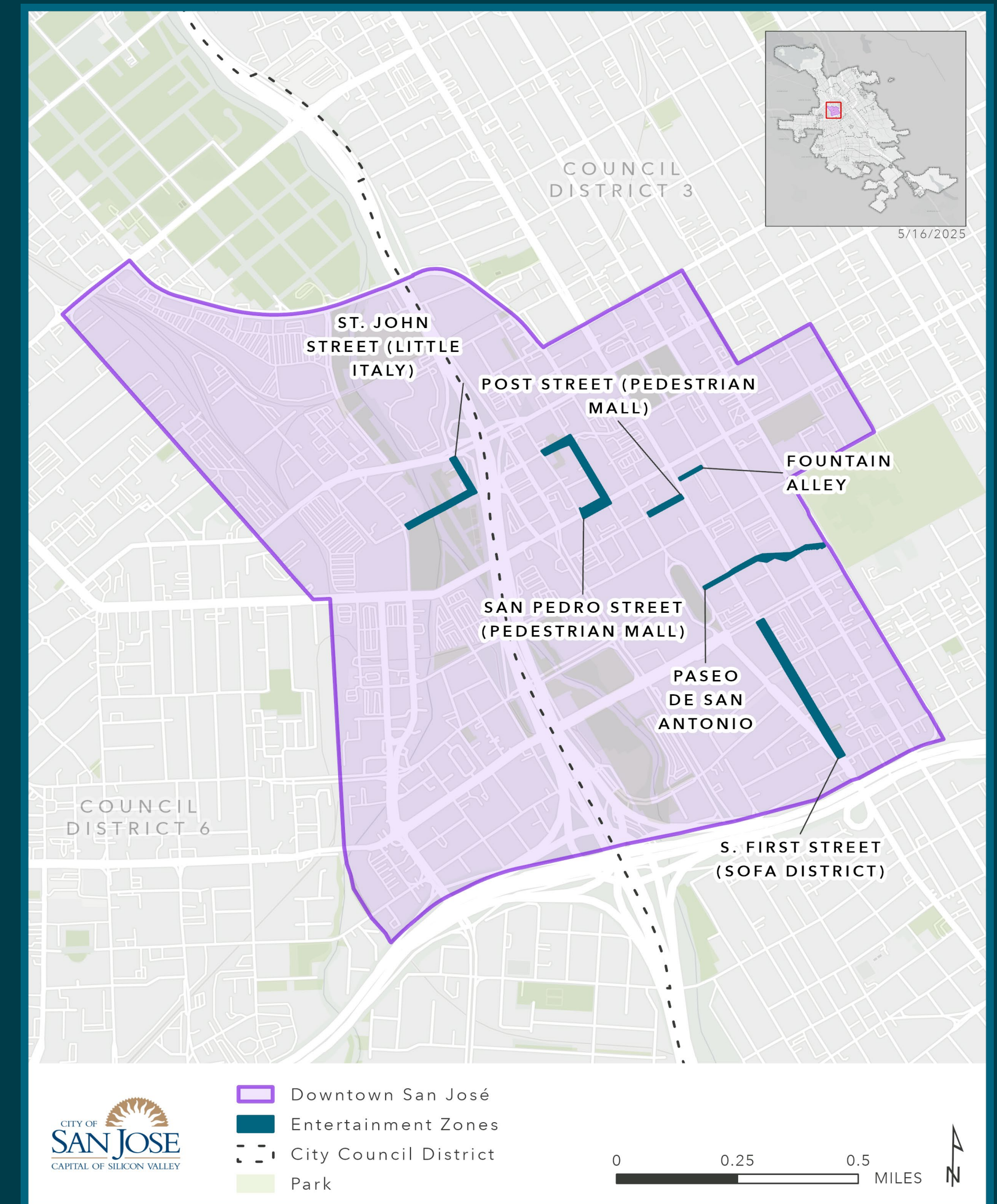


Where are the Proposed Entertainment Zones?

Six locations in Downtown active business districts with active pedestrian usage:

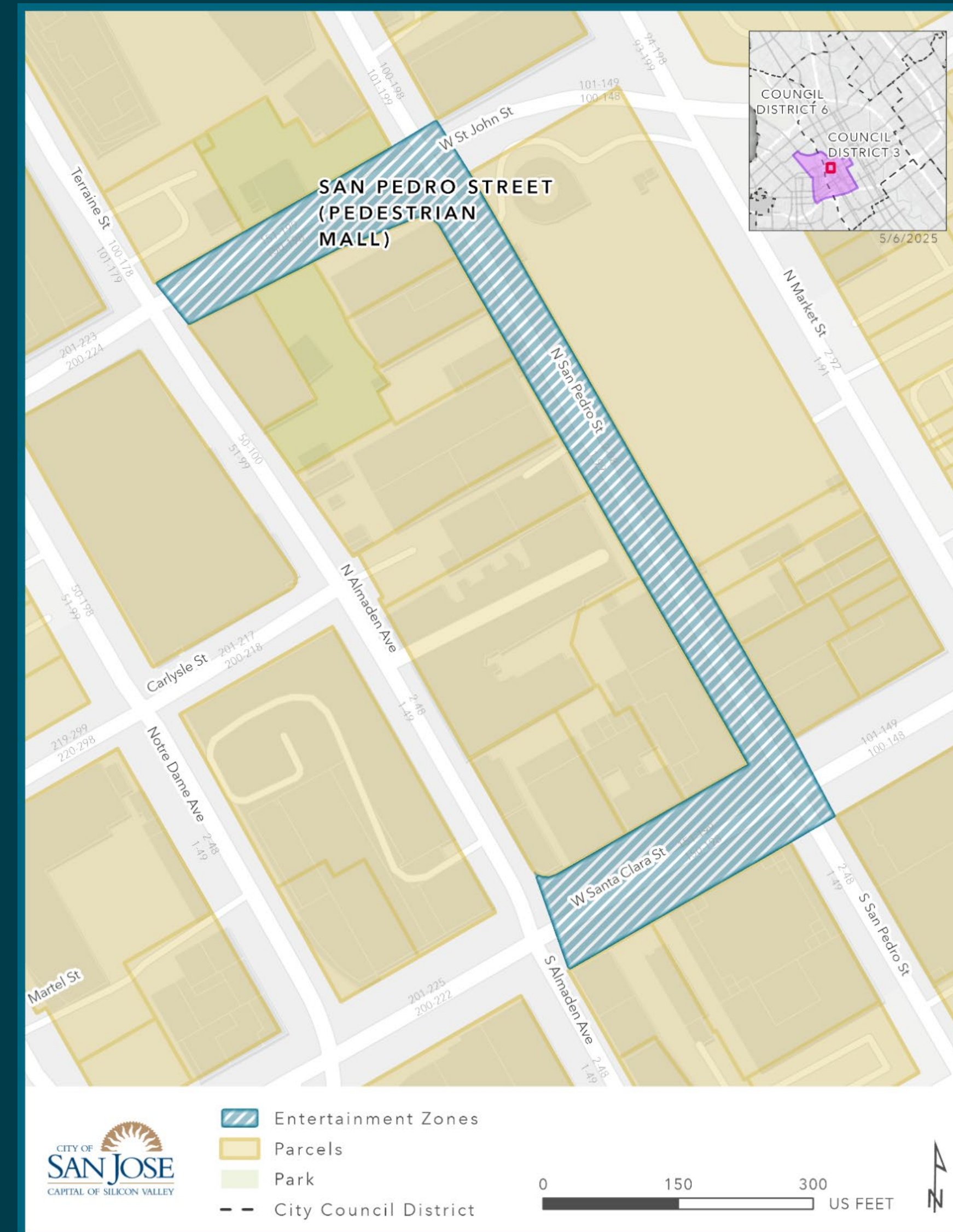
- San Pedro Street
- Post Street
- South First Street (SoFA District)
- St. John Street (Little Italy)
- Fountain Alley
- Paseo de San Antonio

Builds on San José's successful efforts to enliven public spaces through music, festivals, cultural programming and walkability for an entertainment economy.



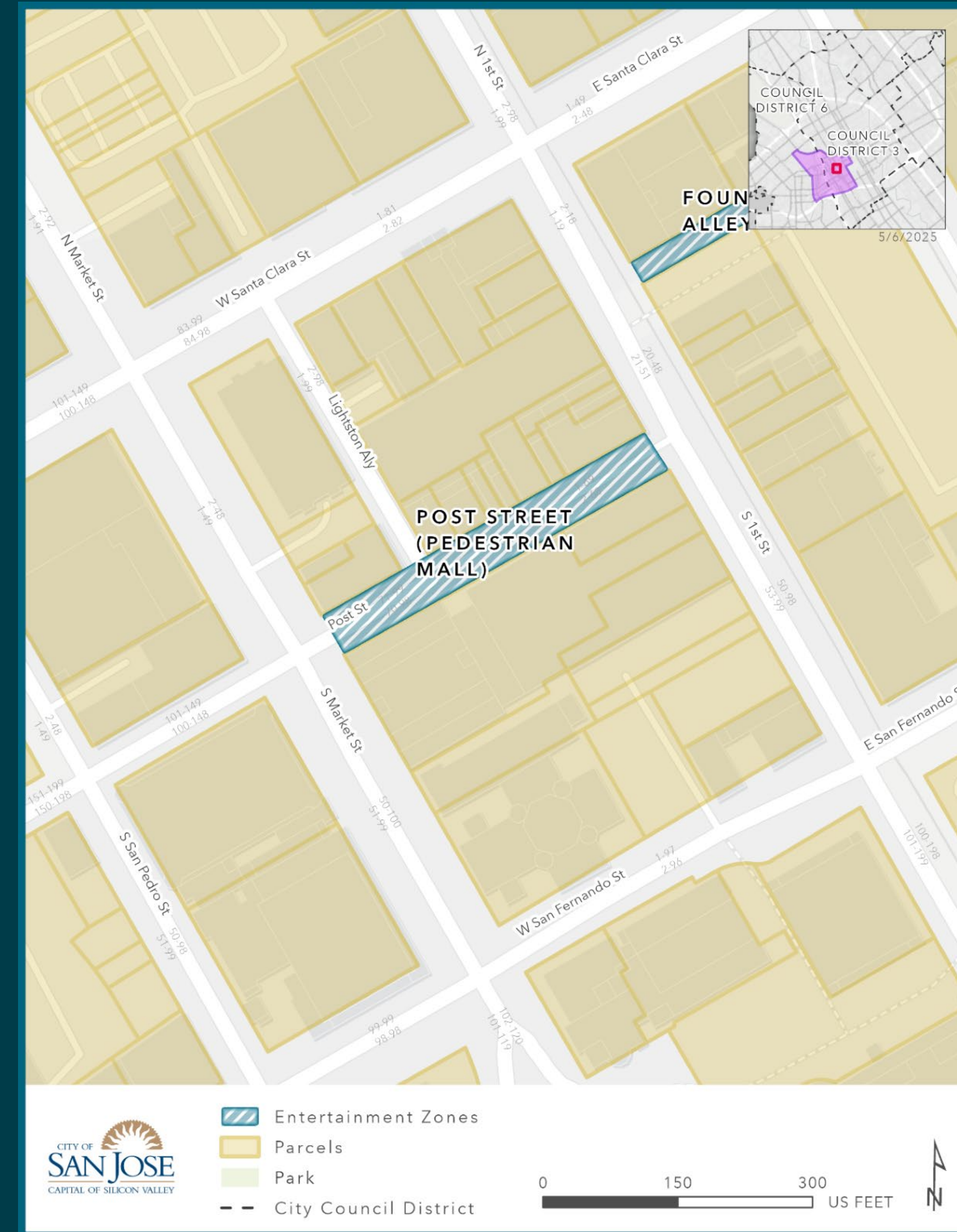
San Pedro Street

and Almaden



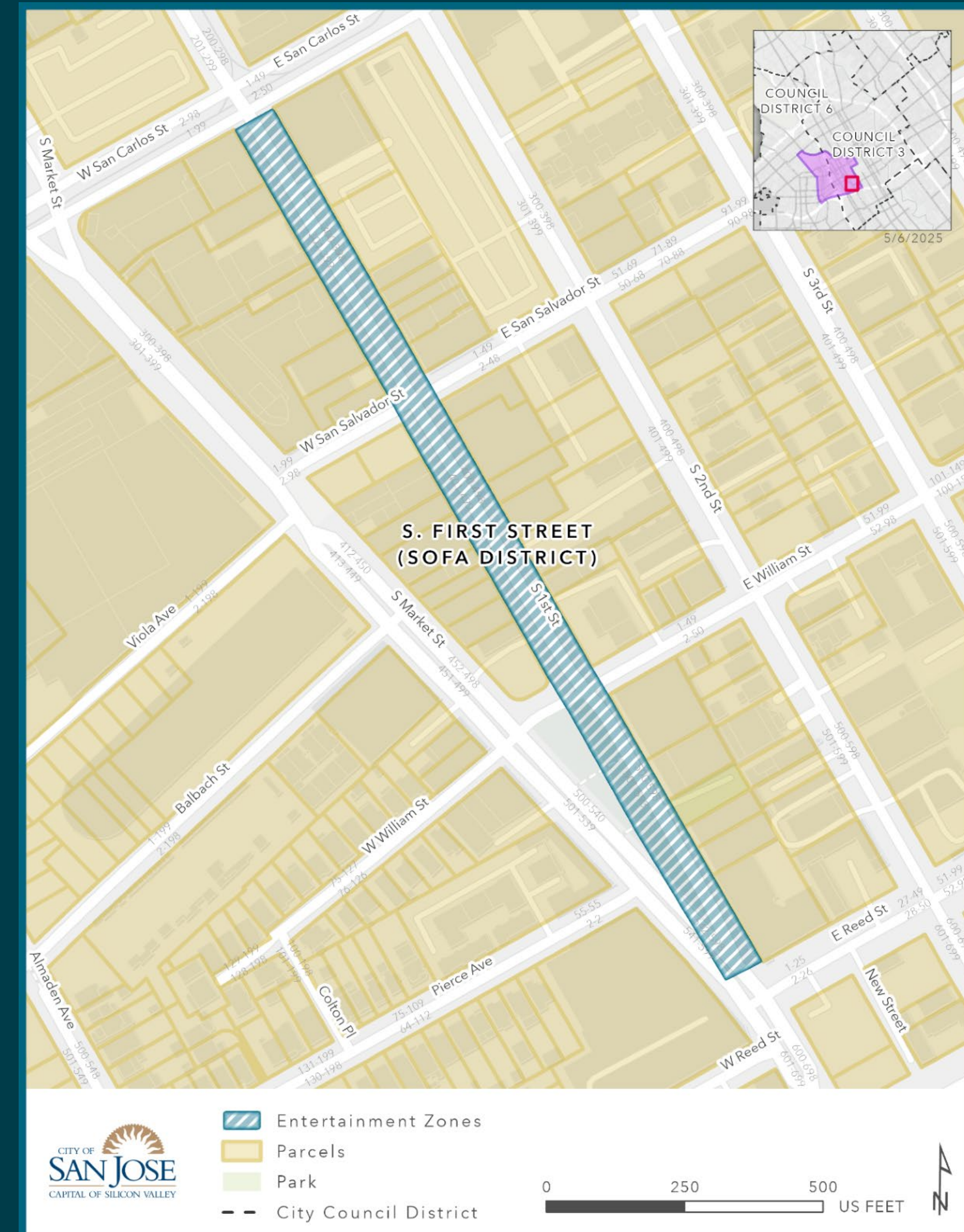
Post Street

and First Street



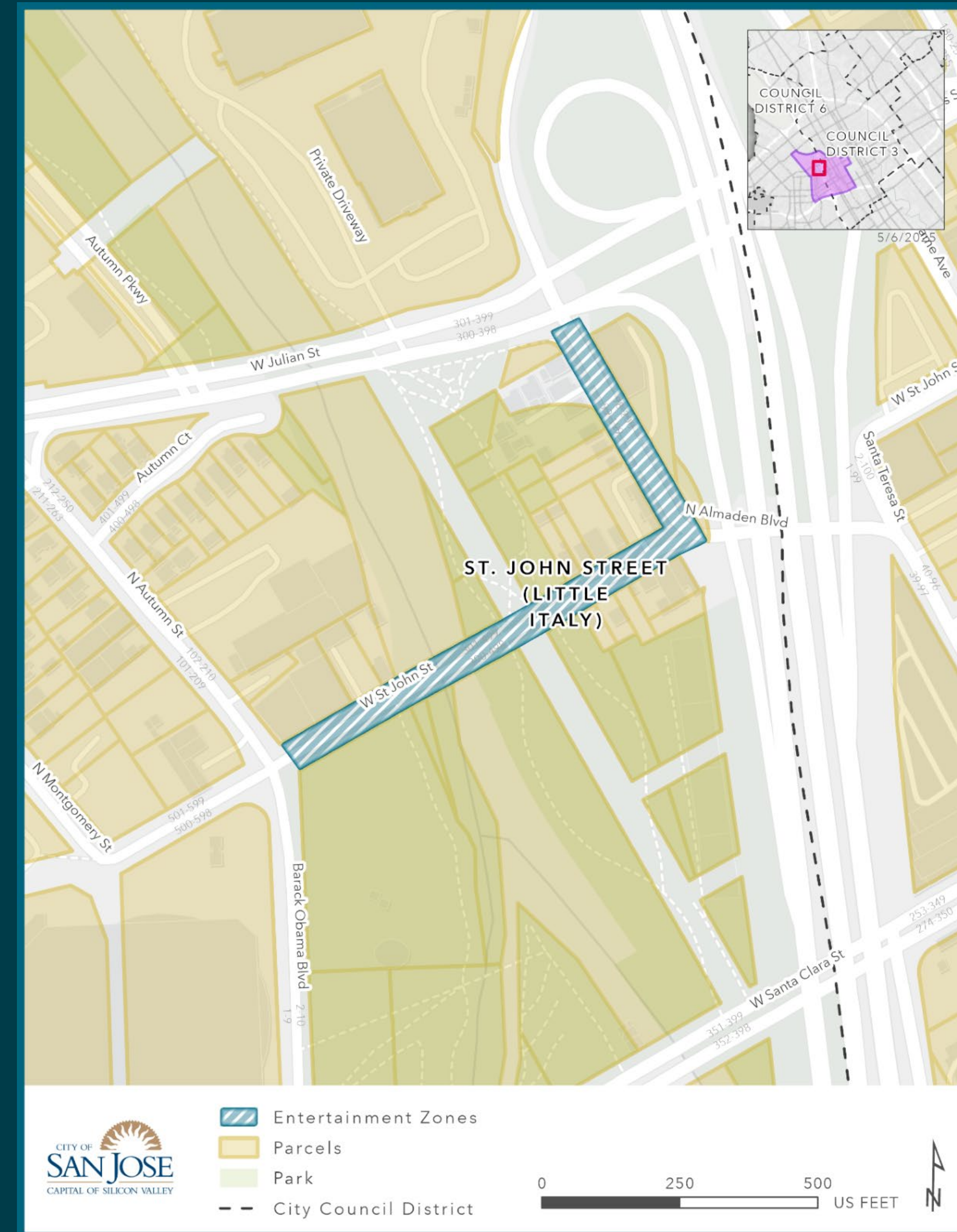
South First Street (SoFA District)

and East Reed Street



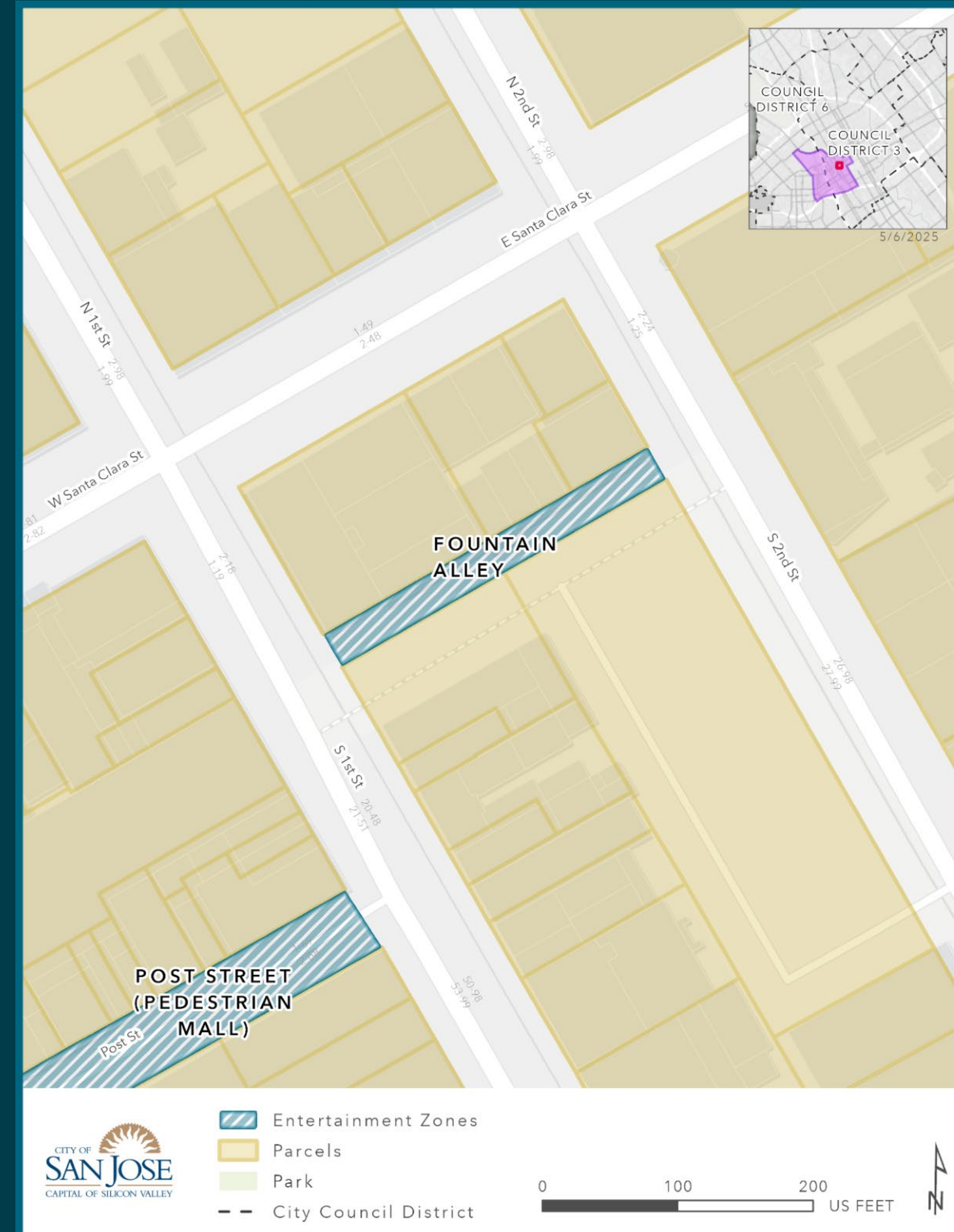
St. John Street (Little Italy)

Between North Almaden Boulevard and North Autumn Street; and North Almaden Boulevard between Julian Street and Barack Obama Boulevards



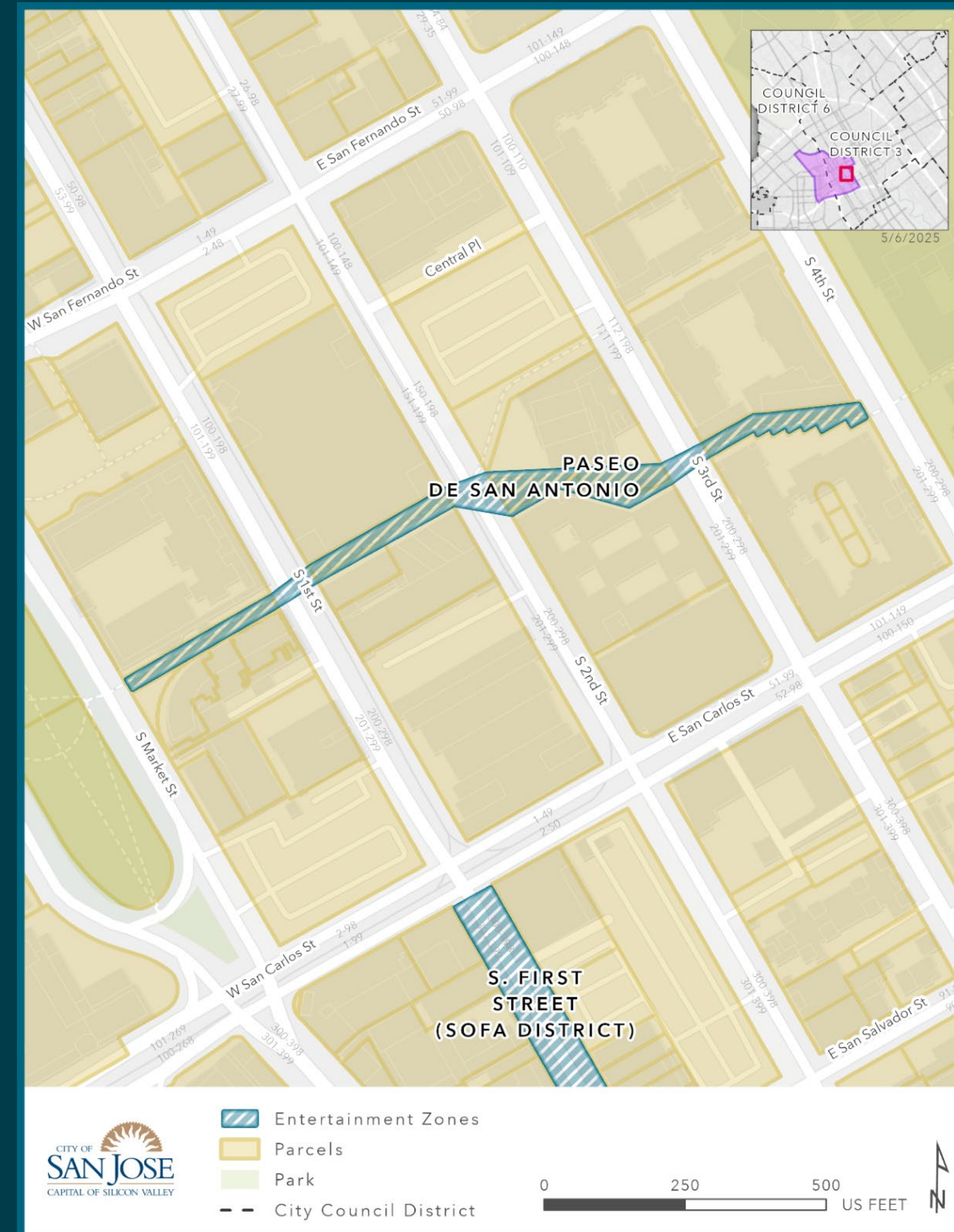
Fountain Alley
