<u>Friendly Amendment</u>: Councilmember Dev Davis made a friendly amendment to direct staff to monitor SB 1211 (Skinner), pending its recent amendments regarding the joint memorandum from Councilmember Peter Ortiz, Councilmember Omar Torres, and Councilmember David Cohen, dated April 19, 2024. The friendly amendment was accepted by the maker of the motion and seconder.

Councilmember Dev Davis addressed her concerns regarding the importance of avoiding the unintended consequences of homes staying vacant.

direct staff to monitor AB 2584 (Lee), mentioned in the joint memorandum from Councilmember Peter Ortiz, Councilmember Omar Torres, and Councilmember David Cohen, dated, April 19, 2024. The friendly amendment was *not* accepted by the maker of the motion and seconder.

<u>Friendly Amendment</u>: Councilmember Dev Davis made a friendly amendment to bifurcate the vote regarding AB 2584 (Lee) of the joint memorandum from Councilmember Peter Ortiz, Councilmember Omar Torres, and Councilmember David Cohen, dated, April 19, 2024. The friendly amendment was accepted by the maker of the motion and seconder. *After further discussion the friendly amendment was retracted*.

Councilmember Dev Davis addressed her reservations regarding the analysis of AB 2584.
