Dear Honorable Mayor and City Council:

On behalf of the San José Library and Education Commission, we appreciate your leadership and commitment to ensuring equitable access to learning, technology, and essential community resources. The San José Public Library ("Library") is one of the City's most utilized and highly rated public services, serving as a pillar of education, workforce development, and digital access that thousands of residents rely on daily.

San José libraries saw a 20% increase in visits last year, reflecting the growing demand for education, career development, and digital inclusion services. As more residents turn to the Library for essential resources, it is critical that Library funding remains fully sustained without reductions. The Commission urges that there be NO service reductions or impact to Library hours. Maintaining full funding ensures that libraries continue to serve as safe, welcoming spaces that foster learning, economic mobility, and community engagement.

To ensure all residents continue to benefit from essential Library services, the Commission respectfully requests support for the following priorities:

- Maintain the Essential Services Provided by the Library Ensure that there are <u>no</u> service reductions or impacts to current Library hours so that libraries may remain open and available to the public seven days per week.
- Sustain Digital Equity and Technology Access Maintain investment in Tech Hubs, digital literacy training, and community Wi-Fi infrastructure to close the digital divide. This includes sustaining SJ Access programs, public device lending, and cybersecurity staffing to protect the Library's public network and ensure safe, reliable access to online resources for all residents.
- Strengthen Workforce Development and Career Pathways Continue funding for <u>SJPL Works</u>, <u>Resilience Corps Learning Pathway</u>, and <u>College & Career Pathways</u> to provide job seekers and students with career readiness training, mentorship, and employment opportunities. Expanding paid internship and workforce training programs through the Library will help prepare San José's next generation for the evolving job market.

- Maintain Library Infrastructure and Public Safety Ensure that Library buildings remain safe, well-maintained, and accessible seven days per week. This includes funding for security staffing, facility repairs, and critical technology upgrades to meet the increasing demand for safe, welcoming library spaces.
- Expand Access to Library Services and Collections Preserve funding for physical and digital collections in English and world languages to meet rising demand and prevent the Library from falling further behind other Bay Area cities in per capita materials available. Investing in multilingual, culturally inclusive resources ensures that all residents—regardless of language or background—can access books, research materials, and educational tools.
- Libraries as Community Hubs for Learning & Engagement Support early education
 programs, youth engagement initiatives, and expanded out-of-school learning
 opportunities that align with <u>San José's Education Policy and Children & Youth Services
 Master Plan</u> and the City's Youth Commission. Funding family literacy programs, civic
 engagement initiatives, and community-driven programming will strengthen the Library's
 role as a key learning and resource hub for all residents.

The San José Public Library is one of the City's most impactful and cost-effective investments, ensuring that residents of all ages have access to the information, skills, and support they need to succeed. Prior funding commitments have already yielded significant community benefits, including expanded Library hours, increased workforce training programs, and greater access to digital resources. As a result, Library visits have risen, job seekers have found employment, and students have received critical educational support.

Sustaining digital equity funding is essential. The Library has been a leader in bridging the digital divide, yet 154,000 San José residents remain unconnected or under-connected, disproportionately affecting low-income households, seniors, and students. The elimination of the Library's hotspot lending program in 2024 has left thousands without affordable internet access. We urge the City Council to allocate new funding to restore this critical service and expand Tech Hubs, ensuring that no resident is left behind in an increasingly digital world.

San José's economic recovery depends on strong workforce training programs. The Library's job readiness services—SJPL Works, Resilience Corps, and College & Career Pathways—must continue to be funded to support residents entering high-demand industries. Investing in paid internships and hands-on learning opportunities will prepare the next generation for San José's evolving job market.

Safe and accessible Library spaces are not a luxury—they are essential community resources. With Library usage increasing, the City must sustain funding for security staffing, facility improvements, and technology upgrades to ensure Library buildings remain operational

seven days a week. Without continued investment, libraries will struggle to meet growing demand, limiting access to the safe, welcoming spaces that residents rely on for learning, career development, and community connection.

Beyond infrastructure, the Library serves as a critical gateway for career exploration, digital skillbuilding, and academic support—especially for young residents. It provides opportunities for students to develop essential skills, explore career pathways, and engage in civic life. Without continued investment, thousands of youth risk losing access to these vital opportunities, widening disparities in education and economic mobility.


While we recognize the City faces a \$60 million budget shortfall, it is essential that Library resources remain fully funded without reductions to meet the rising demand for education, workforce development, and digital access. The Library plays a vital role in keeping San José competitive, equitable, and economically strong by supporting student success, preparing job seekers for high-demand careers, and providing accessible spaces for lifelong learning and community engagement. Additionally, the <u>Youth Commission's 2025 Priorities Survey</u> results reinforce the importance of Library services for young people, highlighting the need for career pathways, digital inclusion, and accessible learning spaces. Ensuring continued investment in Library resources is critical to maintaining these opportunities for all residents.

The Library and Education Commission urges the Mayor and City Council to prioritize Library funding in this year's budget, ensuring that all San José residents—from childhood to adulthood— can benefit from free access to educational programs, workforce training, digital literacy services, and safe spaces to learn and grow. Investing in the Library means investing in San José's long-term economic vitality, equity, and innovation.

We appreciate your consideration of the critical services and opportunities provided by our public libraries and the long-term benefits they bring to our city.

We are homeowners and business owners. It's a disgrace whats on these streets. Have some pride in the job you do, or get another one. Barbara Gallaty Ace Seal LLC



The possibility that the ban on remote comments might only last months is no comfort to those who wish to comment on current City Council, Committee and Commission matters in order to ensure that quality of life in San Jose is maximized. I ask that you immediately restore virtual public comment to ensure that you and the City once again benefit from the voices silenced by your recent decision. I have gone in person to city council meetings and endured long drawn out discussions without the opportunity to speak more than 2 minutes. We need virtual public comments to make sure that our members hear their constituents. Many people who can not get to a city council meeting need this to have their voices heard.


