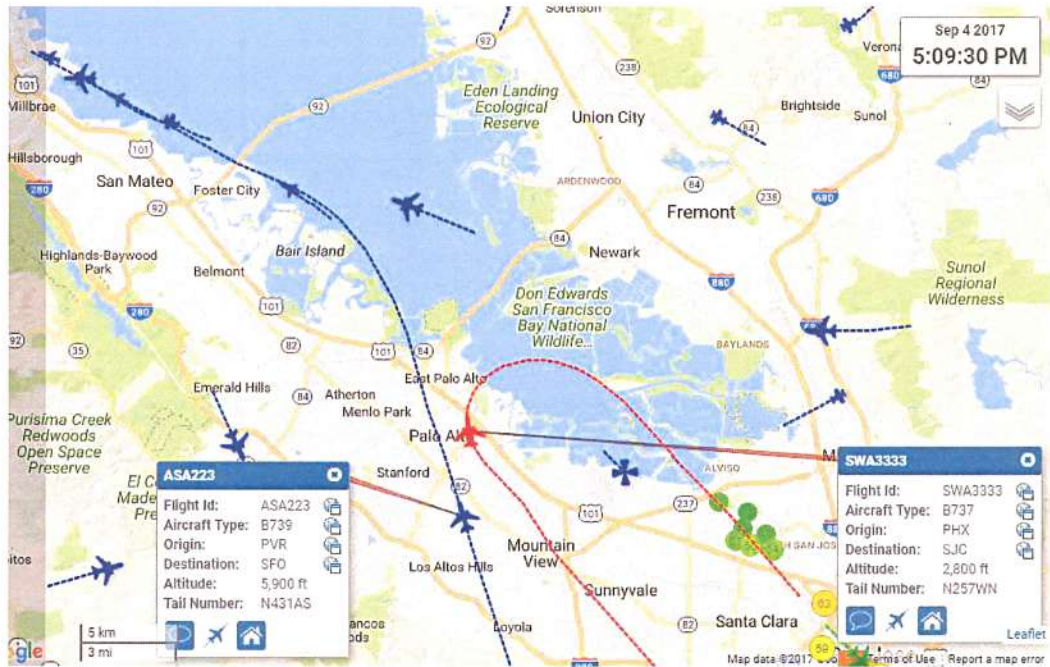

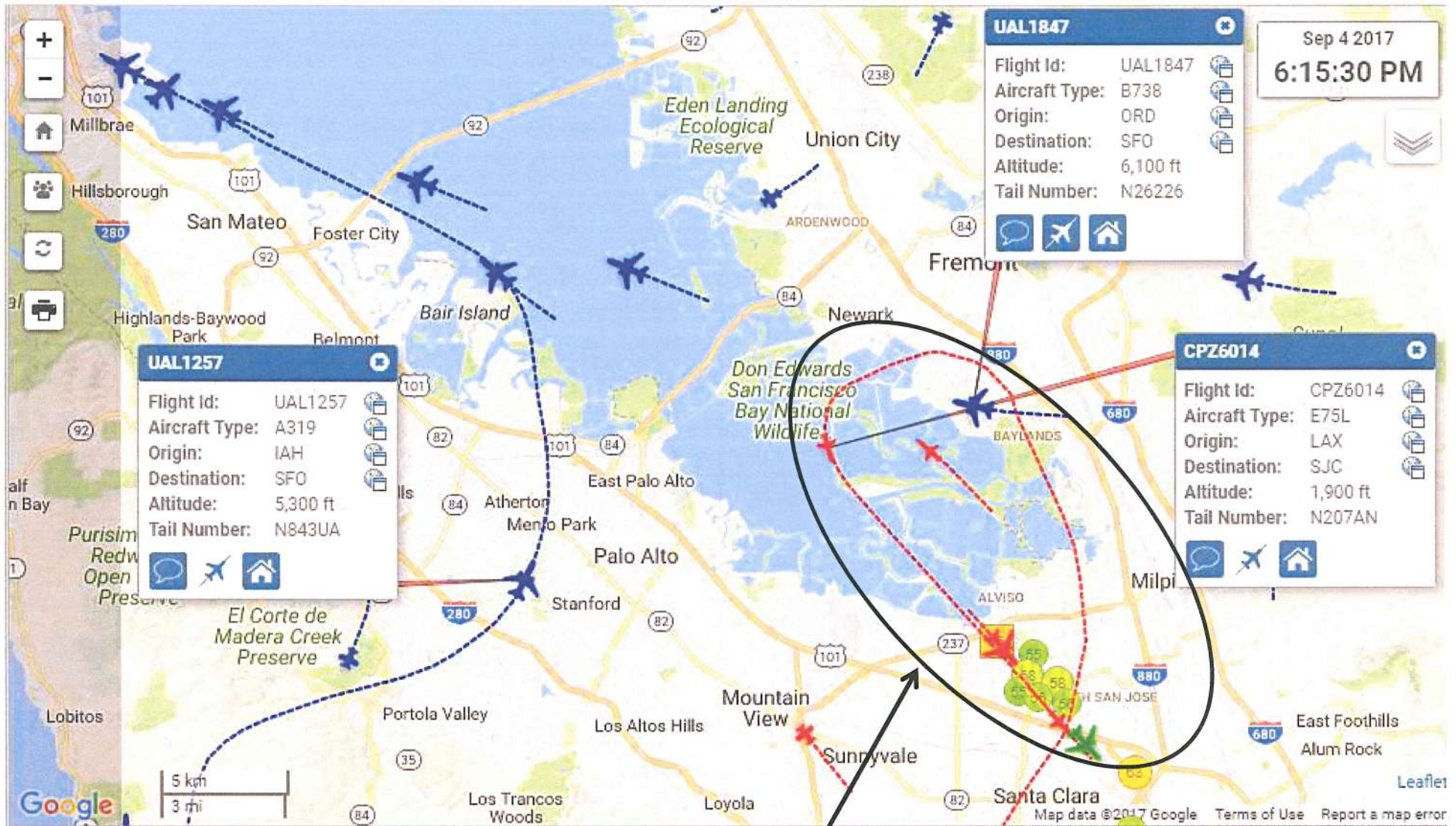

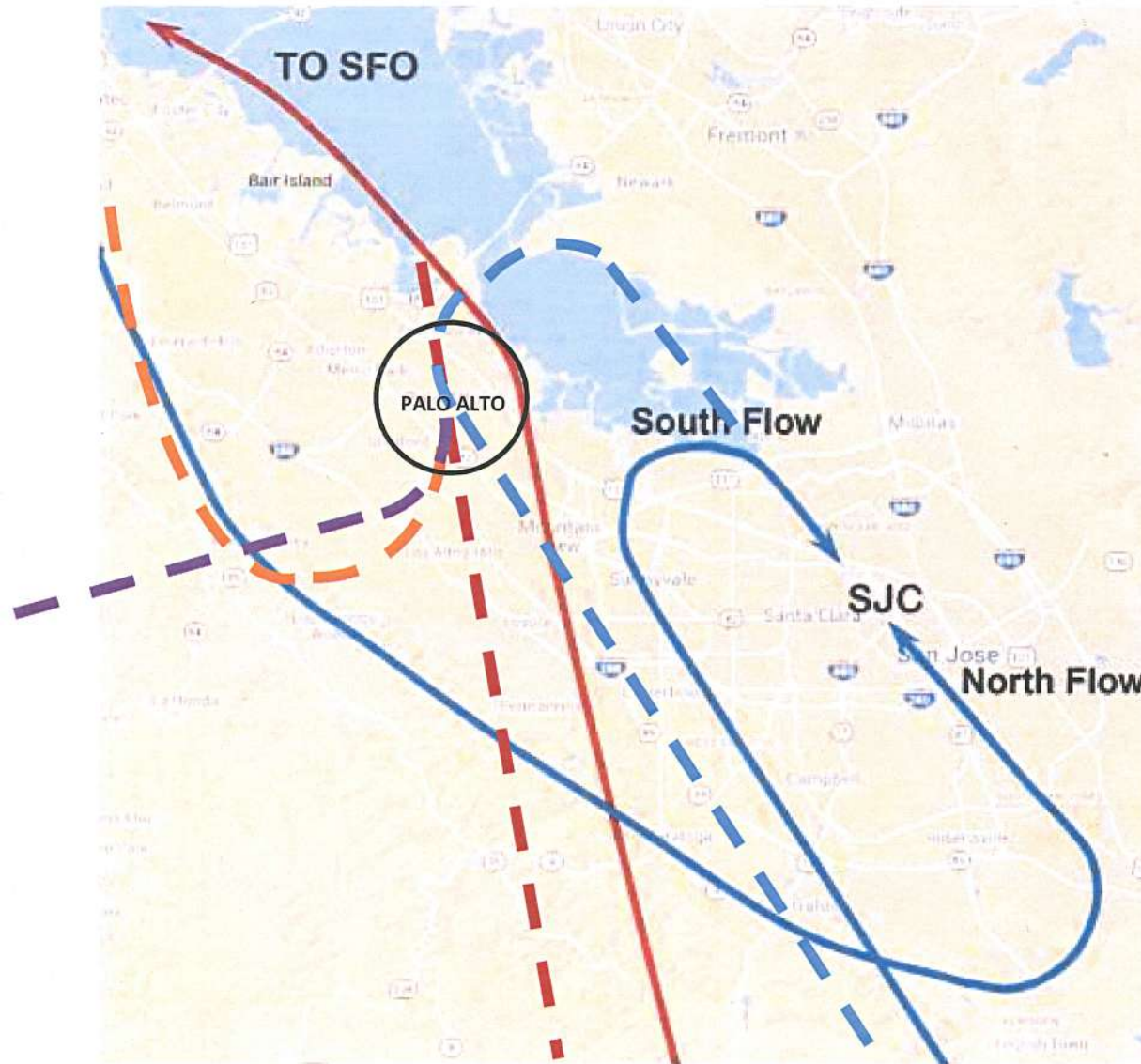

The following statement was read during the public comments period (2 minutes) at the Transportation and Environment Committee meeting of Sept 11, 2017. Agenda Item D3 (Formation of the Ad Hoc Advisory Committee on South Flow Arrivals (Airport) Presentation).

This public comment was presented by Sunnyvale resident Jennifer Tasseff on behalf of the more than 500 members of the Sunnyvale/Cupertino Airplane Noise group.

The text of the presented speech is attached below.

BEGINNING OF PUBLIC COMMENT:

I am here representing more than 500 members of the Sunnyvale/Cupertino airplane noise group.

As you already know, thousands (if not 10s of thousands) of Sunnyvale and Cupertino residents are heavily impacted by the San Jose South flow flight path.

This South flow flight path impacts a swath of over 15 miles of densely populated residential areas in the bay area. During South flow operations, there is likely no other bay area flight path that has so much residential impact.

Sunnyvale & Cupertino residents are enraged- I cannot over emphasize how bad this situation is for residents directly under this flight path. These are normally very quiet residential neighborhoods that are pounded during South flow operations.

This issue needs to be solved.

To solve the South flow problem, our group recommends the immediate creation of a fast action working group or ad hoc committee. This fast

action working group would be temporary, limited to cities directly affected by this flight path, and strictly tasked with solving the South flow flight path issue.

We are encouraged that San Jose airport clearly wants to participate in this process.

Our group definitely would like to see the creation of an ad hoc committee or working group to discuss and solve the issue.

We understand that SJC is recommending that all 15 Santa Clara cities be invited to participate in the committee and become voting members. However, most of these cities are not impacted by the South flow flight path, and have little or nothing at stake.

For this reason, we definitely want it on the record that we have major concerns that the initial committee will potentially be composed mostly of cities not impacted by South flow. Cities not impacted may not have the passion necessary to find effective solutions for this flight path issue.

We respectfully ask if Jim Webb and this Transportation committee can have a discussion today regarding the possibility of limiting the initial number of cities involved to those cities directly affected by the south flow issue.

To be clear, we definitely support the creation of the ad hoc committee regardless of whether the number of cities is limited or not. We need immediate resolutions for this issue, and we need you to vote on approving this committee today. But we are concerned.

I want you to have four of them go by every 3 minutes for 24 hours. That's what we are experiencing.

It's destroying our lives. It's destroying our families. It's destroying our property values. I can't express to you enough how absolutely harmful and destructive this noise is.

The FAA knows they made a mistake here. They are willing to go back and figure something out.

But we need to have this committee. It is absolutely vital that we have this committee.

I've made a joke about this before, where I was a flight attendant for 35 years – The flights are so low and so loud, I'm surprised I don't recognize crews... OK?

And I'm so happy that all of you are here, and you are listening, and you are concerned.

But the cities that are the most concerned have to have the most stake in the game. We are the ones that have this horrible noise – Have this constant noise, have this constant disruption. And please... Don't let us be out-voted by the majority of cities that do not have this complaint!

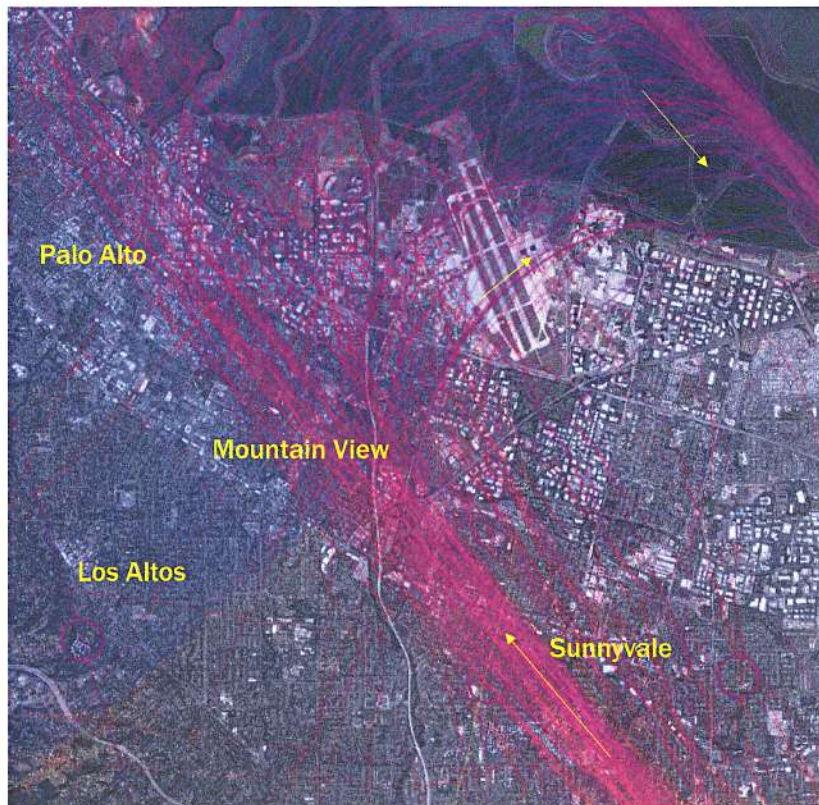

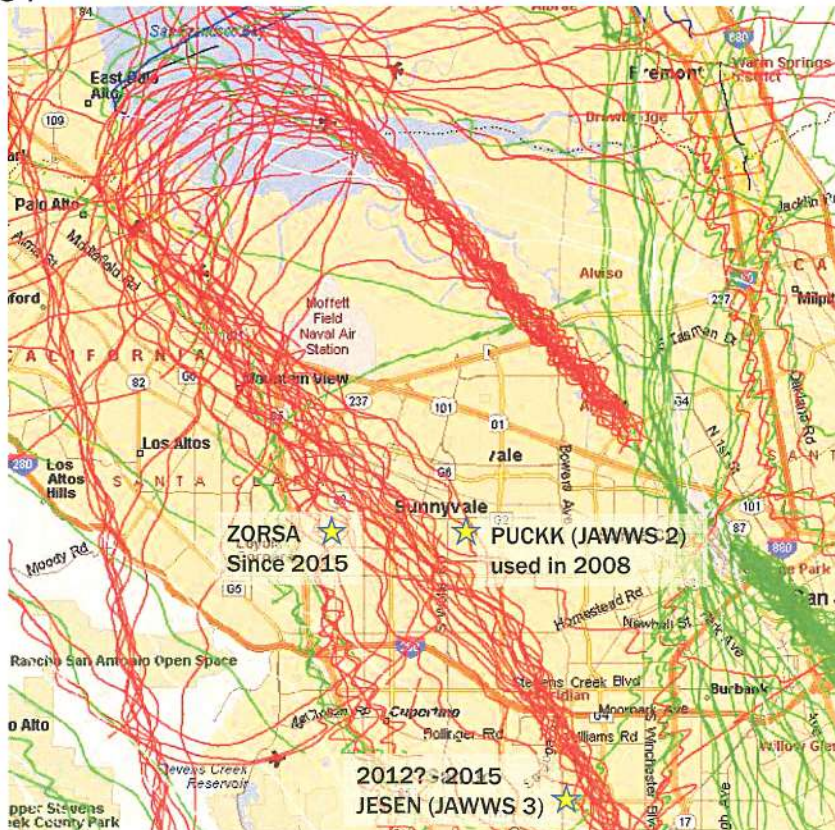


Flight tracks after recent changes 3/10/16



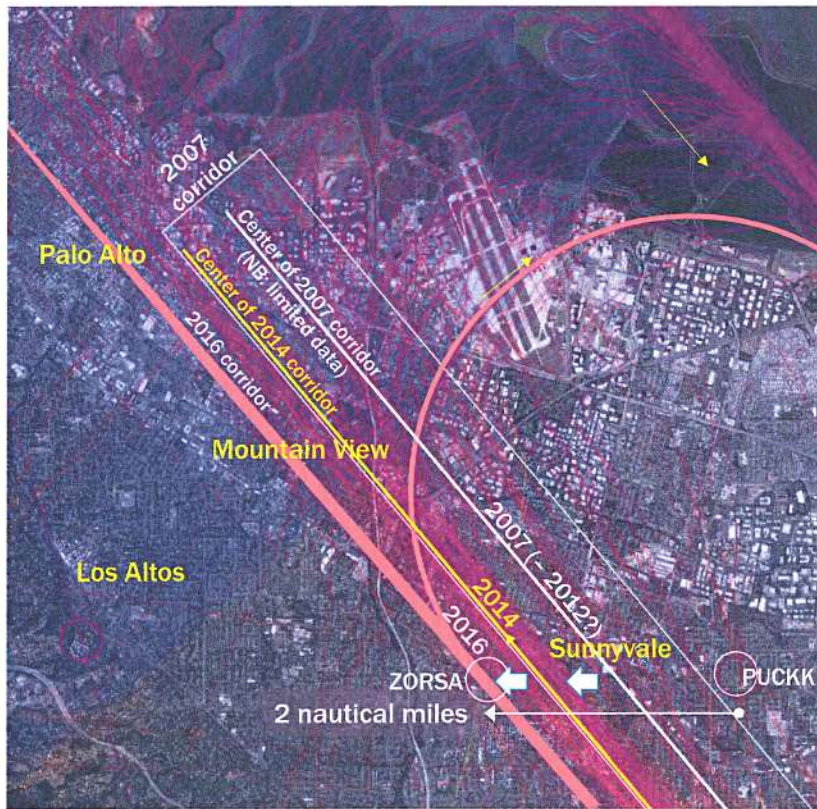

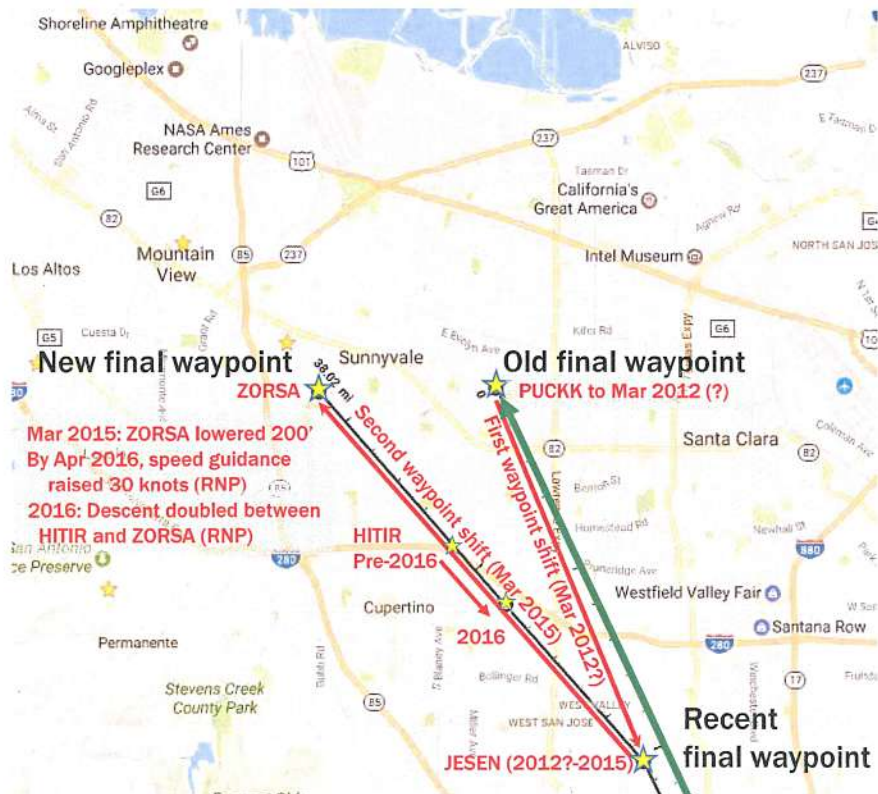

To the Members of the Transportation and Environment Committee of the San Jose City Council:

I am emailing you to support the proposal to set up an Ad Hoc Advisory Committee on South Flow Arrivals, which I understand will be an agenda item for your meeting tomorrow, Sept. 11.

As a resident of Mountain View for 35 years, I can attest that airplane noise from San Jose International (SJC) was historically almost nonexistent. Occasionally during "reverse flow" conditions in rainy weather patterns, one could hear an occasional plane off in the distance as it would approach SJC. All that has changed in the past year or two. Now, reverse flow conditions bring a steady barrage of low-flying planes, most below 3,000 feet, and some under 2,000 feet, traveling down a narrow corridor directly above central Mountain View. The planes can be so loud as to drown out the TV, even with all the double pane windows closed. The planes come in bunches, usually separated by a mere two minutes, and the barrage can last an hour, and can be repeated many times throughout the day. A given day can bring well over 100 such planes, extremely noisy and obtrusive, and sometimes this pattern can last several days on end.

Needless to say, after 30+ years with little airplane noise to speak of, the noise assault we now experience many days per year has had a very negative impact on quality of life here in Mountain View. My own observations are supported by data showing a dramatic concentration of flights in a narrow corridor over Mountain View in the recent past. I find it entirely unacceptable that due to bureaucratic fiat, Mountain View should be subjected to relentless airplane noise, where little existed before. I am also aware that Mountain View isn't the only community affected by the changes in flight patterns. The problem with reverse flow airplane noise is both severe and widespread, and as such, it is imperative that a regional body or committee of some kind investigate and devise solutions to the problem. I believe the proposed Ad Hoc Advisory Committee on South Flow Arrivals would be a good, and necessary, step in the right direction, and one I hope will result in substantial mitigation to the airplane noise problem that we in Mountain View have been subjected to in the recent past.

Mountain View residents very much need this committee to work with the FAA to address the noise impact of the changes they have rolled out during the last 2 years to concentrate flight paths into narrower corridors and shift the center of these corridors west.

As a resident of Mountain View, for whom the increased noise from aircraft flying over my neighborhood in the last 2 years + has been very disturbing, I'm particularly hopeful that some efforts at mitigation can be discussed and implemented. I have a 77 year old home here, well-insulated, with thick wood siding plus stucco added in 2002. The sound from some recent jets, even when we're inside my home is extremely loud, disturbing and interrupts my family's work, rest and play! As a long time resident of Mountain View (and in the Cuesta Park neighborhood since 2008), I have witnessed first hand how a once quiet neighborhood has been turned into a loud highway of low flying, fast planes at all times during the day and late into the night during reverse flow conditions (aka South Flow). This is not the quiet neighborhood anymore I have known since 2008. Concentrated heads down work or just leisure activities such as reading, watching television or listening to the radio are made impossible by a never ending stream of noisy planes.

At the recent meeting of the Transportation and Environment Committee, several members of the public expressed concern about a rule being proposed for the Ad Hoc Advisory Committee on South Flow Arrivals: to adopt any recommendation, a two-thirds vote of the Committee would be required, with all cities in Santa Clara County, plus the County itself being invited to join as members, each with a vote. The problem is that this requirement establishes the noisy status quo as the baseline. I don't recall that two-thirds of the cities in the area voted to approve the changes rolled out over the last few years. Rather, the FAA took us backwards without any kind of vote.

Therefore, I ask respectfully ask the San Jose City Council to consider amending the governance being proposed for the committee as follows:

"The Ad Hoc Advisory Committee shall be allowed to adopt any recommendation that reverts to procedures existing prior to Nextgen, in whole or in part, by a majority vote of the affected Cities."

I believe that the same cities were affected by South flow before and after the changes.

This amendment would remove the strong bias being set up in favor of the current unsatisfactory situation.

Honorable Mayor and Members of the City Council,

I would like to expand on the answers provided to you by SJC Director of Aviation John Aitkin in answer to the Vice-Mayor's question, "How did we get here and what might be done?"

* Mr. Aitkin cited the increased use of GPS navigation, linking it to an approach path introduced in 2011 as did Mr. Glen Martin of the FAA in a January letter to Airport Staff. I think he's referring to the 'RNP' approach over Whisman Ave in East Mountain View (the semicircle on the vector maps) which requires advanced navigation. FOIA data through 1H2016 shows that about a fifth of South flow arrivals took that path, although we can expect that percentage to increase with time, perhaps dramatically. (This needs to be understood.) The noise of flights taking this path might well be louder than flights flying the former path - they are turning - but use of the RNP path does not explain complaints from areas of Mountain View and Palo Alto far from that path.

* Mr. Aitkin mentioned an increase in the weather conditions that dictate South flow. Running numbers based on FOIA data for an area near my house before and after Nextgen, I found 2.7 times as much South flow traffic after as before. After backing out the increase in rainy weather AND the increase in traffic into SJC, there would still have been 2.2 times as many flights as before. And a lot of people think individual flights are louder. Weather has been a factor, but there are bigger issues.

* **The flight corridor was narrowed generally.** Concentration was not limited to flights flying the RNP path. This happened in 2015 when the final waypoint on the heavily used STAR procedure published by the FAA to guide all South flow air traffic to the vicinity west of SJC was moved from JESEN over Hamilton Avenue to ZORSA in Sunnyvale, six miles west. ALL planes at JESEN, not just the fifth taking the RNP path, were routed on to ZORSA. This meant concentration by design over Sunnyvale and concentration by default over Mountain View and Palo Alto as planes continued along the line that took them from JESEN to the new final waypoint at ZORSA. (When the final waypoint was JESEN, pilots had to make a slight turn to the left after reaching JESEN, but, having completed the STAR procedure, they had more discretion in where to begin that turn, which introduced some fan out. That dispersion increased as the planes flew northwest over Sunnyvale, Mountain View and Palo Alto.)

* **The flight corridor was shifted west - twice.** The move from JESEN to ZORSA also shifted the center of the corridor that planes actually flew about a half nautical mile. And that followed an earlier shift of a half nautical mile or so (and another change in the final waypoint) sometime between 2007 and 2013. I rented my house in 2005 and airplane noise was my first consideration, after a bad experience earlier. It was not a problem when I bought the same

house five years later in 2010. After the changes by the FAA, planes now pass within a few blocks of my house. (Please refer to presentation I gave to the Transportation and Environment Committee, published with comments from the public, to see a map showing how corridors have been shifted.)

* **Speed guidance was raised.** Since 2015, the speed guidance at ZORSA was increased from 180 knots to 210 knots. Airplane noise defies our instincts about physics in that seemingly small changes in speed (including exhaust velocity) can have huge effects on noise. I'm not an acoustic engineer, but a SWAG based on my research and making lots of assumptions is that that change alone *might* have the same effect as lowering altitudes from 4000' to 3000'. It would be good to have an expert analyze this.

* **The altitude at ZORSA was lowered.** Mr. Glen Martin mentioned in his January letter to Airport Staff that the altitude at the WAYPOINT between JESEN and ZORSA, named HITIR, was raised and the waypoint shifted a bit. He neglected to mention that the altitude of ZORSA was lowered by 200'. The descent from HITIR to ZORSA doubled. An expert should examine whether these changes contributed noise.

What might be done?

* **Unwind** some of the above changes, particularly the concentration. Reverting to the earlier speed guidance should be considered.

* **Consider alternate approaches**, particularly over industrial/commercial land. 10% of arrivals to SJC during South flow conditions approach the airport from the east, and that includes heavy commercial jets.

* **Consider business incentives** by the airport operator (SJC) for aircraft carriers to reduce noise. The Select Committee reported that a simple fix to a major annoyance (the 'Airbus whine', a loud whistle caused by a design defect in the wings) can be installed at a total cost of \$3000 per airplane. In the US, no government body short of Congress can require this of the airlines, the FAA told the Select Committee that it has no mandate to do so. So far, most (not all) airlines have refused to do it. While fines are not allowed under law, business incentives, properly constructed, should be permissible and could tip this balance. The City Council can ask the airport to look into this. In fact, the City Council, in its capacity as steward of the airport, is the only government body short of Congress that can move this forward. It works in Europe: I have heard that planes at Heathrow are 15% quieter than at other European airports because they have noise-based landing fees.

Two thoughts in closing:

Even the FAA acknowledges that there is a balance to be struck between efficiency and noise. FAA Administrator Michael Huerta has said that he would be willing to give up the last 20% gain in efficiency in order to address noise complaints. "If we can get an 80% improvement in flight

operations efficiency, I will happily take it over a 100% gain if it means avoiding years of litigation [over noise].”

Locally, the stakes involved are high and growing fast: on the worst days, we have seen 220 flights over Sunnyvale and adjacent communities. If SJC grows at the rate they predict, in ten years, we can expect a flight almost every two minutes on average during waking hours on the worst South flow days. It's important to get this right.

The FAA accommodated that transfer without any knowledge from the City of Sunnyvale or any of the other 5 South Bay cities. The primary problem seems to be Surf Air operating out of San Carlos, which is a small non-commercial airport. How this airport can fly commercial planes without proper security and approval is a huge question in our city.

Furthermore, I understand that there is a night curfew which is totally being ignored. Planes fly at all hours of the night. During the day, I often count 4 planes flying over my home every 5 minutes. In the past, there were occasional flights which was acceptable, but now, the pattern has changed and a concentrated narrow flight pattern of 15 miles comes directly over us. In the future, with the growth of the San Jose and San Francisco Airports and the commercial continuation of the use of San Carlos Airport, we are being inundated with noise, all day, all night.

My husband and I have been residents of Sunnyvale for 34 years. Much to our dismay, our beloved home is under the new NexGen South Flow flight path implemented in 2016. Since implementation of this new technology, commercial flights into San Jose Airport arrive immediately overhead one after another, sometimes only a minute or two apart, for hours on end during certain wind conditions.

The constant noise is extremely disruptive to my family. Prior to NexGen, South Flow flights were distributed over a wide swath of the Sunnyvale area, which while somewhat noisy, at least spread the noise and provided relief between flights.

We are very concerned that with airport growth our home will become unlivable during South Flow conditions. We understand that we live in an urban area with dense air traffic, and that all homes in the region suffer some noise pollution from aircraft. In Sunnyvale, we already experience the bulk of Moffett airport noise, and are also impacted by flights to San Francisco, Palo Alto and San Carlos. We believe it is equitable to explore options on how noise from SJC South flow can be reduced.

The San Jose Airport has expressed a desire to look at how the increased noise in our area might be ameliorated through a targeted task force on South Flow solutions. We urge you to approve this working group to remedy the concentration of flight activity over Sunnyvale homes.
