(1) Report on the Pilot Safe Parking Program. (Housing)

Deputy Director of Policy & Budget, Ragan Heninger, provided a presentation and responded to questions.

(D) (1) Report on the Pilot Safe Parking Program. (Cont'd.)

Public Comment:

- 1. Ingrid, with Amigos Guadalupe, had questions about the program expansion. At the Committee's request Deputy Director of Policy & Budget, Ragan Heninger responded, indicating it will be expanded to two additional City sites per an amendment to the LiveMoves contract.
- 2. Karen Gillette discussed her involvement in safe parks on church properties and stressed coordination and monitoring to benefit programs as recommended by the City Auditor.
- 3. Kathy Mattingly, representing the interfaith community, offered comments the safe car park her organization is currently running.
- 4. Dominque, Supervisor at Seven Trees Community Center expressed appreciation for services offered by LifeMoves
- 5. Phil Mastercola offered that the weak link is outreach, and his hopes that this may act as navigation center and a community model.

Chelsea Tercero, LifeMoves Program Director, Safe Parking for Families, provided data on the number of individuals served and offered additional information on First 5 Family Resource Centers efforts.

<u>Action</u>: Upon motion by Councilmember Magdalena Carrasco, seconded by Councilmember Pam Foley, and carried unanimously, accepted the report on the progress and status of the Safe Parking Pilot Program. (5-0.)

Councilmember Maya Esparza left the meeting at approximately 3:00 p.m.

(2) Verbal Update of Police Activities League (Police Department / PRNS)

Deputy Director of Parks, Recreation and Neighborhood Services, Justin Long offered a presentation, and he and Director of Parks, Recreation and Neighborhood Services Angel Rios, Jr. responded to questions from the Committee.

<u>Action</u>: Upon motion by Councilmember Magdalena Carrasco, seconded by Councilmember Pam Foley, and carried unanimously, the Committee accepted the verbal update on the Police Activities League. (4-0-1. Absent: Esparza.)

Director of Public Works John Cicerelli offered an introduction and introduced the new newspaper-style Community Impact Report. Carolina Camarena, Public Information Manager, continued with 2018 community impact report.

Director of Public Works John Cicirelli continued with "moving Forward in 2019" and roll-out of ActivateSJ, formerly known as Greenprint.

Division Manager, Andrea Shelton, responded to questions regarding senior outreach.

<u>Action</u>: Upon motion by Councilmember Pam Foley, seconded by Councilmember Sergio Jimenez and carried unanimously, the Committee accepted the Parks, Recreation and Neighborhood Services 2018 Community Impact Report. (4-0-1. Absent: Esparza)

(4) Project Hope Update. (PRNS)

Director of Public Works John Cicerelli provided an introduction, and Mario Maciel, Youth Intervention Services, introduced the Project Hope Structure. Communication Services Supervisor Olympia Williams gave updates for specific sites; staff provided a presentation and discussed strategic outcomes. Director of Parks, Recreation and Neighborhood Services Angel Rios, Jr. and staff responded to questions.
