2.7 Naming of Two Downtown Park Sites: Bassett and North San Pedro.

Adopt the official names for two park sites based on the following options:

(a) "City Gardens Park," for the Bassett site, as recommended by staff and the Parks and Recreation Commission and as a result of a public outreach process; and

(b) "Elizabeth P. Boyer Park," for the North San Pedro site, as recommended by staff and the Parks and Recreation Commission and as a result of a public outreach process.

- (b) Approve and accept donations from various individuals, businesses, or community groups to support the event.

2.10 California Natural Resources Agency Grant for the Lake Cunningham Water Quality and Shoreline Improvement Project.

Adopt a resolution authorizing the City Manager or her designee to submit a grant application and, if awarded, negotiate, and execute a grant agreement with the California Natural Resources Agency for an amount not to exceed \$1,500,000 contributing to the Lake Cunningham Water Quality and Shoreline Improvement Project, and all other actions necessary to effectuate the grant.

CEQA: Categorically Exempt, File No. ER23-039. CEQA Guidelines Section 15301, Existing Facilities and Section 15302, Replacement or Reconstruction. (Parks, Recreation, and Neighborhood Services)

<u>Action</u>: **Resolution No. RES2024-8** was adopted, authorizing the City Manager to execute a grant agreement with the California Natural Resources Agency for an amount not to exceed \$1,500,000 contributing to the Lake Cunningham Water Quality and Shoreline Improvement Project. (11-0-0)

2.11 Rapid Response Efforts to Support Asylum Seeking Families.

- (a) Approve the one-time allocation of \$150,000 to provide funding to Amigos de Guadalupe: Center for Justice and Empowerment for temporary emergency sheltering and support of new arrival migrant families seeking asylum and who entered the United States after the end of Title 42, and matching the \$150,000 anticipated to be contributed by the County of Santa Clara.
- (b) Adopt the following Fiscal Year 2023-2024 Appropriation Ordinance Amendments in the General Fund:
- (1) Decrease the City Manager Special Projects City-Wide Expenses appropriation to the City Manager's Office by \$25,000; and
- (2) Increase the Non-Personal/Equipment appropriation to the City Manager's Office by \$25,000.
- (c) Direct the City Manager or her designee to monitor and remain engaged in collaborating with immigrant-serving organizations, philanthropic organizations and individuals, and local and state governments to identify strategies to extend support for asylum seeking migrant families beyond January 31, 2024.

City Manager, Jennifer Maguire offered the verbal report and announced that the City of San José has uploaded the first ever Year in Review videos, which highlight the dedicated and passionate City of San José employees. All of the city service areas are highlighted; including strategic support, community and economic development, neighborhood services, public safety, transportation and aviation, and environmental and utility services.

Jennifer Schembri, Director of Employee Relations, Office of the City Manager; Chris Burton, Director, Planning Building and Code Enforcement (PBCE); Jill Bourne, City Librarian, Library; Nanci Klein, Director of Economic Development, Office of Economic Development; Robert Sapien, Fire Chief, San José Fire Department; Neil Rufino, Assistant Director, Parks, Recreation and Neighborhood Services (PRNS); John Ristow, Director of Transportation, Department of Transportation (DOT); and Anthony Mata, Chief of Police, San José Police Department, answered questions from Council.

<u>Action</u>: Upon motion by Councilmember Omar Torres, seconded by Councilmember Bien Doan, and carried unanimously, the Annual Report on City Services was accepted. (10-0-1; Absent: Batra)

3.4 Amendment to Title 24 of the San José Municipal Code for a Proposed Responsible Construction Ordinance.

Direct the City Manager to return to City Council with a Responsible Construction Ordinance that modifies the proposed ordinance, posted for the December 12, 2023 City Council meeting, that reflects the following modifications:

- (a) Limit the basis for violation to an unpaid wage theft judgment to employees and contractors who are working on the San José permitted project that is the subject of the certificate of occupancy.
- (b) Limit the unpaid final wage theft judgements to final judgments that can be confirmed by the contractor through the California Labor Commissioner's portal.
- (c) Exempt from the regulation projects that are subject to prevailing wage under state law, and projects that are under 10,000 sq. ft.

CEQA: Not a Project, File No. PP17-008, General Procedure and Policy Making resulting in no changes to the physical environment. (Public Works) [Continued from 12/12/2023 – Item 3.7 (23-1695)]

Matthew Loesch, Director, Public Works; Nanci Klein, Director, Office of Economic Development; Chris Burton, Director, PBCE; and Chris Hickey, Division Manager, Public Works Office of Equality Assurance, provided a presentation and answered questions from Council.

Chris Burton, Director, PBCE, responded to questions from Council.

<u>Action</u>: Upon motion by Councilmember Dev Davis, seconded by Councilmember Bien Doan, and carried unanimously, the City Manager was directed to return to City Council with a Responsible Construction Ordinance that modifies the proposed ordinance, as discussed in the joint memorandum, with the understanding that outreach with stake holders will continue during the process of drafting the ordinance.

Including acceptance of the joint memorandum from Councilmember Dev Davis, Councilmember Sergio Jimenez, Councilmember Omar Torres, Councilmember Peter Ortiz, and Councilmember Pam Foley, dated January 18, 2024, recommending the following: Accept recommendation #2 from the January 12, 2024, staff memorandum with the following additions and modifications:

- (1) Before receiving a building permit, applicants will attest that, to the best of their knowledge, all contractors and subcontractors hired or to be hired to provide labor on their project are either not listed on the outstanding unpaid wage theft judgments list at the time of attestation or, if they are listed, will produce proof of satisfaction of the judgment(s) before work begins.
- (a) Applicant attestations will be based on checking California Department of Industrial Relations Judgment Search1 to ensure that none of their contractors or subcontractors have outstanding unpaid wage theft judgments in the construction industry. Exhibit A shows the search terms to be used. Each project will perform the search once on or around

the date of the attestation and use those search results (aka "outstanding judgments list") as needed for the duration of the project.

- (b) If a contractor or subcontractor is added to the project subsequent to building permit receipt, the project owner is responsible for checking each new company that is hired either is not on their outstanding judgments list or produces proof that the judgment has been satisfied before beginning work on the project.
- (c) If a contractor or subcontractor is not on the outstanding judgments list at the outset, but later receives a wage theft judgment, does not pay, and is subsequently added to the California Department of Industrial Relations database, the project owner would not be held responsible unless the unpaid judgment is for work on the project.
- (d) As provided in the original ordinance draft, a project owner who hired a contractor or subcontractor who was on the outstanding judgments list without producing proof of satisfaction of the judgment before beginning work would be required to pay the judgment or cause the contractor owning the money to pay the judgment, before receiving the final Certificate of Occupancy. (However, if a contractor or subcontractor was not on the outstanding judgments list but was subsequently added to the California Department of Industrial Relations database, the project owner would not be responsible unless the unpaid judgment is for work on the project.)
- (e) As provided in the original ordinance draft, only contractors and subcontractors that meet the materiality threshold for a project are included.
- (2) All projects at or above 10,000 square feet are included, regardless of project labor agreements or prevailing wage requirements. (11-0-0)

10.2 Urgency Ordinance Amending the Zoning District Map to Apply the Housing Element Residential Overlay Zoning District.

Adopt an Urgency Ordinance:

- (a) Repealing the application of the Affordable Housing Overlay on six sites in North San José from the Envision San José 2040 General Plan Land Use/Transportation Diagram and Zoning District Map;
- (b) Amending the Zoning District Map to apply the Housing Element Residential Overlay on 12 sites citywide; and
- (c) Requiring the six sites in North San José to allow residential use by right and to only allow residential uses on those sites where at least 20 percent of the units are affordable to lower income households.
