#### **RECOMMENDATION**

- 1. Approve a grant to the Preservation Action Council of San Jose to support their 35th anniversary Gala in the amount of \$2,000.

#### **BACKGROUND**

Pursuant to <u>City Council Expenditure and Reimbursement Policy, Policy Number 0-38</u>, Section K "Grants" Item 6 "Any contribution to an organization proposed by the Mayor or a Councilmember who is a member of, or receiving services from, that organization must be approved in advance by the City Council." I am a member of the Preservation Action Council of San Jose.

Approval is requested to expend \$2,000 from the budgeted District 3 Council Office allocation to support the Preservation Action Council of San Jose (PAC\*SJ) for their 35<sup>th</sup> anniversary Gala. Office funds are used to support services to San Jose residents or businesses.
