SUBJECT: DONOR RECOGNITION IN THE CALIFORNIA ROOM AT THE DR. MARTIN LUTHER KING, JR. LIBRARY

RECOMMENDATION

Approve specific donor recognition opportunities, located in the California Room at the Dr. Martin Luther King, Jr. Library.

OUTCOME

The San José Public Library Foundation (Foundation) will accept a \$600,000 gift from Margaret and Phillip Ma to enhance the news resources collections in the California Room.

BACKGROUND

On March 23, 2004, the City Council approved Council Policy #1-17, "Revenue Generating Policy: Fundraising, Sponsorship and Contribution Guidelines." The Policy requires that departments work with the City Attorney's Office to develop guidelines for fundraising programs and related donor recognition, and that the City Manager review and approve these guidelines. On October 29, 2004, the City Manager approved the Library Department's Guidelines for Contributions to the City of San José and Recognition of Donors for the Library Fundraising Campaign. The Guidelines include the recognition opportunities for the Branch Library Fundraising Campaign and state that the City Manager must approve recommendations for specific donor recognition in Library facilities. On December 14, 2004, the City Council authorized the Library to grant donor recognition in libraries for a term longer than one year. Contributions that exceed the City Manager's contract authority must be approved by the City Council.

The Foundation conducts fundraising and donor stewardship activities on behalf of the Library. To date, the Foundation has raised \$600,253 for the specialized local history collection known as the California Room. The California Room is a publicly accessible archive that maintains documents and materials related to California and San José history, ethnic groups and indigenous peoples, statehood documents, the City's articles of incorporation, founding bylaws of Silicon Valley companies, historical maps and records, and hundreds of other materials on related topics.

ANALYSIS

The Foundation is prepared to receive a \$600,000 gift from Margaret and Phillip Ma, given in loving memory of Susan Renzel Carter.

The contribution will be used to fund both the digitization and ongoing digital rights to more than one million pages of the Mercury News, San Jose's newspaper of record. Library customers will have digital access to editions published between 1950 and 1984 which are currently only accessible by using a single microfilm machine available in the California Room. The expansion of digitization for San José's newspaper of record will significantly enhance access to our local history by allowing for more productive research, optimized text search capabilities, and other access and functional needs capabilities for customers with visual impairments or other challenges.

In accordance with the Branch Library Fundraising Campaign and Council Policy #1-17, the donor recognition of \$600,000 from Margaret and Phillip Ma is recommended for approval. In the 2021-2022 Mid-Year Budget Review adjustments adopted by the City Council on February 8, 2022, \$510,000 of this gift was recognized as grant revenue that would be received by the Library from the Foundation for the purpose of acquiring the digital collection. The Foundation will retain an administrative fee from the gift. Any funds remaining will either be retained by the Foundation for future purchases on behalf of the Library, or transferred to the Library under a separate action.

CONCLUSION

This action allows the Foundation to accept funds on behalf of the Library, specifically to support the purchase of digital rights to the Mercury News and other enhancements to the resources provided by the California Room.

EVALUATION AND FOLLOW-UP

Information about the expansion of digital records in the California Room will be included in future reports on the special collection.
