Good morning Mackenzie,

I don't know if you or your staff have calculated what the current spay/neuter capacity was for the first 4 months of this year by SJAC Vets, but it is obviously a most important metric that single-handedly drives much of shelter policy and impacts all live shelter outcomes.

Outside Vendors: 2,023 s/n* SJACS Vets: 1,556 s/n**

Total: 3,579

SJACS Vets: **43.4%**

I've always been puzzled why the Mayor's Office, City Council, and Mr. Rios in the City Manager's Office have thought that offering "TNR for 5 days a week, at a minimum" was a realistic goal.

As you know, last December Mr. Rios stated at the NSE Meeting that this needed to be a policy priority for the City in 2025. Moreover, the Mayor's March Budget Message also noted the need for 5 days per week of TNR on page #31 as directed by Council (attached).

The above "capacity" calculation proves that such a goal is not even close to becoming a reality with existing staff.

Never mind, what exactly the community unmet TNR needs are overall.

Yesterday, the San Jose Community and Stakeholders had once again waited (another six months) for *material* action on low-cost public spay neuter services and TNR only to be disappointed yet again.

Dr. Kather has been in her role as medical director since September of 2022. Dr. Kather and the City have clearly failed to attract quality Veterinarian talent to SJACS. This is in stark contrast to the recent announcement made by Santa Clara County Animal Services in late March, which had hired not one, but two full-time Vets with the primary goal of offering low-cost spay/neuter to residents starting July 1st.

The fact that SJACS is heading into yet another Kitten Season with only 1 full-time RVT is highly problematic and borders on downright negligence. How is one RVT supposed to support three full-time Vets?

I'm curious to learn from you why the City has been incapable of offering material spay-neuter services on a budget approaching \$17.2 million for FY2025-2026 and what "plans" if any, are being made by the Mayor's Office to prioritize this issue so that SJACS can increase its own inhouse spay/neuter capacity.

I understand that the City Manager has been directed to prepare an MBA that evaluates options to redeploy existing resources in order to scale up weekly volume of spay/neuter surgeries. However, the timeline for such an evaluation isn't on the agenda at NSE until December, which means any active implementation will come during a most distant 2026.

The problem is . . . this shelter is already severely impacted NOW and can't afford to wait yet another year for any *material relief*.

I myself, single-handedly brought in a noted South Bay Veterinarian who donated two days of spay/neuter services at SJACS in 2022 when Matt Cano was Public Works Director. All

transport to and from a surgical van based in Redwood City was provided by a volunteer and seamless. This was authorized by Matt Cano and executed with help from Lori Scheibley.

The Vet performed 42 spay/neuter surgeries on Day One.

And a whopping 56 were performed on Day Two just two weeks later.

Yesterday, we heard Matt Loesch reveal that only 5 appointments per week for public spay/neuter will occur starting in June, with 10 appointments per week in July. - - - This is not going to move the needle.

Why can't an "arrangement" be made like the one that I was able to bring in for the City and be implemented immediately instead of waiting around until December for yet another "update"? Is there a City risk manager now preventing such an "arrangement"? Does a Vet wanting to donate their time actually have to become a part-time City employee due to liability issues?

The San Jose Community and stakeholders are tired of "updates" and kicking the can down the road.

This is an emergency situation. Precious time is wasting away. We need a solution!

San José Animal Care and Services (SJACS)

Dedicated SJACS staff, volunteers, and rescue partners provide critical care for thousands of animals every year. Last fall, the City Auditor released an audit that confirmed SJACS is over capacity and needs help keeping up with the large number of animals coming through the shelter's doors. When the audit came before Council in December, the Council provided additional direction for staff to restore Trap, Neuter, and Release (TNR) programs five days a week and work towards providing publicly available, low-cost spay and neuter services for owned pets. The City Manager is directed to prepare an MBA that evaluates options to redeploy existing resources to significantly scale up the weekly volume of TNRs and restore community spay and neuter services.



Had a shocking experience the SJ shelter today at 4:00 while I was there picking up my feral cat. A lady was trying to turn in 3 kittens which were about 7 weeks old. I know they are full so they turned her down. The shocking words that came out of the staff member's mouth was when he said "Go down the street to PETSMART" and stand there and try to give the kittens away, everyone wants kittens!" I told him "are you kidding me telling her that!" Do you know what could happen to kittens being given away for free in front of a store! I'm SHOCKED they would give her that advice. I asked him if he could give her a list of rescues she could call. He gave her a list and I took a look at the list and some of the groups on that list went out of business years ago. I crossed off the rescues no longer in business and wrote down a couple rescues that I knew of not on the list she can try to reach out to. She told the staff member she had tried to give the kittens to friends and family but no takers. I wish I would have recorded that conversation because I could not believe what I was hearing! I told them I would be happy to update the list for them or if they could ask a rescuer to do it because one of the groups on that list closed 8 or more years ago because I used to volunteer with them. Good morning Miss Mossing,

On Monday night, a dog died in his kennel left unattended in the medical ward. No one was around to monitor him and his slip-leash had wrapped around his leg and cut circulation.

In the same ward, a hard-working animal care attendant came across not only this dog but also a cat that was bleeding out because its IV had been disconnected. An IV monitor had been beeping for hours earlier, but a Coordinator had told another animal care attendant to turn the monitor off.

No one was around to authorize a decision to transport to MedVet.

The highly traumatized ACA that came across these two animals in the medical ward as she was on her way to get a drink in the break room, got a hold of an animal control officer by the name of Asher Fairless (a former board member with me at *Kitten's First*). Officer Fairless

made the decision to transport to *MedVet* where the dog died. Apparently, the cat made it but had lost a lot of blood.

This is yet another example of the flat-out negligence being committed by SJACS Directors, Coordinators, and Shelter Managers.

I continue to be alarmed by how the Mayor's Office and City Manager of San Jose show no concern.

Personnel changes by the City Manager should have been made a long time ago, yet under her leadership animals continue to suffer and die from highly avoidable deaths. The Mayor talks about his new accountability initiative, but from my position it appears to be nothing more than "talk" given how many animals continue to suffer and die at SJACS.

Since the City continues to be in denial about the operations at the San Jose Animal Care Center, I have no doubt that this tragic incident will be revealed on a number of news networks.

Good afternoon Miss Maguire and Mr. Rios,

On Monday night, May 12th a terrier (ironically) by the name of *Lola* was found by an animal care attendant with its slip-lead wrapped around one of its legs and cutting off circulation. The dog had also chewed off its catheter.

In the same medical ward, a cat named *Chris* was in the process of bleeding out, as its IV had been pulled by another cat housed below it. An IV monitor had been "beeping" for quite some time earlier in the evening, but a coordinator had told an animal care attendant to turn the monitor off. I guess she found it annoying.

An animal care attendant who was on her way to the break room in the back of the shelter for a drink stumbled across this situation. Sadly, she wasn't able to find anyone ranking above her to authorize a call to *Medvet*. She was finally able to get a hold of an animal control officer by the name of Asher Fairless, who I also served with on the board of directors at the 501c-3 non-profit *Kittens First for the San Jose Animal Care Center* in 2019 which created and operated a kitten foster program for SJACS.

Officer Fairless made the decision to transport both *Lola* and *Chris* to MedVet.

I believe these were both owned and microchipped animals.

The cat made it, but the dog died.

Suffice to say, the young animal care attendant that came across this "incident" is highly traumatized.

Another totally avoidable death at the hands of the City's incompetent management team.

Miss Maguire, how many more animals need to suffer and die before you make any changes?

How much more "blood" does the City have to have on its hands before you make personnel changes?

How many more times does the Community have to listen to Matt Loesch and his Medical Director Dr. Kather "spin" stories in front of City Council about yet another *freak accident?*

Your deputy Mr. Rios has been aware of numerous cases of medical neglect and incompetence at SJACS since March of 2023 shared with him by certified medical professionals who swore an oath to uphold the virtues of animal welfare. However, Mr. Rios has not made a single personnel change at the Director level. I too, have informed you and Council of cases of medical neglect since October 2023.

Given that you have repeatedly done nothing more than pass off my "concerns" to Matt Loesch, it's become clear to me that you are not as engaged as you can be when it comes to the incompetent and negligent operations at SJACS. Photo-ops are all well and good at a City Wellness Clinic. But where is your leadership?





Dear Mayor Mahan and San Jose City Council,

I ask you to rise to the challenge rather than cave to bullies intent on stifling the input of disadvantaged communities. The City needs to immediately restore virtual public comment for all City Council, Committee, and Commission meetings.

It is clear there is an effort to silence members of disadvantaged communities. Many residents rely on being able to provide virtual public comment due to reasons of disability, health, work schedules, parenting and other demands of modern life. The strategy appears to be to engage in racist and hateful speech in order to bully the Council into eliminating virtual public comment. The bullies scored

a victory when the Council decided to eliminate this option without first seeking community input and not at the bequest from community members.

By eliminating remote access on the heels of restricting access to the council chambers in December, San Jose has fallen from a model of good government dedicated to promoting civic participation to a city displaying troubling behavior and giving the impression that hearing from its residents is a bother. We agree that the comments of a few bad actors are vile and have no place in a community meeting. Rather than using racist and hateful speech as an excuse to cut off community participation and hamper people's First Amendment right to petition their government, however, the City should rise to the challenge of finding solutions to preserve access for everyone while continuing to facilitate public comment by providing a virtual option.

Ending the process of remote participation, is to deny a large segment of the community the opportunity to participate in our democratic process. Some examples include:

- Disabled residents who rely on technology to speak, or who otherwise have to arrange rides with Paratransit.
- Immunocompromised residents who take on unnecessary risks to their health by spending hours in a packed room.
- Working people without the ability to arrange their schedules around hours-long council meetings.
- Parents with small children who can't take time off to attend City meetings.

For example, budget season is the most critical time of year for civic engagement. The ban on remote comments means the people most in need of an equitable city budget will be sidelined throughout the process.

The possibility that the ban on remote comments might only last months is no comfort to those who wish to comment on current City Council, Committee and Commission matters in order to ensure that quality of life in San Jose is maximized. I ask that you immediately restore virtual public comment to ensure that you and the City once again benefit from the voices silenced by your recent decision. Rachel Goehner
